Airports

- 1. P08
 - a. Airport closed to transient traffic Nov 14-16 for runway sealing.
 - b. Watch for old commercial aircraft that will be disassembled at the airport.
 - c. Check NOTAMs.

2. P08 and AVQ

a. General AFTW Feedback 10-4-2022: I wanted you to be aware that about a week ago on two separate occasions at two different airports I had close encounters with parachute jumpers while practicing landings with a student. These occurred at Coolidge and Marana airports. In each case the jumpers were attempting to reach their drop zones but because of winds they were dropped from the opposite side of the runway so that their path took them through the departure and crosswind legs of the aircraft pattern. In both cases they underestimated the winds and came short of their target, putting them immediately in the area of multiple aircraft. I don't know that anything can be done but I personally believe they shouldn't be allowed to jump when the winds necessitate they be deployed from the direction of the traffic pattern. Thanks for your work.

Airspace

- 1. Rainbow Valley Practice Area update
 - a. Everything seems to be working well.

2. From Scott Tinnesand:

- a. There is extensive helicopter training in the area south of Chandler/Gateway to Casa Grande. They DO NOT join the practice area frequency, rather, they use a bootlegged FSS frequency (122.25). Altitudes are surface to ~3,000 MSL and mostly Robinson R-22's. The school's student population is high so it's not uncommon for up to a dozen helicopters to be out all day.
- b. For Boeing testing, the area to the south and east of Gateway is typically where we do commo range testing with the comm van. It's not something we do often but there is another test within the next few months that will be doing that for about two weeks.
- c. We're not currently doing any Chinook testing out of Mesa but for the past two years, we have used Casa Grande as a refuel and sling-load location so that's worth mentioning.

 - b. If Tuscon Soaring Club members are in attendance, we would like to determine if this is acceptable to them. Then, we can move forward with our request for waivers for 121.95, 122.775, 123.3 and 122.85.
