Lower Nevisoft("we") is committed to protecting the personal data of users of Lucky Clover Slots("App").

This privacy policy describes the types of personal data we collect, how we use it, who has access and for how long. It also provides information on the rights provided to our users under our data protection rules.

Information Collected

Email, device information(model, manufacturer, language, IDFA, IDFA, GAID, screen resolution, etc.), information about your network connection(mac address, network type), and other information regarding your interaction with the App.

Information Collection Methods

Direct Interactions. When you interact with our Services, you may provide us your personal information by communicating with us by email.

Automated Collection. As you interact with our Services, we may automatically collect Technical Information and Usage Information. We collect these categories of Personal Information by using SDK's, web beacons, and other similar technologies.

Third Parties or Public Sources. We may share and receive personal information about you from various third parties, including but not limited: (a) advertising networks; (b) contact information and technical information from providers of technical, and service providers; (c) identifiers and technical information from social networks when you grant us permission to access data on one or more of those services.

Reasons For Collecting Information

We use this data to provide you with our Services; for example, to contact you, provide you with services and advertising. We also use this data to make sure that we comply with applicable legal requirements.

We only use this data for statistical purposes, and not in a manner that would give us sufficient data to identify you personally. This data help us better understand regarding the use of this App, including where they are generally located, what types of content, Apps, offers and products our users are interested in ,which features are the most popular with our users and what are their general mobile usage behavioral patterns. That data also allows us to determine if this App is working properly, make changes to the App that allows users to have better experiences and improve the App, our offers and promotional content so that they are more relevant to you. In addition, We may use any such data for security, system integrity (the prevention of hacking, cheating and other improper or unlawful activities), or enforcement purposes.

Sharing of Information

We does not sell, trade or transfer User Information to third parties. However, we may share User Information with our business partners for marketing, advertising or product/service offering purposes. We disclose User Information if: we have your consent; we need to share it in order to provide you with the products and/or services you requested; we respond to a court order or you violate our Terms of Use.

Retention of Information

We retain your personal data for as long as necessary to provide you with our services, to fulfill legitimate and necessary business purposes, to comply with our legal obligations and to resolve disputes. We are committed to protecting the privacy of all personal data processed and aim to ensure that personal data is kept no longer than necessary to fulfill the purposes for which it was collected, preserved and processed. Upon your request, we will delete or anonymize your personal data so that it can no longer identify you, unless we are legally permitted or required to retain certain personal data. Due to the complexity of deleting data from inactive, long-term backups, we are unable to delete inactive personal data. If data from a backup is restored for any reason, we will anonymize or delete the data from active systems.

Protection of Information

We have implemented measures to ensure that your privacy is protected from accidental loss and unauthorized access, use, alteration and disclosure.

Unfortunately, the transmission of information via the Internet is not completely secure. Although we do our best to protect your personal information, we cannot guarantee the security of your personal information transmitted to us. Any transmission of personal information is at your own risk. We are not responsible for circumvention of any privacy settings or security measures contained in the App.

Your Rights

Right to withdraw consent. If we are relying on consent to process your personal information, you have the right to withdraw your consent at any time. Withdrawing consent will not affect the lawfulness of our processing, or the lawfulness of any third party processing based on consent before your withdrawal.

Right of rectification. You may request to correct or update any Personal Information we hold about you

Right to erasure. You can ask us to erase any personal information we hold about you where it is no longer necessary in relation to the purposes for which it was collected or otherwise processed, or where it relates to processing activities to which you have objected and there are no overriding legitimate grounds for us to process it.

Right to object to processing. If we process your personal information on the lawful basis of consent, contract or legitimate interests, you can object to our processing at any time as permitted by applicable law. We may continue to process your personal information if it is necessary for the defense of legal claims or any other exception permitted by applicable law.

Right to complain. If you believe that we have violated your privacy rights, please contact us so that we can address your concerns. You also have the right to complain to the competent supervisory authority in the Member State of your habitual residence, place of work or place of the alleged infringement.

Third Parties Services

The App accesses services or advertisements provided by these third parties, and these third parties may collect your personal information. In this case, this Privacy Policy will not apply. The handling of your personal information by these third parties is subject to their privacy policies. Therefore, we recommend that you review the privacy policies of these third parties with the same caution.
