

I. **Questioning Strategy for Inquiry 3 (Write as much as you possibly can! There are no right or wrong answers for now. Everything you think, write it without censoring yourself.)**

In your final inquiry you will be writing a support-based argument essay answering:

***If an Egyptian family with young children has a chance to legally immigrate, should they? What is the best decision... to go or stay?***

- A. List several possible countries (at least three) that you would be interested in exploring as possible places that an Egyptian family might choose to immigrate to.
  
- B. Write your ideas about these countries, either things that you know about them or what made you think of them in this context.
  
- C. Decide on one of the countries to write about for your essay. It may be the one that you already know most about, or the one that you think it will be most interesting to find out more about. State the country.
  
- D. Write a list of possible issues to investigate. Remember, you will be comparing those issues in your chosen country with Egypt. Think about the most important things that the young couple will need to consider. *(There are some questions on the assignment prompt which can help you with this.)*  
**At this stage, you do not need to decide if you will be arguing for the family to stay in Egypt or to migrate to your chosen country. Wait until you find evidence from sources to make that decision.**

II. **Information Literacy**

For this final inquiry, you will need to integrate information from **at least five sources**. A **minimum of two of those sources need to be academic ones**.

- D. How will you address the counter-arguments? Will you refute them or concede to them, and how? What evidence do you have to support your arguments?

## **V. Thesis statement**

Once you have decided on your position and the main arguments that you will use, you should be able to answer the question: *If an Egyptian family with young children has a chance to legally immigrate, should they? What is the best decision... to go or stay?*

Write your thesis statement that will answer the question.

## **VI. Essay Plan**

Write a brief outline for your argument essay, saying what the main focus of each paragraph will be about.

Write the first sentence of each paragraph. That should be a topic sentence, which introduces what that paragraph will be about.
