Note: Mr. Morgan's brother was murdered by a knife-wielder on 27/08/ , where the accused was prosecuted with a 4 year sentence in a Crown Court due to corruption and nepotism. This sparked Mr. Morgan's interest in becoming a custodial officer as it was the easiest pathway to directly handling perpetrators of crime, as stated in later interviews.

Departmental Operations

Operation Stinger: Counter-raid of the Sierra-7 Terror Cell in the Pinewood Region, 2 hours after a previous raid conducted by them on Foundation Site-65. Join operation between Surface Operations Personnel and Site Security. Objective to recapture a compromised Nu7 Major and stolen anomalous objects from within their Operations Base. The operation ended with heavy casualties from both SOP and GSD Staff, but was ultimately successful and resulted in the capture of the Nu7 major and multiple anomalous objects.

Operation Calm Tides: A riot control operation within D-Block caused by recent unrest with Site changes. Lead by Sergeant

Morgan. GSD Staff entered Inner-Dblock in order to subdue overly violent inmates and calm the crowd. After 30 minutes, with the use of crowd control equipment such as tear gas, the original leader and instigators were detained, and the riot dispersed.

Departmental Projects

Project Voice: A project initiated by Captain Morgan with approval from the Chief of Security. Consisted of gathering feedback in interviews from all sorts of different scenarios with D-Class, and storing this feedback for later general reviews. Seemed to improve D-Class quality of life and improved overall wellbeing.

FLC Violations: A few, for minor charges

Behaviour Towards D-Class: Mr. Morgan seems to exhibit a more empathetic viewpoint towards D-Class Personnel, despite their position as death row inmates. He prioritizes improving their quality of life in an attempt to better control their violence

Behaviour Towards the FLC: Mr. Morgan has had a few negative run-ins with the FLC and Internal Security Department, although for minor incidents such as drinking alcohol on-duty, nothing of significance. If alcohol becomes a problem for Mr. Morgan, then it will become of much more significance.

Procedures/Guidelines: Is an adept follower of the set procedures for Site Security, hasn't had any issues with following the rules set out for him and the department.

Incident Summary:

- On the 11th of June, 20:30, HMP Wakefield experienced an uncalled for power outage due to a bolt of lightning striking the electrical circuit from a thunderstorm outside.
- The power surge caused a power outage within the prison and surrounding civilian area, leaving the place in darkness with the already set sun.

- 15 minutes into the power outage, the inmates of HMP Wakefield began to get unruly and contempt with the sudden darkness. A bloodcurdling scream was heard from within a cell, but was played off as shenanigans from unruly inmates.
- 5 minutes later, again, another scream was heard and echoed in the halls. Custodial officers investigated, and were horrified to discover an inmate with his torso completely detached from his upper body.
- The prison was placed on an artificial lockdown by custodial officers, and it was deduced the murder must have been from a foreign intruder since all the inmates were still locked in their cells.
- Patrols were conducted across the prison in pairs of two. A loud shriek of nonsense crackled into the radio frequency, describing a 'black monster without legs' and 'white eyes' before radio silence. The pair was found 10 minutes later, both mutilated and grotesque.
- SCP Foundation Site-34 eventually intercepted outgoing communications from HMP Wakefield to neighbouring authorities, matching the description of SCP-280.
- MTF Eta-10 and DEA agents were swiftly deployed to the prison, and worked on recontainment & amnestication efforts. However, a single custodial officer proved impressive in handling the situation.

I mean, it was pitch-black so I pulled out my flashlight. I see this weird-as-shit black monster coming towards me and I shine my light on it, and it starts to back off. So obviously I realised the thing doesn't like light.
