

- My Turnaround Time is **1 month** for simpler commissions, **2 months** for more complex commissions, and finally **3 months** for things with backgrounds or heavy details or a lot of little items (think ref sheets, scenes, etc). More items added to the order will result in the order extending over that limit. Please do not “poke” me frequently before that. I have you on my private queue, you haven’t been forgotten. **If you need it sooner it must be agreed upon beforehand.**
- My Character Design Commissions are currently \$100 +. My regular commissions are usually much less- do not try to get me to design in a regular commission. Each commission needs a **drawn reference** unless discussed otherwise with me beforehand.
- All characters **MUST** be age 18+.
- You must be 18+ to commission me.
- My commissions are SFW only unless offered otherwise.
- I reserve the right to post my commissions publicly. Private commissions are available upon request. Please do not assume I know you want a picture to be private if you did not say so directly.
- I take payment beforehand through Paypal currently.
- I do not work with characters who are involved in incest, even if the commission is not incest related.
- I won't draw hate art towards any gender, ethnicity, or religion. There is not an unspoken exception to this. This includes drawing caricature stereotypes. And culturally appropriate clothing.
- I reserve the right to turn down any commission, for any reason.

## **Refunds**

- I do not offer refunds for completed work. Attempting to chargeback me after work has been completed will be considered scamming and will be treated accordingly.
- You may request a refund if work is not completed within my turnaround time. I will refund you for the part of the work I have not completed.
- I do not refund for purchased adopts. If you purchase a design from me and then chargeback, I reserve the right to take the design back and resell it. I will also treat this like a scam and act accordingly.

- I am no longer doing “exchanges” for adoptables, where if I post a newer WIP and a client asks to swap for it for an adoptable they have purchased in the past.

### **Edits**

- I will send you multiple WIPS throughout the process of commissioning me. Throughout those WIPS you have many opportunities to point out if I missed something major or if you'd like something changed. I will not be editing lineart if you've given me the okay to color.
- **You have 48 hours** after the commission is completed to ask for edits to it. I will not be going back to edit it after this as it disrupts my workflow. This also includes asking for edits to adoptables.
- Edits will **cost extra** if you ask me to redraft the pose more than twice, or ask me to redo the pose after I've moved on to line art.
- I do not do major edits to purchased adopts. I might do **minor** color and marking tweaks as long as you're clear with what you want.
- I do not take third person critique. The requests and changes need to come from my commissioner! Although I might complete a picture while this is happening, it's very likely I will turn down commissioners who did this in the future.

### **You Will Not;**

- Post my work uncredited.
- Use my work to make profit. This includes selling it as stickers, prints, or NFTS. Commercial usage fee is +50% of the commissions price.
- Edit my work heavily unless stated otherwise. Small edits and things like drawing outfits over an outfit doll base is ok.
- Feed my work to AI. This will get you blocked and blacklisted.

### **You Can;**

- Repost my work with credit.
- Print it out for personal use.
- Use it as headers, and icons, and page decoration.

- Slightly edit my work when appropriate.

### **I Draw;**

- Tasteful nudity
- Mild NSFW
- Light Gore
- Mild Kink
- Romantic Couples of all genders
- Armor
- I now draw penises and vaginas!

### **I do not Draw;**

- I am no longer drawing belly dancer style outfits. This does include outfits I have designed in the past.
- Sexualized kimonos.

### **Holds;**

- I only do 24 hour holds for new customers, ghosting me will result in a block.
- I am willing to be flexible for repeat customers with holds, but please note if you have me hold a design for more than a few days, and you back out within 48 hours of the due date I will no longer do holds for you.

### **Design ToS**

- You may trade or resell an adoptable you've purchased from me.
- You may only sell my adopts for the amount you've invested. (for example base price + the art you've bought or made)
- You Must credit me for my designs. My toyhou.se is Goblins
- You may not make a "closed species" off a design you purchased from me or a "twin"
- You May not "age down" my designs to make them babyfurs.
- You may not draw underage porn or sexualized minors of my designs. Doing so will result in your rights to the design being revoked. This is the only case where I will take a design back without refunding you.

- You may not make your own set of rules for reselling my designs. You can not demand someone give it back or sell it back to you, you can only ask.
- You MAY use designs you've bought from me in merchandise as long as YOU made the art and it is not my art.
- By Purchasing one of my designs you recognize that breaking one or more of these will result in black listing.
- Do not delete my designs off of Toyhou.se. I use it to keep track of them. If you need a toyhou.se code, I can provide it!
