- Each candidate running for office in Lake County for School Board, FL State House, and FL State Senate were contacted for an interview and they were sent the uniform FEA questionnaire.
- All questions are developed using only education topics. NO OTHER TOPICS are considered or discussed.

- During candidate interviews candidates are asked to elaborate on their responses from the questionnaire as well as some additional questions specific to Lake County Schools.
- Interviews are conducted by LCEA members. Any member that wishes to be a part of the Political and Lobbying Committee can attend the interviews.

Questions from their responses on the questionnaire:

- On the questions about specific positions Can you expand upon specifically what you would like to see with funding, testing, and direct path to workforce education?
  - 1. Would you address the compression for experienced educators currently in state law?
  - 2. You mention you want less testing but also mention an emphasis on early development for reading. Does this mean you would like more testing for early age groups? Explain?
- On the question on teacher and staff shortages: Can you explain what you mean by using contracts for effective educators?
- On the question about potential funding deficits, you say you will work with the legislature.
  - 1. Since Florida is now 50th in average teachers salary, FEA has called on lawmakers to increase funding by 2.5 billion a year for the next 7 years. **Would you support this proposal?**
- On the question about funding and health care costs you mention retirement and healthcare is important for teacher retention and attraction. How would you improve healthcare costs?
  - 1. Would you propose more funding to address health care costs coming out of the general fund for the district?
- Question about school choice you state you support school choice but do not address the questions about accountability. What accountability and oversight for tax dollars would you support if any for private, charters, and other non-traditional schools?
- Question about school safety Would you support additional funding and resources to ensure our schools are safe for all?
- We really appreciate how accommodating you have been in meeting with our educators and leaders but often you have voted against our positions on bills related to public education and unions. We also have not seen a practice of reaching out to gain information about our educators' concerns about specific policy. We want to develop a relationship where we can have a dialogue and work together to improve public education in Lake County. We also understand the political climate and the pressures legislators feel from their leadership, but believe there are ways we can still work together to improve things.
  - 1. Why did you vote for and support those positions for example with SB 256?
  - 2. How can we work together to create a space where you feel you can reach out for information from us and consider our position when voting for policy?
