Acknowledge that I have read the conditions applicable to the National Team Trials of **MIND SPORTS SOUTH AFRICA** (MSSA), and agree that I shall abide by them.

2. I acknowledge that by signing this form, I am in no way guaranteed of being selected for the national squad or the national team.
3. I confirm that if I enter into the National Team Trials, and I submit the Acceptance Form obtainable at such Trials within 7 days of the completion of such Trials, I am making myself eligible for selection.
4. I acknowledge that if I am selected as a member of a squad, I shall abide by the rules concerning the squad as promulgated by MSSA, and which may be amended from time-to time.
5. I understand that the national team shall be selected from the national squad per international event for which the team is required.
6. I acknowledge that if I am selected as a member of any MSSA national squad, I agree that I shall become a member of all MSSA's mailing lists, Twitter account, and Facebook page being:

7. I acknowledge that if I am interviewed while I am member of a national squad, I shall:
  1. Wear official team kit, as per the Regulations if such has been provided,
  2. Always thank the MSSA, and all sponsors associated with the event, and
  3. Never criticize the event, other competitors, officials, MSSA or any body to which the MSSA is affiliated, or any of their policies.
8. Should I transgress point 7, in total or in part, above, I shall be responsible to retract, at my own cost and in the same forum, such statements, failing which, I acknowledge that I shall be liable for a fine not exceeding R15,000.00 as imposed by the Management Board of the MSSA which shall have the right to issue such statements on my behalf as if I had done so myself and hereby indemnify the MSSA against any and all costs associated or occasioned thereby.
9. I acknowledge that if I am selected as a member of a national squad, I shall abide by the MSSA 's dress code, and the Code of Conduct.
10. I undertake that I shall not make any statements in any way about the national squad, selection process, etc., unless it is at the MSSA's direction. Should I make any such statements I acknowledge that I shall be discharged from the national squad with immediate effect and forfeit any colours that I may have.
11. I acknowledge that if I am selected as a member of a national squad, my selection to the National Team is not automatic and is dependent upon selection thereto in terms of the rules for such selection.
12. I acknowledge that the national squad is chosen for a period as determined by the MSSA's Management Board and that such period cannot exceed 12 calendar months. I thus acknowledge that I shall remain a member of the national squad for the full period and that I shall remain in good standing as a player of the MSSA while I am a member of such national squad. Should I not remain in good standing, I acknowledge that:
  1. I be immediately discharged from the national squad, and by implication the national team, and
  2. I shall be liable for all costs incurred by the MSSA in replacing myself on the national squad and/or team, and
  3. I shall not be eligible for National team Trials in such year or the next.
13. In the event that I am selected for the national squad, and that any club or clan or group involved in activities which are related to my membership of the national squad, that is not affiliated to Mind Sports South Africa claims credit for my ward's selection to the national squad, that is not affiliated to Mind Sports South Africa, it shall be my duty to deny, at my own cost and in the same forum, such allegations, failing which I acknowledge that I shall be discharged from the national squad with immediate effect.
14. In the event that I am unable to meet my commitments for any reason, I acknowledge that I shall be responsible for the costs of any player selected as a replacement. Such costs may only be waived at the discretion of the MSSA 's Executive Committee.
15. I agree that Mind Sports South Africa shall not be liable in any circumstances for any death, injury, loss or damage of any kind whatsoever arising directly or indirectly from any act or omission (whether negligent or otherwise) by any person whatsoever, connected with membership of the team, my travel to and from the event, my participation at the event, or any disciplinary action taken against me by Mind Sports South Africa.
16. Mind Sports South Africa (MSSA) shall mean:
  1. Mind Sports South Africa, its members and executive,

2. Officials, coaches, medical practitioners, sports scientist, therapists, and other members of the team, and
3. Any independent contractor or volunteer providing services to Mind Sports South Africa.
