- 2. November 5, 2018 LPS obtained
- 3. December 12- 28, 2017 Stopped meds, shouting at neighbor's cat. December 12- 28, 2017; UCLA Harbor, Torrence: Diagnosed: Paranoid schizophrenia
- November 5-December 12, 2017; Venice area; Diagnosed: Exhibiting psychotic behaviors; psych refused to apply for LPS
- 5. September 10- 23, 2017; Attacked person in elevator. College Hospital Long Beach; Diagnosed: Bipolar

SYMPTOMS AND CHARACTERISTICS

- Auditory hallucinations. Hears TV talking to him, voices telling him to jump, that he is evil, telling him to harm self
- Paranoid thinking. FBI, CIA listening to thoughts, family agents of evil, conspiring, wires in head... keeps
 gun/knife... believes the "energy" from head can help or harm people, being stalked.... disorganized speech
 or behavior word salad speech, rambling, sounds, can't follow conversations... DUI, broke into neighbor's
 house to borrow spoon.... yelling at neighbors, shouting obscenities to strangers... was beaten up
- Mood swings, destructive behaviour (broke wall, keyed car)
- Poor hygiene. Won't shower, cut or wash hair, sets fire to kill imaginary insects
- Lacks insight over his mental illness, benefit from medication, delusions, etc. and is very paranoid about medications.

MEDICATIONS/DRUG USE/OVERDOSES

- Self-medicates with Marijuana, alcohol
- Smokes 2 ppd cigarettes, never sober, marijuana causes dramatic increase in psychosis
- History of NON-COMPLIANCE once he returns home (despite always insisting in hospital that he will be compliant
- Lacks insight, medications help, paranoid about meds
- History of non-compliance with prescription medication

Restraining order from neighbor issued after threatening cat; August 2008

March 2- April 4, 2017; Twin Towers

- Do not give Risperdal which gives muscle twitch
- Zyprexa cause elevated liver tests
