#### Welcome

We welcome you to Temple Hill School. We hope it will be a happy and successful year for everyone. Our dedicated teachers and staff are here to work with you to ensure that your child has a successful school year. If you have any questions, please see your teacher or give the school a call. **Have a great year!** 

#### **School Hours**

For the current school year, the school hours are 7:20 a.m. to 2:25 p.m. All students are to arrive at school on time to be in their classes at 7:20. Breakfast is provided from 6:55-7:15 am.

#### Attendance

Attendance is very important to the success of our educational program at Temple Hill School. Our school has been a leader in the district in attendance. We want to continue this success during the 2024-25 school year. Thanks for your efforts in our success. Average daily attendance is an important part of our funding source to provide adequate resources for our school. Please make every effort to have your child at school on a regular basis.

- 1. To report student absences, parents are requested to call the school to inform the office of the absence between 8:00 a.m. and 9:00 a.m.
- 2. Parents will need to send a signed note to school anytime a child is absent (including tardies) within three days of the student returning to school after an absence. (This is in addition to the initial phone call.) Make-up work is the student's responsibility. In the event of an absence, the parent may call the school by 9:00 a.m. to request assignments to be available for pick-up between 2:00 and 3:00 p.m. in the office.
- 3. For a student to be eligible for a perfect attendance award for the school year, he or she shall have <u>no</u> <u>absences and no more than three (3) unexcused tardies. Perfect attendance for a 9 week period will be 0 absences and no more than one (1) unexcused tardy.</u>
- 4. Students who arrive late or leave early must sign in/out at the office. A parent or guardian must sign in the student at the office stating the reason for the tardiness/pickup.
- 5. Only parents or guardians may pick up children from school unless we have <u>written authorization and proper identification</u>. The attached "Leave school permission form" is required for all students. This form should be completed and returned during the first week of school. Anyone who picks up a student from school may be asked to show identification.
- 6. Every student is to leave school immediately following the last bell except those under the direct supervision of a teacher, coach, sponsor, or principal. School will not be liable for students left after this time.
- 7. Please refer to the Barren County Board of Education District attendance policy for specific details.

#### **School Nurse**

Temple Hill will employ a full time nurse for the 2025-26 school year. This is a partnership between the Barren County Board of Education and Cumberland Family Medical. A consent form will be sent home for each student. Parents/Guardians need to complete and return the consent form back to school as soon as possible. Without the completed consent form on file, the school nurse cannot see or treat your child.

#### **Student Behavior**

Students are expected to conduct themselves in a safe, courteous manner. Please help us to maintain a beautiful school facility. The following are general rules for Temple Hill students:

- 1. No gum chewing in the building or grounds.
- 2. No radios, CD players, IPods, cell phones or other electronic devices or toys should be brought to school unless approved by the principal or homeroom teachers.
- 3. Students are to walk in the halls at all times. They are to walk to their right as to minimize traffic problems in the hall. No noise or talking in the halls, voice level zero. No touching the walls or leaning their feet on the walls.
- 4. No body contact sports are allowed.
- 5. Proper restroom use and courtesy is expected at all times.
- Dangerous weapons, including "look alike" toys, are NOT permitted on school property. 6.
- 7. All trading cards need to remain at home.
- 8. Any improper items will be confiscated.

The Board of Education adopted the Student Code of Conduct in the Barren County Discipline Handbook

#### Illness/Injuries at School

that applies to all students. Temple Hill also has a student discipline code used with all students.

- 1. All accidents and illness must be reported to the office as soon as possible. An accident report will be completed.
- 2. Should a student need to be excused from gym or recess for an extended period of time, a physician's note stating the reason and length of exclusion must be brought to school.
- 3. School Day insurance is provided to all students by the Barren County Board of Education.

#### **School Buses**

- 1. Safety rules for the school bus will be given to each bus rider.
  - a. Sit on your bottom
  - b. Face forward
  - c. Voice Level 2 (with appropriate language)
  - d. Keep hands, feet, and all objects to yourself
- 2. Children who cannot abide by all the established rules regarding transportation may lose bus privileges.
- 3. District-wide bus procedures will be followed. (See attached bus form for disciplinary actions.)
- 4. Children must ride their assigned bus unless the office receives a written note from the parent or guardian indicating another bus or other transportation arrangements.
- 5. Please notify the school office if your child's regular method of transportation changes.
- 6. Due to safety concerns, please keep to a minimum, the number of daily bus drop-off changes.
- 7. Students are expected to follow the same guidelines and procedures when riding the bus to and from school as they follow during school. Voice levels will be posted on the bus.

#### **Visitors**

- 1. Parents/guardians are welcome to visit at Temple Hill School.
- 2. **ALL** visitors must report to the office upon entering the building.
- 3. Our school will ask for proper identification upon entering the building and secure your vehicle keys until you are signed out of the building.
- 4. All visitors will be signed-in and signed-out in the office. In regard to student safety, you will also be required to state your reason for being on campus.
- 5. Name, address, telephone may be required as needed.

#### Parent /Teacher Conferences

- 1. Please contact the office to schedule a conference with a teacher, counselor, or the principal.
- Parents/guardians will not be permitted access to teachers during instructional time. If you
  need to meet with a teacher, please schedule a time that will meet the needs of the teacher
  and parent.
- 3. A Parent/Teacher Conference opportunity will be scheduled during the fall semester and the spring semester.

#### **School Closing**

On those snowy/icy mornings when there is doubt as to whether there will be school in the Barren County School System, listen for an announcement on the local radio and TV stations. Households will be notified by the Rooms Communication system. **DO NOT CALL THE SCHOOL OR THE OFFICE OF THE SUPERINTENDENT UNLESS ABSOLUTELY NECESSARY.** It is important to have these lines open for urgent calls or emergencies. The Barren County Schools will once again utilize non-traditional instruction (NTI) days. More information will come home this fall.

#### **Guidance and Counseling**

Guidance and counseling services are available for all students. If you have questions or concerns, please contact the office.

#### **Dress Code**

- 1. All students are expected to dress for prevailing weather conditions.
- 2. Any attire that attracts undue attention to the wearer, thus causing a disturbance and/or interfering with the orderly operation of the school, is **not acceptable**. Improper language or advertisements are not allowed.
- 3. Jeans/pants with rips, frays, and holes in them should not show visible skin more than three inches above the knee. Leggings or tights can be worn under jeans/pants with rips, frays, and holes in them. (added 01/19/22 per SBDM)
- 4. <u>NO</u> short tops, halter tops, tank tops, spaghetti/T-strap tops, skin-tight clothing, sagging pants, "confederate/rebel", or wrestling shirts, (which contain inappropriate pictures or language) etc. will be permitted. Parents may be called to bring suitable attire or if possible, the school will provide suitable attire.

- 5. Shorts and dress lengths must be mid-thigh or longer. This will be monitored closely.
- 6. No caps or hats are to be worn in the building unless prior approval of the principal or teacher.
- 7. The Principal shall have the final authority in determining compliance with the dress code.

#### **Student Activities**

A number of curricular and extra curricular programs for students are held during and after school hours. Please contact us regarding information on:

Little League and Bitty Ball Basketball, Beta Club (grades 4-6), Academic Team, Student Technology Leadership Program (STLP) and other activities that will be offered through our Barren Beyond the Bell after school program and 21st Century programming.

#### **Grades/Progress Reports/Student Records**

Each student will receive a grade card or progress report at the end of the nine-week grading period. Barren County grading scale is as follows:

A=90-100; B=80-89; C=70-79; D=60-69; F=Below 60.

To enroll at Temple Hill Elementary, all students are required to have a valid immunization certificate, medical examination form, and an official birth certificate and a copy of the child's social security card. Required documents **MUST BE** received before a student can be officially enrolled at Temple Hill. This is in accordance with district policy.

Non-custodial parents have the same right to access of student's records as the custodial parent, except where access is limited by an agreement between the parents or a court order affecting the rights for parents. **Custodial parents or guardians are responsible for providing the school with documentation for all custody changes and/or restrictions.** 

#### **School Lunch**

Breakfast and Lunch

Breakfast and lunch are available in the cafeteria at "no charge" due to the Community Eligibility Provision program. The Community Eligibility Provision or CEP is a program offered through the National School Lunch and Breakfast Programs that allow schools and local educational agencies (LEAs) located in low-income areas to provide free breakfast and lunch to ALL students in Barren County School District. Please be sure to complete the household income form as this is used in determining the district's funding eligibility.

Please refer to the district student handbook or the beginning of the year student folders for information about student meal charge policies and required documentation for the CEP program.

The only items that will require payment are a la carte items and second meals, if students choose to purchase these items. Students may also be able to utilize a share table, when available, at no charge to the students.

Students should **NOT** bring soft drinks for lunch. No glass containers are permitted due to safety issues. Parents should call by 10:00 am if they plan to eat lunch at school. Students may bring a packed lunch from home, but parents are encouraged to refrain from bringing food from a restaurant into cafeteria spaces.
