## *General*

- ❖ Provide a short and clear description of what you are seeking.
- ❖ I am willing to work off of stick figure drawings or clear descriptions (visual references are highly preferred).
- ❖ My prices are subject to change at any given time.
- ❖ I can deny a commission if it's outside my comfort zone.
- ❖ No changes can/will be made once a piece is lined.
- ❖ No more than **three** small revisions and **one** major revision.
- ❖ Once the piece is finished it is **finished**, meaning no changes will be made.
- ❖ You can repost your commission but you **must** credit back to me.
- ❖ You can absolutely use it as icons, profile pictures, etc!
- ❖ **Do not** claim it as your own!
- ❖ **Do not** edit over my work/remove my watermark without asking.

## *Payment*

- Prices are listed in **USD**, other currencies must be equal to the value at the current exchange rate. (You can find your conversions easily on google!)

- Posted prices are final, haggling will result in your commission being denied.
- Payments are due at the beginning of the commission unless worked out with me for 50/50!
- Payment plans are not subject to refunds but you are allowed to get art equal to the value of the amount paid, if you cancel your payment plan.

## *Tips*

- ❖ Any/all tips or donations received are final, that means you cannot get a refund for these!
- ❖ Tips do not ensure you get any extra work, or that I will work faster on your commission.
- ❖ Tips/donations are extremely appreciated but not required!

## *Refunds*

- If deadlines for rush orders are not met, you will receive a **partial** refund, as I cannot give full refunds as the work has already been started.
- If I decide to cancel an order for any reason you will receive a full refund.
- Being disrespectful will result in your commission being canceled and you will receive a partial refund. **This can also put you on a blacklist** depending on the severity of it.
- If your commission is not done within five months, you are entitled to a full refund. Applies only to sketches or unfinished work. This excludes large projects that feature more than one characters, animations, big refs, and health-related circumstances.

## *Usage*

- ❖ Purchasing anything for commercial usage will cost **200% of the original price**.
- ❖ I retain all copyrights to my work, unless a commercial license is bought.
- ❖ Do **not** post your commissioned art without credit to **Dokekki**.

## *Blacklist*

- If you file a wrongful chargeback against me when you are not permitted a refund your rights to work with me in the future will be revoked.
- Your commercial usage (if purchased) will be revoked.

- You will be put on my blacklist; which means you are banned from buying, or commissioning me.
- Do not ask me daily for updates, please be patient - you can still buy from me but three strikes and you're on the **blacklist**.
- Please don't share overly personal details with me or guilt trip me for not wanting to be your friend. **This is my job**. Doing so to an excessive degree will put you on my **blacklist**.
