Whereas, the Organizational Ways and Means (OWAM) Committee has the responsibility of allocating funding to Student Organizations, and

Whereas, OWAM had a significant increase in the amount of funding requested from years past, and

Whereas, funding by OWAM exceeded the budget for Fall Semester 2023, and

Whereas, OWAM took out of Spring Semester 2024 to fund Student Organizations in Fall 2023, and

Whereas, OWAM has limited funding to fund Student Organizations for the remainder of the fiscal year, and

Whereas, the committee thought it would be best to divide the funding to ensure that it would last the length of the semester, and

Whereas, the committee found that a cap of \$5000 per week would be best to ensure this would be possible.

Therefore, be it resolved by the Student Senate of the University of North Carolina at Charlotte, as follows:

SECTION I: The Student Senate supports the cap of \$5000 per week implemented by the Organizational Ways and Means Committee to ensure that funding lasts throughout the Spring 2024 Semester. In the case that the \$5000 cap is not reached in one week, the Student Senate
