Title

Concise and informative. Titles are often used in information retrieval systems. Avoid abbreviations and formulae where possible.

Affiliations

Please include the full address of each author institution. Do not use abbreviations. Affiliations should reflect where the work was performed.

Corresponding author's email address

Institutional email address preferred.

Abstract

A concise and factual abstract is required, 200 words maximum. The abstract should state briefly the purpose of the research, the principal results and major conclusions. An abstract is often presented separately from the article, so it must be able to stand alone. For this reason, References should be avoided, but if essential, cite the author(s) and year(s). Also, non-standard or uncommon abbreviations should be avoided, but if essential they must be defined at their first mention in the abstract itself.

Keywords

Provide a maximum of 6 keywords, using American spelling and avoiding general and plural terms and multiple concepts (avoid, for example, 'and', 'of'). Be sparing with abbreviations: only abbreviations firmly established in the field may be used.

Figures and tables

*Ensure that each illustration has a caption. Supply captions separately, not attached to the figure. A caption should comprise a brief title (**not** on the figure itself) and a clear description of the illustration. Keep text in the illustrations to 250 words and explain all symbols and abbreviations used. Please submit tables as editable text and not as images. Be sparing in using tables and avoid using vertical rules and shading in table cells.*

CRedit author statement
