- Who will be today's [Wendy's Member of the Meeting](#)?
- It has not been unusual in the tech review process, especially when juggling hundreds of submissions and many of us feeling overloaded with multiple responsibilities, to edit for originators instead of slowing things down with tech review back and forth. This might mean adding an "instructor-led," "active participation," or a "timely completion" to a methodology description; or fixing capitalization, formatting, a typo, or grammar in the contents; or a key SLO detail that can be easily inserted in the evaluation section; or inserting a parenthetical "classic text" next a book printed 5+ years ago. We try to do this for you, when possible, to maintain current outline standards, get through what has been a huge amount of items, and make the tech review process less time-consuming and stressful. **But this also means that when launching an outline you should look very closely at outlines very recently approved so that you can better emulate the phrasing, format, and expectations.**

- When using [the outline/addenda expiration sheets](#) be sure to use the filter view. Even better, download the sheets as Excel files so that you won't have to worry about temporarily altering colleagues' views in the shared file. Don't wait till August '25 to deal with stuff that needs to be in place for fall '26. Plan, assess, reflect, discuss, improve.
- All departments, please think deeply about the overall design of your programs and how students may be perceiving them. Might digital badges or microcredentials help with your overall design? Is there good stackability? Is there confusing redundancy? Is anything outdated? Are there any barriers to completion?
- CTE departments, are you considering course aggregate and program assessments when meeting with industry advisory groups? Think about how that might inform discussions and help with curricular design. And, again, remember to discuss new degree/certificate ideas with your advisory group and to document their support. This is needed for state-level approval.
- **Think about [Common Course Numbering Phase II](#)!** Some of these will be pushed back from fall '26 to fall '27 due to template issues, but several are now available and now to be worked on asap so that the impacts of those changes and any articulation issues can be handled for fall '26 effectiveness as well.
- **The [CCN Phase III course list](#)** is out. These course changes for fall '27 will now also include some deferred Phase II courses. Please look at the list now to help your department with planning.
- [Phase III surveys](#) close April 15! If you want to see something on a CCN outline template, respond to a survey. It couldn't hurt.
- [Disciplines list \(min quals\) update, plus a 9/30 deadline call for new disciplines](#)
- The [Proposed Revisions to Title 5](#) have received BoG approval (not yet chaptered). These revisions will need to be part of our planning.
