

The following are the rules ("**Rules**") for **inStreamly Metaverse Research** competition (the "**Competition**") being administered by **inStreamly** ("**inStreamly**").organised and administered by **inStreamly P.S.A. (simple joint-stock company)** with its registered office in Warsaw, address: ul. Lindleya 16, 02-013 Warszawa, entered to Krajowy Rejestr Sądowy (KRS, National Court Register) kept by the District Court for the Capital City of Warsaw in Warsaw, 12th Economic Division of the National Court Register, under the KRS No.: 0000953481, NIP (Tax Identification Number): 7010954779, with the share capital of PLN 64,000.00 (in words: sixty-four thousand 00/100) ("**inStreamly**"). The Competition is organised on territory of the Republic of Poland.

1. ELIGIBILITY

To be eligible for the competition, entrants must be at least 16/18 years old. Employees of inStreamly and its affiliates, subsidiaries, related companies, advertising, and promotional agencies, and the household members of any of the above, are not eligible to participate in the Competition.

2. COMPETITION PERIOD

The competition shall run from **07.12.2022** to **31.12.2022** (the "**Competition Period**") after which time no further entries will be considered.

3. HOW TO ENTER

To enter the competition entrants must:

1. **fill out the inStreamly Metaverse Survey on inStreamly's website (LINK TO THE WEBSITE: <https://instreamly.com/posts/virtual-worlds-research/>)). The answers provided will not affect the committee decision.**
2. **answer the last question, i.e. XXX (with "..." in it). Answering this question constitutes the task of the Competition and will be evaluated by the committee.**

In the event of a dispute as to who submitted an electronic entry, the entry will be deemed to have been submitted by the authorized account holder of the email account associated with the entry. "Authorized account holder" of the email account is defined as the natural person who is assigned to an email account by the email account provider.

4. PRIZES

There are **7 prizes** available to be won, (each a "**Prize**" and together, the "**Prizes**"):

1. **3x Amazon Gift Card worth 100 USD**
2. **4x Amazon Gift Card worth 50 USD**

inStreamly reserves the right, in its sole discretion, to substitute a prize of equal or greater value if a Prize or any part thereof cannot be awarded for any reason. The

Prize(s) are not transferable and not redeemable for cash, will not be extended under any circumstances and must be accepted as offered without substitution.

The owner of each winning entry can claim one Prize.

Prizes will be distributed within **fourteen (14)** business days after the winner has been successfully contacted and fulfilled the requirements set out herein. inStreamly shall not assume any liability for lost, damaged or misdirected Prizes. Each participant can win only one Prize.

5. SELECTION OF WINNER[S]

Upon completion of the competitionCompetition Period, an inStreamly committee, comprised of three (3) inStreamly employees, shall pick **seven (7) entries** from all eligible entries received during the competition Period, based on the creativity of each entry, its relevance and comprehensiveness. Each entry shall be awarded 1-5 points in each of the categories. The winners shall be picked based on the number of points awarded. If a draw occurs, the personal preference of the committee will be taken into consideration.

Each selected entrant will be notified **[by email] within three (3)** business days after the end of the competition Period. The selected entrant must respond to the notification within **three (3)** business days.

If a selected entrant does not respond within **three (3)** business days of being notified, he/she will be disqualified and another entry will be randomly selected from the pool of eligible entries. This process shall continue until **four (4)** entrants have been selected, and satisfied in full, the terms of these Rules. The odds of being selected as a winner are dependent upon the number of eligible entries received during the competition Period. However, inStreamly will not take into consideration multiple instances of the survey being filled out using the same email. Any attempt by any participant to obtain more than one entry per person by using multiple and/or different identities, email accounts, or any other methods are prohibited and may result in the person's disqualification.

inStreamly shall be in no way responsible for the failure, for any reason whatsoever, of a selected entrant to receive notification or for inStreamly's failure to receive a selected entrant's response.

6. GENERAL

By participating in the competition, you agree to abide by these Rules and the decisions of inStreamly in awarding the Prize(s), which decisions shall be final and binding upon all entrants. Entrants who have not complied with these Rules are subject to disqualification. inStreamly reserves the right, in its sole discretion, to terminate the competition, in whole or part, and/or modify, amend or suspend the competition, and/or these Rules in any way, at any time, for any reason without prior notice. For the purposes of the competition and the awarding of a Prize, these Rules

shall govern in all respects. Interpretation of these Rules and the decisions of any inStreamly representatives shall be final.

By participating in the competition, each entrant releases and holds harmless inStreamly, its affiliates and/or representatives and their respective officers, directors, employees, representatives, and agents, (the "Releasees") from any and all liability for any injuries, loss or damage of any kind to the entrant or any other person, including personal injury, death, or property damage, resulting in whole or in part, directly or indirectly, from acceptance, possession, use or misuse of any Prize, participation in the competition, any breach of the Rules, or in any Prize-related activity. Each Entrant agrees to fully indemnify Releasees from any and all claims by third parties relating to the competition, without limitation.
