

Terms and Conditions

Please read these Terms and Conditions ("Terms", "Terms and Conditions") carefully before using the GymNotes mobile application (the "Service") operated by Zvavy ("us", "we", or "our").

Your access to and use of the Service is conditioned upon your acceptance of and compliance with these Terms. These Terms apply to all users of the Service.

By accessing or using the Service, you agree to be bound by these Terms. If you disagree with any part of the terms, then you do not have permission to access the Service.

Intellectual Property

The Service is protected by copyright, trademark, and other laws of both the Georgia and foreign countries. Our trademarks and trade dress may not be used in connection with any product or service without the prior written consent of GymNotes.

User Conduct

You agree to use the Service only for purposes that are legal, proper, and in accordance with these Terms and any applicable laws or regulations.

You agree not to engage in any activity that interferes with or disrupts the Service or the servers and networks connected to the Service.

Termination

We may terminate or suspend your access to the Service immediately, without prior notice or liability, under our sole discretion, for any reason whatsoever and without limitation, including but not limited to a breach of the Terms.

All provisions of the Terms which by their nature should survive termination shall survive termination, including, without limitation, ownership provisions, warranty disclaimers, indemnity, and limitations of liability.

Changes

We reserve the right, at our sole discretion, to modify or replace these Terms at any time. If a revision is material, we will provide at least 30 days' notice prior to any new terms taking effect. What constitutes a material change will be determined at our sole discretion.

By continuing to access or use our Service after any revisions become effective, you agree to be bound by the revised terms. If you do not agree to the new terms, you are no longer authorized to use the Service.

Governing Law

These Terms shall be governed and construed in accordance with the laws of Georgia, without regard to its conflict of law provisions.

Our failure to enforce any right or provision of these Terms will not be considered a waiver of those rights. If any provision of these Terms is held to be invalid or unenforceable by a court, the remaining provisions of these Terms will remain in effect. These Terms constitute the entire agreement between us regarding our Service, and supersede and replace any prior agreements we might have had between us regarding the Service.

Processing Your Request: Upon receiving your deletion request, we will take the necessary steps to permanently delete your account and all associated personal data from our systems. The deletion process will be completed within ten (10) working days from the date we confirm receipt of your request.
