Good morning/Dear XXX/Hello XXXX,

I'm writing with the hope you might be able to support and raise awareness for our #stopthechop campaign to save an ancient Essex oak tree from being unfairly felled.

As covered by the [BBC](#) and the [Colchester Gazette](#), an old oak tree estimated to be more than 120 years old is due to be felled in Wivenhoe, Essex, next week due to claims made by an insurance company (Aviva) of subsidence – purportedly caused by the tree – affecting nearby houses. These houses are notably located on the periphery of a railway line cutting and on very gravelly soil.

Even if the tree is found to be contributing to the subsidence, other solutions – such as root zone management, crown management, transplanting the tree (sounds extreme but is achievable) and underpinning the structures affected – exist besides felling, but these have to our knowledge not been considered fully by the insurance company in question, Aviva. Instead, the local council is being intimidated with huge financial implications if they don't fell the tree.

The local community has been petitioning to save this historic oak for the past 18 months, gaining more than [2,500 signatures](#) to our petition in the last few days and with an active community group all in support of saving the tree. Architects, parents, lawyers and biodiversity specialists are amongst prominent members of the community all sharing their concerns – and reasons for – the tree not being felled. The tree is in a prominent town centre location and is a much loved landmark. It supports wildlife (over 2300 species rely on oak trees), carbon sequestration and climate resilience and as an old oak, it is irreplaceable. We are informed there may be endangered species, bats, resident in the tree which may mean felling it could be a wildlife crime. We have sought additional advice on this.

The tree contributes to the quality of place of our town, with long views in multiple directions that will be changed forever by its loss. It faces directly onto a children's playground which adds additional interest for us to save it. We want our children, and their children, to enjoy the shade of this mighty oak for generations to come. We want our children to play in a playground in sight of nature, not cars.

We appreciate any support and exposure you may be able to give this campaign. We may only be a small community of fewer than 8,000 people, but the will to preserve this beautiful tree – and its history, legacy and significance to the local community and environment – is mighty. We will be holding an event this Saturday 11th January to celebrate the tree and give the children an opportunity to enjoy its beauty, possibly for the last time.

We know this situation to be just one of many up and down the country where old oak trees and other important and well loved trees are at risk in similar circumstances. We believe protection for trees must change and hope our story at the very least will help to ensure other old oaks, other urban trees, are saved from the same fate.
