- These files are sent to the Fal Al API for processing
- Media may also be stored locally on your device
- 2. Device Information
- iOS version and device type (for performance optimization)
- App usage statistics
- Crash reports (anonymous)
- 3. Subscription Information
- Your subscription status via RevenueCat
- Purchase information from the App Store

### How We Use the Information

- Video Generation: To analyze your images and create videos
- App Improvement: To enhance performance and fix errors
- Subscription Management: To manage access to premium features

- Media is transmitted via secure HTTPS connection
