Vaccinations	Faculty, students, and staff should become vaccinated or seek exemptions.	All faculty, students, and staff must be <u>vaccinated</u> for campus access, or have approved documented exemptions.		
Face Coverings	Required in all cases, except outdoors when fully vaccinated (outdoor masking may be required in certain circumstances such as for large outdoor gatherings). Even if vaccinated, masking may continue to be a choice.			
Physical Distancing	Six foot distancing in all cases.	Distancing not required for vaccinated individuals, indoors or out. Unvaccinated individuals will be informed of any distancing precautions they must observe.		
Campus Access	Controlled through single entry point at main gate.	Campus grounds are open during daytime hours. Building card readers are enabled for BC/CU ID holders. See website for detailed information related to visitor protocols.		
Daily Health Attestation	Symptom reporting is required for all community members on a daily basis.	Symptom reporting continues to be required daily and will be connected to swipe access. "Green Screen" will be required for building access through electronic swipe control via BC/CU ID at most building entrances.		
Events and Gatherings (for Barnard/CU Attendees)	Distancing and masks required. Capacities will be determined on a case by case basis. Attendees may be Barnard/CU ID holders only.		Distancing not required. No universal capacity limitations, but capacities may be restricted on a case-by-case basis.	
Events and Gatherings (to Include Outside Visitors/Attendees)	No visitors permitted at events or gatherings.	Barnard is developing protocols related to this category of events and will distribute guidance prior to the fall.		
In-Person Classes	May be conducted with six foot distancing and fully masked. Hybrid and remote permitted through the end of Summer B.		Return to in-person classes.	
Student Arrival and Orientation	See website for health and safety requirements specific to student arrival and orientation.			
Residential Guest Policies	No access to housing except by residents.		Barnard/Columbia guests will be allowed. See website for details.	
Food and Dining (Vaccinated)	To-go food service only. Food may be consumed outdoors or in private locations, except for sanctioned planned meals for student arrivals.		Indoor dining opens. No restrictions on where food may be eaten.	
Food and Dining (Unvaccinated)	To-go food service only. Food may be consumed outdoors or in private locations such as individual offices, break rooms or student rooms/suites with no others present.			

General Visitors (non-Residence Hall)	Must provide health check via QR code at main entry gate for limited access.	Access is expanded to allow some visitors limited indoor access. Completing a health attestation remains a requirement. See website for further information, including for admissions visitors.	
Vendors	Access and protocols for vendors will be managed by designated Barnard employee managers. See website for more information.		
Barnard-Sponsored Travel	Faculty/Staff: Permission required for some international travel. Students: International travel is suspended. See website for further information.		Faculty/Staff: Permission required for some international travel. Students: International travel permissible with case-by-case approval. See website for further information.
