

# Terms & Conditions

By downloading or using the Quinault Indian Nation Tribal Electronic Fish Tickets (TEFTS) app, these terms will automatically apply to you – you should make sure, therefore, that you read them carefully before using the app. You're not allowed to copy or modify the app, any part of the app, or our trademarks in any way. You're not allowed to attempt to extract the source code of the app, and you are not allowed to translate the app into other languages or make derivative versions. The app itself, and all the trademarks, copyright, database rights and other intellectual property rights related to it, belong to Quinault Indian Nation.

Quinault Indian Nation is committed to ensuring that the app is as useful and efficient as possible. For that reason, we reserve the right to make changes to the app or to charge for its services, at any time and for any reason. We will not charge you for the app or its services without making it very clear to you exactly what you're paying for.

The Quinault Indian Nation TEFTS app stores and processes personal data that you have provided to us, in order to provide our Service. It's your responsibility to keep your phone/device and access to the app secure. We therefore recommend that you do not jailbreak or root your phone/device, which is the process of removing software restrictions and limitations imposed by the official operating system of your device. It could make your device vulnerable to malware/viruses/malicious programs, compromise its security features and it could mean that the Quinault Indian Nation TEFTS app won't work properly or at all.

You should be aware that there are certain things that Quinault Indian Nation will not take responsibility for. Certain functions of the app will require the app to have an active internet connection. ## Log Data
