



East Amwell Township School Student Device & Account Policy Acknowledgement



Each student in grades K-8 will receive a school issued device and account. As a recipient of a school-issued electronic device & account, the parent/guardian digitally signing this form agrees to comply with the following conditions:

1. I /we have reviewed the *1:1 Device Use Policy*, *East Amwell Township School Google Accounts Permission Form* and the *Internet and Network Use Agreement* on the school's website & EATS Student Handbook. We will care for our school issued device & account as outlined in the policies.
2. The student will act as a model Digital Citizen when using the school issued device. The student will use the device & account in ways that are responsible, appropriate, educational and meet EATS expectations.
3. I /we understand that the device is intended solely for educational use and that students are not permitted to download any unauthorized applications unless specifically approved by the EATS teacher, technology department or administration.
4. I /we will know where the device is at all times and I /we will do our best to never leave the device unattended.
5. We understand that students will take their devices home after school everyday for school related use, however we understand that the student will charge their device at home each school night & bring a charged device to school ready to use daily.
6. During the school day, the student will store the device safely in their school bag, desk or locker while not in use.
7. The student will not leave their device in the hallway, floor or empty rooms within the school.
8. The student will protect the device by only carrying it properly and storing it in a safe place.
9. The student will not loan the device to other individuals and understand the device is our responsibility.
10. The student will not place decorations (such as stickers, markers, etc.) on the device or charger.
11. I /we will keep food & beverages away from the device since they may cause damage.
12. I /we will not disassemble any part of my device or attempt any repairs on my own. If there is a problem I /we will report it to the Technology Department in the computer lab as soon as possible.
13. I/we understand that any damage to the device must be reported immediately to my homeroom teacher or technology department.
14. I /we will be responsible for any damage caused by neglect or misuse.
15. I /we understand that I am responsible for my device or charger if it is lost or stolen.
16. I /we will not deface the serial number or school identification label on my device or charger.
17. I /we understand that my device is subject to inspection at any time, without notice and remains the property of EATS. I /we will also provide the device passcode to staff, immediately upon request.
18. I /we understand that inappropriate content found on the device is subject to disciplinary action.
19. I/we understand that the use of devices will be governed by all terms and conditions of the East Amwell Township School policies and regulations.
20. I understand that administration has the ability to review device use and website history and my students' teachers (grades 5-8) have the ability to monitor the students' use of the device only during their class periods in the classroom.
21. I acknowledge that my child will receive an iPad (K-1) or Chromebook (2-8) along with a charger for the student to use throughout the academic year. I understand that my child is expected to return the same devices at the end of the year in good, acceptable working condition. I also understand that if my child does not return the device, charger or if the device is broken, I may be charged to repair or replace it.

As the parent or guardian, I understand and agree to the preceding terms and conditions regarding the device(s) provided to this student. I also understand that this device(s) is provided for educational purposes, and that I will not hold the Board of Education responsible for materials acquired on the Internet using this device. Further, I accept full responsibility for the actions of my child in the use of this device. I hereby give my permission to issue a device(s) to my child under the conditions above.
