Prize Draw

The title of the prize draw is Chief Walking Officer.

Key Details

- **No offer of employment is being extended via this Prize Draw. “Chief Walking Officer” is not an open role at The Sweat Foundation. “Chief Walking Officer” is a prize draw only.**
- To enter the prize draw, you will need to hold a valid Sweatcoin account and Sweat Wallet and, at the time of entry, staked 25 SWEAT in your Sweat Wallet and pay the 1 SWEAT opt-in fee.
- You cannot enter the prize draw if you reside in the USA, China, Pakistan, Russia or any jurisdiction in which the use of SWEAT is restricted as per our terms and conditions (see [here](#)).
- There is a limit of one entry per person.
- For full instructions on how to enter, and full details of the eligibility requirements to enter, please read the terms below.
- The Opening and Closing Dates of the prize draw, including respective times, are set out in paragraph 8.
- The winner will be chosen by random draw within 7 days of the Closing Date.

Promoter

The Promoter of the prize draw is The Sweat Foundation Ltd, a company registered in the British Virgin Islands under company number 2081818 with its registered office at Trinity Chambers, PO Box 4301, Road Town, Tortola, British Virgin Islands (“**The Sweat Foundation**”).



General Rules

1. These Terms and Conditions prevail in the event of any conflict or inconsistency with any other communications, including advertising or promotional materials.
2. By participating, all entrants will be deemed to have accepted and be bound by these Terms and Conditions and by the decisions of The Sweat Foundation.
3. The Sweat Foundation's decisions are final in all matters relating to the prize draw.
4. The Sweat Foundation may cancel, suspend, or amend the prize draw where it becomes reasonably necessary to do so.
5. The prize draw will be governed by English law and entrants to the prize draw submit to the jurisdiction of the English courts.
6. Please retain a copy of these Terms and Conditions for your information.
7. You acknowledge and agree that in entering the prize draw: you will comply with all applicable laws and regulations; and the prize(s) awarded to the prize winner will not be used or dealt in a way that is incompatible with such applicable laws and regulations.

Prize Draw Period

8. The prize draw will run from 18:00 UTC on 3 April 2023 (the "Opening Date") to 23:59 UTC on 16 April 2023 (the "Closing Date") inclusive.
9. All prize draw entries must be received by The Sweat Foundation by no later than the time stated above on the Closing Date. All entries received after that time on the Closing Date are automatically disqualified.

How to Enter and Eligibility:

10. To enter the prize draw you must:
 - a. be aged 18 or over at the time of entry;
 - b. be the holder of a valid Sweat account;
 - c. be the holder of a valid Sweat Wallet;
 - d. have, at the time of entry, staked 25 SWEAT in your Sweat Wallet;
 - e. paid the 1 SWEAT opt-in fee



- f. successfully completed all campaign actions as determined and communicated by The Sweat Foundation; and
 - g. comply with our general terms and conditions which can be found [here](#).
11. You cannot enter the prize draw if you reside in the USA, China, Pakistan, Russia or any jurisdiction in which the use of SWEAT is restricted as per our terms and conditions (see [here](#)).
 12. In entering the prize draw, you confirm that you are eligible to do so and are eligible to claim the applicable prize. The Sweat Foundation may require you to provide proof that you are eligible to enter the prize draw.

 15. There is a limit of one entry per person. Entries on behalf of another person will not be accepted and joint submissions are not allowed.
 16. No purchase is necessary to enter the prize draw.

Ineligible Entries

17. The Sweat Foundation will not accept prize draw entries that are:
 - a. automatically generated by computer, completed by third parties or in bulk, illegible, have been altered, reconstructed, forged or tampered with or are incomplete;
 - b. received outside of the prize draw period;
 - c. from individuals who have submitted more than one entry, either through the use of multiple accounts or through the same account; or
 - d. from personnel of The Sweat Foundation (including employees), or its holding or subsidiary companies (or their holding or subsidiary companies), and their immediate families or associates, or anyone professionally connected with the prize draw.
18. The Sweat Foundation reserves all rights to disqualify you if your conduct is contrary to the spirit or intention of the prize competition.

The winner



19. A winner will be chosen by random draw by computer algorithm via live stream on 17 April 2023 14:00 UTC. The decision is final and binding and no correspondence or discussion will be entered into in relation to it.
20. The winner will be notified by The Sweat Foundation using the contact details provided at entry/through their account within 21 days of the Closing Date.
21. Reasonable efforts will be made to make contact with the prize winner over a period of three weeks from the initial notification. If it has not been possible to contact the winner in that time, the prize may be forfeited and The Sweat Foundation reserves the right to offer the prize to the next eligible entrant selected from the correct entries that were received before the Closing Date.
22. If it turns out that a winner (i) was ineligible to participate as set out in these Terms and Conditions, (ii) fraudulently entered the prize draw or (iii) otherwise obtained an unfair advantage in the reasonable opinion of The Sweat Foundation, the prize will be forfeited and awarded to the next eligible entrant.

The Prize

23. The prize is 2000 USDC or 2000 USDT per month for 12 months (the “**Prize**”). Exact timings, delivery methods, and other logistical details will be communicated by The Sweat Foundation to the winner.
24. In order to receive the entire Prize, the winner must:
 - a. Walk an average of 5,000 steps a day, as recorded in their Sweatcoin app;
 - b. Send a “selfie” to The Sweat Foundation once a month;
 - c. Regularly create video/photo content during the 12 month period to be shared with The Sweat Foundation for marketing purposes, with expectations to be agreed with The Sweat Foundation.
 - d. Attend media interviews(video or written) and press coverage with the Sweat Foundation for marketing purposes to illustrate the results of this campaign
25. The Sweat Foundation may not be able to offer and deliver the Prize for the following reasons:
 - a. The Prize is not able to be delivered to the winner for regulatory or legal reasons;
 - b. Any other reason due to circumstances beyond The Sweat Foundation’s reasonable control as determined by The Sweat Foundation in its reasonable opinion.
26. In the event that The Sweat Foundation is unable to offer and deliver the Prize as described in paragraph 30, The Sweat Foundation may replace the Prize with an alternative prize of equal or higher value including (but not limited to) to be decided in the absolute sole discretion of the Sweat Foundation.



27. The Prize is not a salary payment, and no employer-employee relationship is created by virtue of these Terms or the overall Chief Walking Officer prize draw.
28. The Prize is not paid in any traditional currencies. The Prize is solely paid in cryptocurrencies. The winner is solely responsible for keeping their cryptocurrencies and cryptocurrency wallets safe.

Limitation and Exclusion of Liability

29. The Sweat Foundation's responsibility to the eligible winner (determined in accordance with these Terms and Conditions) is delivery of the Prize in accordance with these Terms and Conditions. The Sweat Foundation must only deliver the Prize to the wallet address specified by the winner. The Sweat Foundation has no obligation to verify the winner's wallet address, protect the winner against computer viruses or other malicious systems or actors, or otherwise ensure that the Prize reaches the winner. The winner shall be solely responsible for keeping their wallet address and the received Prize safe, keeping their email accounts, computer systems, and other technological systems safe, and otherwise protecting their communications with The Sweat Foundation.
30. Except for liability for death or personal injury caused by The Sweat Foundation's negligence, and any other liability where it would be unlawful for The Sweat Foundation to exclude, The Sweat Foundation shall not be liable for any loss or damage incurred or suffered by any person, including, but not limited to, indirect or consequential loss, by reason of any act or omission by The Sweat Foundation, or its agents or distributors, in connection with the arrangement with the supply of the Prize to the winner or in connection with the prize draw.
31. The Sweat Foundation shall not be liable for any failure to comply with its obligations where the failure is caused by something outside its reasonable control. Such circumstances shall include, but not be limited to, weather conditions, fire, flood, hurricane, strike, industrial dispute, war, hostilities, political unrest, riots, civil commotion, inevitable accidents, epidemic or pandemic and supervening legislation or government or regulatory requirements.
32. Your statutory rights are not affected.

Use of your Data

33. The Sweat Foundation may verify all entries including but not limited to asking for address and identity details, and voiding any prize awards where the requested information is not provided.
34. If you object to any or all of your name, city, country and winning entry being published or made available, please contact The Sweat Foundation. In such circumstances, The Sweat Foundation may still be required to provide the information and winning entry to the UK Advertising Standards Authority or any other similar body on request.
