

## **Bowman-Shannon Cultural Arts Fund**

The purpose of the Bowman-Shannon Cultural Arts Fund of the Shenandoah Community Foundation is to educate, guide and stimulate the enjoyment of and participation in cultural arts in Shenandoah County, Virginia. For this purpose, the term "cultural arts" includes individual and group artistic expressions through drawing, painting, collage, glasswork, pottery and other ceramics, weaving, sculpture, carving, photography, film, video, other digital and electronic media, music, theatre, dance, writing, and any other mode or medium of visual, aural, tactile, physical, or written artistic expression, including artistic expression for or by special needs individuals.

In 2025, a total of \$11,000 is available to staff of the Shenandoah County Public Schools for cultural arts projects as described above. Applications will be due on November 14, 2025, no later than 4 p.m. and funding will be awarded in February 2026.
