A. **Call to Order** – M. Ogden, Interim Chair, called the Regular Meeting of the School Committee of May 24, 2023, to Order at 7:03pm, at the High School Library.

3. Elect Vice-Chair of the School Committee
A motion was made to nominate J. McLean as Vice-Chair of the School Committee by C. Balmer, seconded by P. Bourque.

Committee by C. Bolzan, seconded by P. Bernheart.
T. Currier asked if the nomination of the Vice Chair had to be a member from Boxford and could there be a second nomination. He added that the Vice Chair needs to be physically present at meetings when the Chair is not available. J. McLean's work schedule may not allow for this. J. McLean stated that there was a merger at his work that caused the travel in order to establish work groups over 3 continents. Travel is not necessary now except for a week or two which will be scheduled around School Committee meetings. Discussion followed regarding the tradition of towns rotating into Vice Chair and Chair seats and having a second nomination on the floor. M. Harvey clarified that according to Robert's Rules you can have a second nomination. The vote is taken on the candidate in the order that the nomination is made, if the first person nominated receives a majority vote then no additional nominations are considered. **A second motion was made to nominate Trevor Currier as Vice-Chair of the School Committee by K. Petrone, no second is required.**

C. Remarks from the Chair – M. Ogden thanked everyone who ran for School Committee and welcomed the new members. She reviewed her first term on the School Committee in 2020 and that “we must move forward together”. She reviewed the upcoming projects to be accomplished by the School Committee. M. Ogden reviewed the work done by the School Committee members and asked that everyone be respectful of each other, put the students first, be kind, flexible and work together.

E. Review School Committee Protocols – School Committee and Superintendent Roles Graphic – M. Harvey and M. Ogden reviewed the School Committee protocols. Each member read aloud the protocols and signed the protocol document. M. Ogden explained that the School Committee’s work is similar to a legislative body creating policy and the superintendent carries out the policies with the leadership team. M. Harvey reviewed the graphic showing the School Committee and Superintendent individual roles and overlapping roles.

F. Review Sub-Committee Composition – M. Ogden explained that there are three major sub-committees, Community Relations, Budget and Policy. The other sub-committees are Anti-Racism, Turf Up, Negotiations, Liaison. Capital Budget and Strategic Planning will be added while others will be combined. M. Ogden asked that each member fill out the form indicating which sub-committees they want to be involved with. Roles of the sub-committees were reviewed.
