

APPEARANCE CONTRACT

THIS **AGREEMENT** is entered into as of this ____ day of *month*,

SECTION 1

PROMOTER hereby engages the services of **PERFORMER** for a
PERFORMANCE under the conditions set forth in the **DJ**
RustRyu Technical Rider except as amended or modified in this
document. This contract is for a controller performance only.

B. Location of Appearance

SECTION 2

PROMOTER agrees to provide **PERFORMER** with

- A. Performance fee** of _____ to be paid directly to **PERFORMER**'s legal name Barnaby Felton, in cash, direct transfer, or digital monetary exchange (including digital check).
- B. Listing as a GUEST DJ**, accompanied by a photo and short bio, in all **EVENT** communications media (e.g., website, flyers, etc.).
- C. Admission to the EVENT** with guest-level credentials for both **PERFORMER** and a companion. This access includes any events ancillary to the event (e.g. afterparties).
- D. Access to performer hospitality suite** or catering for the duration of the event. If not available, a catering buyout of \$60 per performance day may be substituted.
- E. If the booking is for a multi-day event**, lodging must be provided for the **PERFORMER** and one companion in a 4 star or better hotel within 5 miles of the venue.
- F. Gas and toll reimbursement** in the amount of \$25 for every 0-100 miles that have to be driven to the venue, if it is a drive in event.
- G. Secure onsite parking** for **PERFORMER**'s vehicle at no cost to **PERFORMER**.
- H. If it is a fly in event**, airfare for **PERFORMER** and one companion will be negotiated in an addendum.

SECTION 3

In consideration of the above items and provided all stated and referenced terms are met,

PERFORMER shall provide his services as DJ at the **EVENT** to be held on

PERFORMER shall provide his services in a competent manner, arrive and appear at times specified between the parties, abide by all reasonable rules and requirements that **PROMOTER** shall make.

SECTION 4

PROMOTER will arrange for any publicity relating to **PERFORMER's** appearance for the event. **PERFORMER** agrees to provide or pose for customary and usual photographs and/or bios to be used for publicity.

SECTION 5

Either party may terminate this contract by giving the other party at least three (3) weeks notice in writing. This contract shall automatically terminate without further notice at the end of the term of appearance.
