I, Michael John Arnup, a living man under the **Common Law of England** and subject only to the **Commonwealth of Australia Constitution Act 1901 as Proclaimed and Gazetted under the Royal Coat of Arms**, hereby issue this rebuttal and demand for proof of lawful authority.

## REBUTTAL
