

## Privacy Policy for NewMitBBS Reader

*Last Updated: April 25, 2025*

Welcome to NewMitBBS Reader, a content reader application developed by LeafArtistic. This Privacy Policy explains how we handle your information when you use our app. We are committed to protecting your privacy and ensuring transparency.

### 1. Information We Collect

NewMitBBS Reader itself collects minimal data, limited to user settings stored locally on your device. Additionally, the app uses third-party services that may collect certain information as described below:

- **Locally Stored Settings:**
  - NewMitBBS Reader saves user preferences (e.g., font size, theme, or reading preferences) locally on your device. This data is not transmitted to or stored on any servers controlled by LeafArtistic.
  - These settings are stored in the app's local storage and are only used to customize your experience within the app.
- **Third-Party Advertising (AdMob):**
  - We use AdMob, a Google advertising service, to display ads in NewMitBBS Reader. AdMob may collect:
    - **Device Information:** Information such as device type, operating system, unique device identifiers (e.g., Advertising ID), IP address, and other technical data to serve relevant ads.
    - **Usage Data:** Anonymized data about your interactions with ads (e.g., ad impressions, clicks).
    - **Location Data:** Approximate location (derived from IP address or device settings) to deliver location-based ads, if enabled by your device settings.
  - AdMob's data collection is governed by Google's Privacy Policy. You can opt out of personalized ads via your device settings (see Section 6).
- **No Other Data Collection:** Apart from local settings, NewMitBBS Reader does not collect user-provided data (e.g., names, emails, bookmarks) or transmit any data to LeafArtistic's servers.

### 2. How We Use Your Information

The information handled by NewMitBBS Reader is used as follows:

- **Locally Stored Settings:** User preferences are used solely to customize your app experience (e.g., applying your chosen font size or theme).
- **AdMob Data:** Data collected by AdMob is used to serve advertisements within the app and analyze ad performance to improve the advertising experience. LeafArtistic does not directly access or use this data.

### 3. How We Share Your Information

LeafArtistic does not share any personal information because we only store settings locally and do not collect other data. However:

- **Third-Party Service Providers:** AdMob, operated by Google, collects and processes data as described above. This data may be shared with Google's partners for ad delivery and analytics, as outlined in Google's Privacy Policy.
- **Legal Requirements:** We may disclose data collected by third parties if required by law or to protect our rights, safety, or property.

### 4. Data Storage and Security

- **Local Storage:** User settings (e.g., font size, theme) are stored locally on your device in the app's storage. This data is not transmitted to any external servers.
- **AdMob Data:** Data collected by AdMob is stored and secured by Google according to their policies. LeafArtistic has no control over AdMob's data storage practices.
- **Security:** Locally stored settings are protected by your device's security features (e.g., app sandboxing). You are responsible for securing your device and managing app permissions. LeafArtistic implements no additional server-side security since no data is stored remotely.

### 5. Children's Privacy

NewMitBBS Reader is not intended for children under 13. We do not knowingly allow AdMob to collect personal information from children under 13. AdMob complies with the Children's Online Privacy Protection Act (COPPA) by limiting data collection for users identified as under 13. If you are a parent or guardian and believe your child has interacted with ads in a way that violates COPPA, contact us at [dclone.notifier@gmail.com](mailto:dclone.notifier@gmail.com) or Google directly.

### 6. Your Rights and Choices

You have control over the data associated with NewMitBBS Reader:

- **Manage Local Settings:** You can modify or delete your settings (e.g., reset font size or theme) within the app's settings menu. Uninstalling the app will remove all locally stored settings.
- **Opt-Out of Personalized Ads:** You can disable personalized ads by adjusting your device settings:
  - On Android: Go to **Settings > Google > Ads > Opt out of Ads Personalization**.
  - Alternatively, reset your Advertising ID in your device settings.

- **Manage Permissions:** Review and modify app permissions (e.g., internet access for ads) via your device settings.
- **Limit Location Data:** Disable location services for NewMitBBS Reader in your device settings to prevent AdMob from using location-based data.

For users in the EU (GDPR) or California (CCPA), you may have additional rights, such as opting out of data sharing by AdMob. Visit Google's Privacy Policy or contact Google for details.

## 7. Third-Party Links

NewMitBBS Reader may include ads or links to external websites served by AdMob. We are not responsible for the privacy practices of third-party sites or advertisers. Review their policies before providing information.

## 8. Changes to This Privacy Policy

We may update this policy to reflect changes in our practices or legal requirements. We will notify you of significant changes via the app. Check this page regularly for updates.

欢迎使用由LeafArtistic开发的内容阅读应用程序新MitBBS阅读器。本隐私政策说明了您在使用我们的应用程序时我们如何处理您的信息。我们致力于保护您的隐私并确保透明度。

### 1. 我们收集的信息

新MitBBS阅读器本身收集最少的数据,仅限于本地存储在您设备上的用户设置。此外,该应用程序使用第三方服务,可能会收集如下所述的某些信息:

本地存储的设置:

新MitBBS阅读器将用户偏好设置(例如字体大小、主题或阅读偏好)保存在您的设备上。这些数据不会传输到或存储在LeafArtistic控制的任何服务器上。

这些设置存储在应用程序的本地存储中,仅用于在应用程序内定制您的体验。

第三方广告(AdMob):

我们使用Google的广告服务AdMob在新MitBBS阅读器中显示广告。AdMob可能收集以下信息:

设备信息:包括设备类型、操作系统、唯一设备标识符(如广告ID)、IP地址以及其他技术数据,以提供相关广告。

使用数据:关于您与广告互动的匿名数据(例如广告展示次数、点击次数)。

位置数据:根据IP地址或设备设置推导的大约位置信息(如果您的设备设置启用了该功能),用于提供基于位置的广告。

AdMob的数据收集受Google隐私政策的约束。您可以通过设备设置选择退出个性化广告(见第6节)。

无其他数据收集:除本地设置外,新MitBBS阅读器不收集用户提供的数据(例如姓名、电子邮件、书签)或将任何数据传输到LeafArtistic的服务器。

## 2. 我们如何使用您的信息

新MitBBS阅读器处理的信息使用方式如下:

本地存储的设置:用户偏好仅用于定制您的应用程序体验(例如应用您选择的字体大小或主题)。

AdMob数据:AdMob收集的数据用于在应用程序内提供广告并分析广告表现,以改善广告体验。LeafArtistic不直接访问或使用这些数据。

## 3. 我们如何共享您的信息

LeafArtistic不共享任何个人信息,因为我们仅在本地存储设置且不收集其他数据。然而:

第三方服务提供商:由Google运营的AdMob按上述方式收集和處理数据。这些数据可能与Google的合作伙伴共享,用于广告投放和分析,具体见Google的隐私政策。

法律要求:如法律要求或为保护我们的权利、安全或财产,我们可能披露第三方收集的数据。

## 4. 数据存储和安全

本地存储:用户设置(例如字体大小、主题)存储在您设备的应用程序存储中。这些数据不会传输到任何外部服务器。

AdMob数据:AdMob收集的数据由Google根据其政策存储和保护。LeafArtistic无法控制AdMob的数据存储做法。

安全:本地存储的设置受您设备安全功能(例如应用程序沙盒)的保护。您有责任保护您的设备并管理应用程序权限。LeafArtistic不实施额外的服务器端安全措施,因为没有数据存储在远程服务器上。

## 5. 儿童隐私

新MitBBS阅读器不适用于13岁以下的儿童。我们不会故意允许AdMob从13岁以下儿童收集个人信息。AdMob遵守《儿童在线隐私保护法》(COPPA),限制对被识别为13岁以下用户的数据收集。如果您是父母或监护人,相信您的孩子与广告的互动违反了COPPA,请通过 [dclone.notifier@gmail.com](mailto:dclone.notifier@gmail.com)联系我们或直接联系Google。

## 6. 您的权利和选择

您可以控制与新MitBBS阅读器相关的数据:

管理本地设置:您可以在应用程序的设置菜单中修改或删除您的设置(例如重置字体大小或主题)。卸载应用程序将删除所有本地存储的设置。

选择退出个性化广告:您可以通过调整设备设置禁用个性化广告:  
在Android上:转到设置 > Google > 广告 > 选择退出广告个性化。

或者,重置您的广告ID。

管理权限:通过设备设置审查和修改应用程序权限(例如用于广告的互联网访问)。

限制位置数据:在设备设置中禁用新MitBBS阅读器的位置服务,以防止AdMob使用基于位置的数据。

对于欧盟(GDPR)或加利福尼亚(CCPA)的用户,您可能有额外的权利,例如选择退出AdMob的数据共享。详情请访问Google的隐私政策或联系Google。
