

## Privacy Collection Statement –Account application / Sales

Sealanes (1985) Pty Ltd (ACN 009 121 331) (**Sealanes**) is committed to protecting the privacy of individuals and their personal information and complies with the *Privacy Act 1988* (Cth) (**Privacy Act**).

Please read this carefully as it will have important consequences for you in relation to the collection, use and disclosure of your personal information you provide to Sealanes.

You understand that:

Sealanes will collect your personal information directly from you. In certain circumstances, Sealanes may be required to collect personal information from third parties, including but not limited to:

if applicable, any guarantor or contact listed on any application for credit;

service providers (including IT service providers, contractors and sales consultants) who assist Sealanes in providing our products and services to you;

third parties connected with the sales and after sales process including, ecommerce services and financial institutions;

those instances where we may be required to collect information by law, without any requirement to notify you of the same; and

our contractors, agents, partners, suppliers or other companies who assist us in processing your application and providing our products and services to you.

The purpose of Sealanes collecting your personal information is:

to facilitate the processing of your application for credit with Sealanes in relation to new accounts with Sealanes, and any products or services you have procured from Sealanes and the administration and management of the foregoing, which shall include but is not limited to providing any refunds of any products or services purchased;

to provide other customer service functions, including handling sales related customer enquiries and complaints relating to any sales of products or services; and

to offer you updates, discounts, or other content or products and services that may be of interest to you and to provide you with direct marketing communications from us or our related entities and associates (via direct mail, telemarketing or email),

and you acknowledge and agree to your personal information being collected and used for, and in connection with, these purposes and any other purpose set out in our Privacy Policy and Credit Reporting Policy.

If we do not collect this personal information in connection with the purposes in paragraph 3, then:

Sealanes will be unable to facilitate the processing and administering of your application for credit;

we may be unable to assist you in relation to any sales related enquiries; and

we will be unable to send you direct marketing communications (unless you have consented to such communications through your other dealings with Sealanes).

Your personal information may be disclosed to the following classes of people and organisations in connection with the purposes in paragraph 3:

Sealanes, its personnel and related entities;

If applicable, any guarantors, contacts or referees listed in your application for credit;

third party service providers including without limitation IT service providers, contractors and sales consultants and other parties who assist us in providing our products and services to you;

third parties connected with the sales and after sales process including, ecommerce services and financial institutions;

third parties, such as the appropriate court (depending on the value of the debt) or other entities to which we are required by law to disclose personal information, should the delay in payment of a debt proceed to litigation; and

any other organisation as expressly covered in our Privacy Policy and Credit Reporting Policy.

It is possible that some of the information collected may be disclosed and utilised by service providers or contractors who assist in the administration of Sealanes and provision of its services (such as IT providers or providers who undertake credit related services on our behalf), who may be based outside

of Australia or store their data in another jurisdiction . You **consent** to your information being disclosed to a destination outside of Australia for this purpose and you understand and acknowledge that Australian Privacy Principle 8.1 will not apply to such disclosures of your personal information.
