# **OUR VISION**

A health-informed end to homelessness in Australia.

# **OUR MISSION**

- To promote collaboration amongst the healthcare, homeless and housing sectors to drive innovative responses to the health and housing needs of the homeless.
- 2. To ensure the health-informed implementation of the Advance to Zero Campaign to end all homelessness in Australia starting with rough sleeping.
- 3. To provide a national forum for the sharing of experiences and the development of new tools, guidelines, models of care and other resources to support practitioners in the health, housing and homelessness sectors.
- 4. To support and develop strategic national initiatives to address the health and housing needs of people experiencing homelessness in Australia.
- 5. To advocate, with local and national partners, for greater funding and a greater role for health care systems in contributing to an end to homelessness in Australia.

## **OUR WORK**

- 1. Establish the Network's governance, administrative and membership structures.
- 2. Get key players/influencers in the health sector on board.
- 3. Increased investment from the NHMRC, AHURI, Philanthropy and elsewhere in this work.
- 4. Developing policy papers to inform and support advocacy for more joined-up policy making and investment.
- 5. Raising awareness of, better counting and supporting efforts to prevent the number of people dying whilst experiencing homelessness each year.
- 6. Supporting people in the 3H sector generally with upskilling, and encouraging their engagement in the Advance to Zero Campaign to end homelessness.

- 1. Quarterly online meetings.
- 2. Workshop at the biennial Advance to Zero Summit.
- 3. Occasional policy/advocacy forums on particular topics.
- 4. Annual National Homelessness Deaths Memorial.
- 5. Training.

# **RATIONALE**

The A3HN has developed its policy asks because:

- Each year we estimate that approximately 424 people die whilst experiencing homelessness.
- People who experience chronic homelessness can die up to 30 years younger than those who are sustainably housed. There is a clear moral case.
- We also know that it is more expensive to leave people in a state
  of chronic homelessness, to the health system, housing,
  homelessness and other systems, than to provide permanent
  supportive housing. There is a clear business case
- Despite having a universal health system, not all Australians enjoy health equity. Access to healthcare for people experiencing homelessness is a big issue.
- As a result, additional pressure is put onto our hospital systems which are already incredibly stretched for a range of reasons.
- Hospital avoidance is everyone's priority, and yet it is the focus of too few.
