

# **The Murder Recap of a famous YouTuber Gabby petito!**

## **Gabby Petitos Murder Recap:**

### **About Gabby petito:**

Ms Petito's bones were discovered in western Wyoming's Bridger-Teton National Forest this weekend, according to a post-mortem investigation conducted last week. The coroner declared her death a murder based on his early findings.

The 22-year-old went on a cross-country camper van road trip with Mr Laundrie, 23. They were visiting the Grand Teton National Park.

Mr Laundrie, however, returned to Florida without Ms Petito after a month on the road. On September 17, his relatives reported him missing. They stated he went on a trek three days before and never returned.

Following Ms Petito's death, the FBI filed a federal arrest warrant, accusing him of illegally using a debit card. On October 21, his corpse was discovered in a Florida park.

## **Observations before Murder:**

Petito and Laundrie were at Blue Point, New York, on June 17, 2021, for Petito's brother's graduation ceremony. They then embarked on a cross-country journey in a Ford Transit van on July 2, 2021.

Monument Rocks, Great Sand Dunes National Park and Preserve, Zion National Park, Bryce Canyon National Park, Mystic Hot Springs, and Canyonlands National Park were among the places they visited during that month.

## **The Incident Of Domestic Disturbance:**

On August 12, 2021, a witness reported a couple arguing in front of the Moonflower Community Cooperative in Moab, Utah, to the 9-1-1 emergency response phone line. The pair was subsequently identified as Laundrie and Petito.

The caller said that they saw a guy smack a lady, and that after the two ran up and down the sidewalk, the man slapped her again before driving away.

Petito and Laundrie were talking "aggressively" and Petito "was striking him in the arm," according to another witness who gave police a statement. Petito eventually climbed into the driver's seat, moved over to the passenger seat, and asked, "Why do you have to be so mean?" the witness said Laundrie appeared to be attempting to leave Petito and take her phone with him before Petito eventually climbed into the driver's seat, moved over to the passenger seat, and asked, "Why do you have to be so mean?" They then drove away.

Police located the vehicle at the Arches National Park entrance and conducted a traffic check. Petito was discovered weeping hard in the passenger seat, telling authorities, which was recorded on police body camera tape.

## **The incident happened with Brian Laundrie:**

Mr Laundrie's family reported him missing on September 17th, stating he had gone for a trek on September 14th and never returned.

Before his remains were recovered on October 21, teams spent weeks exploring the Carlton Reserve, a 24,000-acre park in Sarasota County, Florida, using police dogs, drones, and all-terrain vehicles.

Mr Laundrie and Ms Petito had relocated to North Port, Florida, in 2019, and federal officials had searched his parents' house for over eight hours.

Several boxes were removed from the property, and a silver Ford Mustang was towed away by agents.

Mr Laundrie had dodged authorities and refused to provide them any information before vanishing.

His lawyer, Steve Bertolino, had planned a press conference on September 21, but canceled it after meeting with the FBI. According to local media, he said that going forward with the event was not in his "client's best interest."

Mr Bertolino published a brief statement after learning of Ms Petito's death, saying, "May Gabby rest in peace."

On September 24, the FBI said that Mr Laundrie had been issued a federal arrest warrant for his "usage of unapproved devices."

Between August 30 and September 1, according to the indictment, he used a debit card and PIN number for accounts that did not belong to him. It was unclear if Ms Petito was the owner of the debit card.

## **The most recent sightings and activities have been reported.**

Laundrie flew from Salt Lake City to Tampa, Florida on August 17, leaving Petito alone. Petito checked out on August 24 after staying several days at a Fairfield Inn

and Suites hotel near Salt Lake City International Airport, according to staff. Laundrie made the trip to "obtain some items and empty and close the storage unit to save money as they contemplated extending the road trip," according to the Laundrie family lawyer. On August 23, he returned to rejoin Petito and finish the journey.

Petito's mother said she last spoke to her daughter on August 25, when she told her they were heading to Grand Teton and Yellowstone National Parks from Utah. Petito's final Instagram post was on August 25, and it consisted of photos of herself in front of a butterfly mural outside of a restaurant in Ogden, Utah.

## **Petito and Laundrie have both gone missing.**

Petito's mother filed a missing person report on September 11 after not hearing from her daughter since late August.

Laundrie was named a person of interest on September 15. Laundrie's parents hired an attorney and, on his advice, remained silent about the case, refusing to speak to anyone about it.

On September 13, police were watching the Laundrie home and saw him leave. They saw his car return on September 15, and police believe Laundrie was the person who exited the car and entered the house. North Port Police Chief Todd Garrison told reporters at a press conference on September 16 that "all I'm going to say is we know where Brian Laundrie is." Laundrie was reported missing by his parents on September 17 after they hadn't seen him since September 13.

At this point, the cops realized their error and realized that the person exiting Laundrie's car was actually his mother, and that they had no idea where Laundrie was. Laundrie and his mother are "built similarly," according to police, and she was wearing a baseball cap, leading them to believe she was Laundrie.

Police seized the van, an external hard drive, and the family's Ford Mustang from Laundrie's family home after obtaining search warrants.

## **Petito's remains were discovered.**

Human remains matching Petito's description were discovered on September 19, 2021, in the Bridger-Teton National Forest's Spread Creek Dispersed Camping Area, just outside Grand Teton National Park and not far from where the van was last seen. Her identity was verified, and an autopsy revealed that she died of a homicide by strangulation three to four weeks before her body was discovered.

## **Laundrie's remains were discovered during the search for her.**

The United States District Court for the District of Wyoming issued an arrest warrant for Laundrie on September 23 for obtaining US\$1,000 or more using someone else's debit card without their permission between August 30 and September 1. The FBI retrieved items from Laundrie's residence in order to match his DNA.

Laundrie's sister pushed him to turn himself in to police in an interview with ABC News on October 5.

Laundrie's father accompanied detectives in investigating the Carlton Reserve on October 7. The FBI, police, and Laundrie's parents looked for him at the reserve and the nearby Myakkahatchee Creek Environmental Park, where he liked to hang out.

Laundrie's skeleton remains, verified by forensic dentistry, and some of his possessions were discovered in the park on October 20 in an area that had just been flooded. An autopsy revealed no cause of death, therefore his bones were sent to an anthropologist for further investigation.
