Howdy! I'm Jade, and these are my terms of service; thank you so much for taking the time to consider commissioning me! ^_^ All of this here is information you should know before requesting anything from me! And if anything is unclear, you are free to ask!



GENERAL TERMS



- By commissioning me, I will take that as you have read the TOS and are willing to comply with what is written within it.
 - ◆ **I am allowed to decline a commission if I so choose.**
- With having ownership over all pieces that I have done, it is possible that I may post them publicly and use them as examples of my work.
 - ◆ I will always ask beforehand if I have permission to do so. I will not claim anything that isn't my work as my own.
- I am NOT a professional by any means; avoid commissioning me if you're expecting professional results.
- Turnaround Time may be anywhere from a few days to a month, depending on my queue.
 - ◆ Updates may be requested at any point in time.



PRICING & PAYMENT



- At this point in time, any transactions **must** be done through **Cashapp OR Paypal** in **USD**.
 - ◆ Should you live in an area with harsh price conversions, I am open to negotiations/discounts.
- More complex/experimental works will generally result in higher pricing. This will all be discussed before I go into the sketch phase.
- I will always ask for payment **after I send you the sketch**.
 - ◆ You may request to pay earlier, but it is not expected.
 - ◆ You may also request to pay in multiple parts.

REFUND POLICY

As of **1/15/25**, I can provide **full refunds**. The amount you may receive will be based on how much progress has been made on your order.

- If the commission has not been started, you will receive **100%** of the amount that **I** received.
- If a sketch has been done, you will receive **50%**.
- If more than a sketch has been done, you will receive **25%**.
- **I will not give you a refund for a completed piece.**



TERMS OF USE



- You may use my works for any **non-profit use by default**. (Ex. Avatars/Icons, Headers, Wallpapers, etc. Just make sure they're linked back with proper credit!)
 - ◆ Which means you may **not** use it for commercial items, such as merchandise, or resell, **unless we have discussed it beforehand**.
- If you have not been given a **PSD** of your commission, please **do not** try to edit it yourself. If you want something to be fixed, you can alert me!
- You may not use commissioned works that you did not request yourself without **explicit permission** from the commissioner.
 - ◆ Unless it was bought for you *and* them, in which case, you don't have to ask. <3



CONTENT I WILL NOT DRAW



(Note that if you are ever confused about where I draw the line, you are always welcome to ask. The more transparency, the better!)

- **Not Safe For Work (NSFW) or Not Safe For Life (NSFL)** content.
 - ◆ Suggestive works are a fine line and may be discussed.
 - I will **not** draw nudity.
 - **I will also not draw anything fetish/kink related.**
 - ◆ Gore itself is also a fine line and should be discussed.
- **Anything that promotes hate speech of any kind.**
- **Non-consenting IRL people/couples.**
- **Age Gap Relationships.**
 - ◆ Or any relationships that make me raise a red flag or two.
- Anything that would get me in trouble with the Law, for that matter. Be sensible.
