Ansvarsområder

Dansk Frisbee Sport Union sender XXX som holdkaptajn for den danske delegation til EM i disc golf i august 2020. Holdkaptajnens primære rolle er at fungere som bindeled mellem de danske deltagere og organisationen. Her tænkes både i forhold til DFSU og EDGF. Holdkaptajnen skal groft sagt sørge for, at spillerne under turneringen ikke behøver at bekymre sig om andet end at spille og tænke disc golf samt spise, restituere, sove og møde rettidigt til næste runde.

Ansvarsområder før turneringen

- Sikre at diverse deadlines ift registreringen overholdes (i samarbejde med DFSU) - se nedenstående tekst fra EDGF.
- Sikre at spillerne får de nødvendige oplysninger vedr. turneringen.
- Evt booking af tee-tider til træning i samråd med spillere
- Sikre at spillerne får udleveret spillertøj inden turneringen (i samarbejde med DFSU)
- Holdkaptajnen skal som minimum være på lokationen senest tirsdag inden turneringsstart onsdag. DFSU ser dog helst at holdkaptajnen er til stede fra mandag til og med lørdag.

Ansvarsområder under turneringen

- Holdkaptajnen deltager i alle møder under turneringen, hvor repræsentation af DK repræsentant eller holdkaptajner er påkrævet.
- Holdkaptajnen repræsenterer Danmark ved de officielle ceremonier



- Holdkaptajnen er ansvarlig for kommunikationen mellem spillere og turneringsledelse
- Sikre at alle spillere er velinformerede ang turneringsprogrammet tee-tider mm
- Være til rådighed for spillere der evt får brug for coaching/sparring undervejs i turneringen. Holdkaptajnen prioriterer selv, ud fra sportslige hensyn, hvor fokus bedst lægges under runderne.
- Arrangere et socialt arrangement i løbet af turneringen for spillerne (aftenspisning e.l.)

Ansvarsområder efter turneringen

- Evaluering af turneringen i samråd med spillere og DFSU
- Aflevering af regnskab ifm DFSUs udgifter ifm turneringen

DFSU yder økonomisk støtte på 5.000 kr til afholdelse af holdkaptajnens udgifter såsom rejse, ophold mv.

DFSU er ansvarlig for flg:

- Udtagelse af spillere/reserver og sender oplysninger til XXX i god tid, så deadlines kan overholdes ift. indberetning til turneringsarrangør
- Spillerkontrakter/-aftaler (udformning og indhentning af underskrift/accept fra spillere)
- Spiller tøjpakke udvælgelse, økonomihåndtering (evt. sponsorer), bestilling af prøvepakke, endelig bestilling og tryk
- Mediedækning
- Evt. indfrielse af forpligtelser overfor sponsorer

Nedenstående er uddrag for EDGF retningslinjer for EM 2020

Each team must bring one <u>team captain</u> whose responsibility is to <u>attend all captains</u> <u>meetings</u>, <u>represent the country at official event ceremonies</u>, <u>and provide</u> <u>communication between the LOC and the players of the team</u>;

in case of a joint EDGC and EMDGC event one team captain can serve for a country for both events

Team captains do not pay the event fees, except limited administration fee, the green fees for requested days of practice play, eventual area access fees, and social event fees for which they have free access

Team Captains are eligible to play doubles.

Program

- four (4) days Wednesday Saturday
- two (2) days of practice with tee-times (Monday Tuesday); at least one (1) more day of open practice for players (Sunday);
- all team members need to sign the Participants Event Contract with the LOC/EDGF that specifies their rights and responsibilities during the event within the deadline imposed by EDGF;
- the contract may include insurance waivers, media and marketing rules, release of public liability of the LOC, etc.
- in addition to the PDGA dress code players in competition (singles/doubles) need to adhere with the uniform policies at the event with the right to add their sponsor info in a limited extent

(4) Nomination and Registration Schedule

- November 18, 2019 deadline for nomination of players for the individual spots by the team captains
- November 19, 2019 EDGF publishes the list of all nominated players; players
 who were not nominated and feel that they were forgotten have 7 days to contact
 their national disc golf governing bodies (through the team captain) to receive a
 last minute nomination
- November 26, 2019 EDGF publishes the final list of awarded individual spots and the waiting lists for individual spots in each division, no further nominations for individual spots will be possible after November 25.
- first half of January 2020 the opening of the event registration
- **February 18, 2020** the end of the event registration, all players with individual spots need to be registered *by the team captains* by this deadline, players with



national spots may be registered or the national spots may remain unnamed even after this deadline if your country prefer so, and if you claim them and pay them by the deadline (and in case of MP40/FP40 national spots you also need to indicate the divisions of your choice).

- March 3, 2020 all spots (individual and national) must be paid (including unnamed national spots, and eventual substitute players)
- August 1, 2020 all unnamed spots must be assigned to players

Nomination Procedure for Individual Spots

Each team captain will have an access to edit the particular sheet (name of the sheet is the name of the country) of the nomination document:

All team captains, please check whether the settings are right and you are able to edit your own country sheet. If you encounter any problems with it, please, inform us right away.

In the sheet the name of the captain(s) is listed, in case of the joint captain for the whole event, the data are the same for both EDGC and EMDGC.

Then, just for your reference the number of national spots for each country is listed. This is only provided for a reference, i.e., it does not limit in any way the number of your nominated players for individual spots.

Finally, the captains need to fill in the table Nomination for Individual Spots for their own country.

- In each row enter the First Name, Last Name, PDGA number, Country, and
 Division of each nominated player (including the current European Champion). By
 nominating a player you confirm that you have checked that the player satisfies all
 the requirements listed above, particularly nationality eligibility, approval of the
 player by the national disc golf governing body, activity of the player, etc.
- Players may be nominated in multiple divisions if they satisfy the age requirements. In that case you need to nominate the player separately in different rows, one for each division and also you need to indicate the order of preference for divisions with 1 be the highest preference, 2 being a lower preference, etc.
- For an example of the completed nomination list, see the sheet Example (Molvania), see also the proper format of the data.
- You can freely edit your nomination list until November 18, 2019, 24:00 Central European Time (UTC + 1). Then the list will be frozen and all additional last minute nominations that are a result of a forgotten players (or similar situations) will need to be submitted by email. No additional nominations will be allowed after November 25, 2019, 24:00 (UTC + 1).

If at any time later (before the start of the event) a player will receive an individual spot from the individual spot waiting list due to a cancellation of a player with the individual spot, the spot will be awarded to the player regardless whether the player received a national spot or not. That means that in case such a player is already registered for the event with a national



spot, the country will be able to award the national spot to an additional player. In that case, the event fees will need to be paid within two weeks period for the additional player.
