VISA SUPPORT BY ISRAELI EXPERTS

TO Israel-Tours DMC has been welcoming guests in Israel from all over the world since 1999.

Our company has all the 3 options of VISA SUPPORT for groups and individuals:

1) GROUPS SUBMISSIONS

E-Group Visas for our guests in groups from countries that require visas before arriving in Israel. Our company handles everything independently; tourists don't need to go to the Israeli embassy in their home countries to obtain visas, we take care of everything till the visa is granted.

- **Minimum group size for submission by our company:** 25+ Participants in the group
- **Minimum Tour cost:** approximately starting from \$750 and up.
- **50% chance that the Ministry of Internal Affairs will request a self deposit for each guest, thereby guaranteeing a visa.**
- ***Official self deposit amount the Ministry of Internal Affairs may request:** \$3,000-\$16,000. However, the minimum amount of self deposits are typically used in authorities decisions, rarely the medium deposits, and almost never the high deposits.
- **Self Deposit Refund:** After departure from Israel, the full paid deposit is refunded within 14-30 days to the agent or guest in person.

✓ **The process:** TO Israel-Tours DMC As an accredited Tour operator company by the Israeli government, we process the submission, apply for a group visa, pay all consular fees for each group member and the general group application fee. The submission is then reviewed by the Israeli Ministry of Interior for approximately 15-28 days. **Then the ministry informs us regarding their decision.**

A Possible decisions of Ministry:

- The visa is granting (meaning everyone was approved and granted a visa **without a self deposit**);
 - The visa is granting **without a self deposit**, but not for everyone (some were not approved and removed from the group list);
 - Rejection for the entire group, **with a propose to pay a self deposit**;
 - **Rejection** for the entire group without explanation or any deposit options;
- ! Since guests must be prepared to pay a self deposit, it is advisable to have members of the group who can pay **at least the minimum self deposit** if the Ministry of Internal Affairs requests a deposit, otherwise, it's better to take the next option 2 of Visa Support.

🇮🇱 Our group visa application:

- **Prepayment for the tour program is \$220**, including our submission and all the application fees, as a part of the entire tour program cost.

⚠️ If a visa is denied or the group is unable to cover the requested deposit, this amount is retained for the paid state fees, the completed group submission and our company's processing and administration of the entire process.

- **100% guarantee that refusal will never be due to our confirming documents or any issues with the host company, otherwise full refund.**
*Upon obtaining a visa, the guests / agent complete the full payment for the tour program immediately or no later than 15-90 days (groups more than 10 guests 90 days) before the arrival, for which an invoice will be issued.

2) Individuals 1-9 guests / Mini Groups 10-17 guests / Groups 18-24 guests

VISA B2 - For any number of guests who could submit by their own for a tour visa in the nearest embassy of Israel in their country of citizenship or residence (for any citizenship), we will support with all the necessary documents and official invitations (the main docs needed for each visa submission).

- **Prepayment for the tour program for:**

- ❖ **Groups - \$290**, including all the package for visa submission which is required from the Israeli host company.
- ❖ **Mini Groups - \$330**, including all the package for visa submission which is required from the Israeli host company.
- ❖ **Individuals - \$360**, including all the package for visa submission which is required from the Israeli host company.

*Upon obtaining a visa, the guests / agent complete the full payment for the tour program immediately or no later than 15-90 days (groups more than 10 guests 90 days) before the arrival, for which an invoice will be issued.

- No self deposit is required, Visa Submission in accordance with the requirements of the Israeli embassy in the applicant's country.

⚠ In case a visa is denied, this amount is retained for the paid state fees and our company's processing and administration costs.

- **100% guarantee that refusal will never be due to our confirming documents or any issues with the host company, otherwise full refund.**

3) For citizens of India and Sri-Lanka only!

E-Visa B2 - For Individuals, families or mini groups up to 10 guests (one by one) our company will fully support the online submission. [more details by the link...](#)

- **Prepayment for the tour is \$390**, including the visa application fees and all the package for visa submission which is required from the host company in Israel.

*Upon obtaining a visa, the guests / agent complete the full payment for the tour program immediately or no later than 15-90 days (groups more than 10 guests 90 days) before the arrival, for which an invoice will be issued.
