I am still trying to figure out if we can have Arisha see by Dr Delaney here. In the meantime, here is the timeline since Arisha was referred here, as was asked following my phone conversation with Edith;

Dec-11 2018: referral by Dr Rouleau to Dr Delaney.

Dec-11 2018: first physio appointment.

Dec-18 2018: consulted Dr Cermigiani at Sports Med clinic. Referred to MGH TBI clinic. Dr Delaney wanted Arisha to take Impact test (cognitive) in order to see her. She hasn't seen him yet to this date.

Jan 2019: seen at TBI clinic. Was seen by neurosurgeon for her intake. Seen by neuropsych for cognitive assessment; recommended to cognitively rest. Seen by physio who wasn't able to identify source of her dizziness.

March-19 2019: referred to student health by physio due to signs of right vertebral artery dysfunction.

March 21 2019: seen by student health MD. Referred to neurologist, and prescribed Doppler for vertebral artery.

March-26 2019: seen by neurologist. Prescribed head and neck MRI and EMG.

April 5- 2019: Student health ordered Doppler.

April-8 2019: went to ER due to difficulty speaking and "spacing out". CT scan revealed no anomaly.

Arisha can correct me if I got anything wrong up there. I realized that I had Arisha sign the consent to communicate Dr Cermigiani's exam results to Edith, but not to Dr Ptito who it would eventually end up to. I'm more comfortable if you just send him that timeline so start, and I believe this is the most relevant part in Arisha's case. Arisha also has the report from the neurologist if Dr Ptito would judge it to be pertinent and if she consents to share it.

I hope this can help; both of you can let me know if there is anything more I can do.
