ABSTRACT

Abstract should be written with the total number of 150 - 200 words (11 font size, Times New Roman, justified, single line spacing). Abstract should be written briefly and factually in English. Abstract contains the clear elaboration of research, background, purpose, methods, result and conclusion. Statistics may be shown in the abstract if any statistical results are mentioned in the research. Abstract should be written separately from the article. References should not be written in abstract. Nonstandard abbreviation should be avoided, but if it is indispensable, the full name should be specified in its initial mention. response to reading long texts has an impact on their.

1. Introduction

Introduction contains the background and problem, the state of the art of the research, and purpose of the article or research that is formulated and presented by adequate introduction and avoids research result

presentation. The body of text should be written with Times New Roman font, single line spacing and 12 font size. It can contain figures. Extended abstracts should be in a structure that explains the content of the declaration therefore the preparation phase of the said work. Page margins are formed as in this

template. End of the lines should be aligned to the right and there should be no syllable segmentation. The total length of the article should be 3000-5000 words including the references.

Current literature regarding the work subject should be examined and the differences of the said work from the past, similar works should be presented clearly in the introduction section. The style of citation is as following example:

However, availability and quality of music preferences and personality among Japanese university students was influenced by natural conditions where the students stay as reported by Brown (2012). Another study reported that the same condition is affected by the activity of students in the university (Cernicova et al., 2015; Alves & Raposo, 2016).

3. Results and Discussion

Results and discussion should be presented in the same part, clearly and briefly. Discussion part should contain the benefit of the research result, not the repeat result part. Result and discussion part can be written in the same part to avoid extensive quotation. All of the tables, images and figures should be centered. Figures and images should be numbered together (Figure 2) and figure definitions should be placed under the figure or image; as for the tables, they should also be numbered (Table 2) and the table header should be placed at the top of the chart. Table, image and figure headers should be written with uppercase initial letters, bold and should be centered. References (if any) of the tables, figures and images should be presented just under the tables, figures and

images in the form of author surname and publication date
