Papers should be original research contributions with a maximum of 25% similarity to be checked using Turnitin or other tools. Articles should be written in Bahasa, English or Arabic and consist of a maximum of 20 pages (3000-7000 words). The article in Bahasa and English are written with 11 pt Cambria, Regular, spacing 1.5. At the same time, the article in Arabic is written with 16 pt Sakkal Majalla and 1.5 spacing. The citation format must follow the APA 7th - American Psychological Association 7th Edition style. Papers must be submitted electronically via open journal systems and register in website http://journal2.uad.ac.id/index.php/insyirah/index. Please be aware that all authors are registered in open journal systems.

The introduction should contain general issue in society (why your research is important for

What is an important issue faced by society?), general problem (a general problem that motivates research in your field), literature synthesis (critically analyze advantage and disadvantage of previous research, and find research gap from previous research), research problem and research questions (details of research gaps that you found from previous research and will be answered with your research), proposed solutions and claims of novelty, and implications of the proposed solutions.

#### 3.1.1. Subsection (Sentence case)

Papers should be in pages with a font size of 11 points using Cambria type for text, title, author information, and main section headings. Papers should be formatted for A4 paper. Top, bottom, and side left and Right margins should be 3 cm. followed by details of the methods, materials, procedures, and equipment used. Findings, discussion and conclusions should follow in that order. Appendices may be employed where appropriate. The APA Publication Manual should be consulted for details as needed.



Captions should be Cambria 11-point, centered. Tables and pictures should be sequentially numbered in separate series. Captions for tables should be above the table. Captions for figures should be below the figure (Fauzi, 2017).
