#### **Leadership Team**

The Leadership Team is not a governance committee, but is the responsible authority for the operation of the Union and support of elected officers. The Leadership Team consists of: 3 Sabbatical Officers, the Chief Executive Officer, the Deputy CEO, and the Head of Business & Development.

Leadership Team meets fortnightly and has the remit of:

- 1. Oversee and coordinate the operational objectives of the Union, in line with the Union's strategy and actions of the Board of Trustees;
- 2. Review the operating policies and procedures of the Union;
- 3. Coordinate operational objectives against the Union's operating plan and against PI's and KPI's;
- 4. Receive reports on membership and engagement from MSL;
- 5. Receive reports on the Union's budget in line with the Union's financial plan and the actions of the Board of Trustees;
- 6. Receive reports from managers as to the progress of the Union against its operating plan;
- 7. Receive reports from sabbaticals as to progress against their manifestos, other objectives and campaigning plans; and
- 8. Consider the actions and resolutions of the Union Council, Annual Members' Meeting, Union on Tour and other democratic forums.
