Abstracts are written in English using Times New Roman with a font size of 10, single space, and no more than 200 words. The abstract has to contain the background statement, aims, methods, results, and conclusion of the research. The abstract should not contain any citations, references, images or equations.

Keywords: Maximum five keywords alphabetically arranged (Time New Roman, 10 pt, regular)

Writing guide: The manuscript is written in Times New Roman 11 pt, single space, A4 paper type (margin: top 2 cm, bottom 2 cm, left 2 cm and right 2 cm), justify alignment, and written in the form of a 1-column page layout. The manuscript's minimum page is 6 and a maximum of 12 pages. The minimum number of references is 20, at least 80% from the last 10 years. References are cited in American Medical Association Style ¹ (Mendeley: <http://www.zotero.org/styles/american-medical-association>). The manuscript should be written in good and correct language and include aspects of the introduction, research methods, results and discussion, and conclusions with the following writing format:

1. INTRODUCTION (12 pt, bold, capital letters)

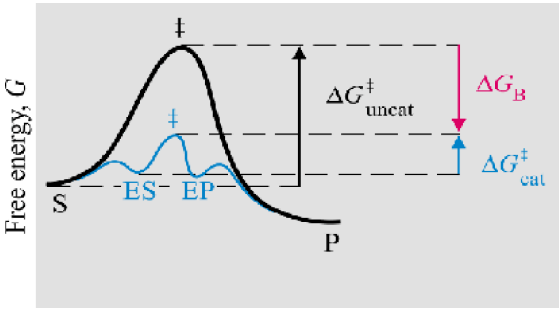

Here you get a chance to sell your data. Make the discussion following the results, but do not repeat the results. The following components should be covered in the discussion: How does the research result relate to the original question or objectives outlined in the Introduction section? Does the study provide a scientific interpretation for each of the results? Are your results consistent with what other researchers have reported (what else)?

The minimum number of references is 20, at least 80% from the last 10 years. Using the reference manager to organize references, such as Mendeley or Endnote, is highly recommended.
