### **Dan Witherell**

UC Davis Instructor

A new vision-what path will you take?

In an atmosphere of increasing polarization and hostility towards those vulnerable and needy populations eligibility professionals can provide the counterbalance to those who seek help in the journey to self-sufficiency as well as those simply seeking to improve their health and overall quality of life. As agencies and individuals, we are continually faced with choices as to which path we choose in this profession, to simply meet the technical requirements or to strive for more.

In a society where our work is often unappreciated and undervalued by many it is important to stay true to the hope, the enthusiasm and the values that not only attracted us to this profession in the first place but has provided us the fuel to keep moving forward to accomplish what we set out to do while at the same time increasing our sense of accomplishment and job satisfaction.

### CalWORKs Early Engagement and Eligibility

**Elaine Ward** currently serves as the Chief of the CalWORKs Early Engagement, Eligibility and Tribal TANF Bureau, under the Family Engagement and Empowerment Division, at the California Department of Social Services (CDSS). In this capacity she is responsible for providing state level leadership and oversight of CalWORKs Eligibility and California's Tribal TANF program. Before serving in state government, Elaine had sixteen years county government experience, having served as Sacramento County's CalWORKs, Employment Services Program Specialist and Subject Matter Expert.

Elaine was born in California, raised in the Bay Area and has lived in Sacramento for the past 30 years. She graduated with honors from California State University, Sacramento with a bachelor's degree in Psychology, has a background in early childhood education and is inspired to make a positive difference in the lives of children.

### Medi-Cal

**Sandra Williams (Sandie)** has been the Medi-Cal Eligibility Division Chief for the Department of Health Care Services since December 2015. The Medi-Cal Eligibility Division works directly with counties, CWDA, CalHEERS, Covered CA, SAWS, and a variety of stakeholders within the Medi-Cal Program. Born in Modesto, California, Sandie was hired in 1991 as a Medi-Cal Eligibility Worker with the Community Services Agency of Stanislaus County. Sandie spent many years as a Program Training Supervisor, Medi-Cal Coordinator/Manager, and Health Care Reform Project Lead. Sandie served on numerous county and state workgroups, including the County Welfare Directors Association Medical Care Committee. During her career, she developed and implemented such programs as 1931(b), Quarterly Reporting, TANF ECF Subsidized Employment, Task Based Case Management, and HCR/MAGI Medi-Cal. As the county's Health Care Reform Project Lead, Sandie served on the ACA Training Advisory Committee, and launched the county's ACA Regional Call Center. Her program experience includes: Medi-Cal, CalFresh, CalWORKs, GA, and WTW.

### CalFresh

**Kathy Yang** joined the CalFresh and Nutrition Branch at the California Department of Social Services in October 2018. As a CalFresh manager specialist, she focused on the coordination and implementation of expanding CalFresh to Supplemental Security Income/State Supplemental Payment recipients which had a huge impact on the older adult and people with disabilities population. Prior to joining the California Department of Social Services, Kathy worked for a local nonprofit organization supporting efforts aimed toward providing social services and health education through youth programming.

### Welfare to Work

**Damien Ladd** is currently the Chief of the CalWORKs Engagement Bureau within the Family Empowerment and Engagement Division at the California Department of Social Services, responsible for ongoing oversight of the CalWORKs Welfare-to-Work program. Damien has been actively involved in deliberations and negotiations that resulted in significant changes to the CalWORKs program, including the enactment of a new, comprehensive client-engagement process and the subsequent development of the On-line CalWORKs Appraisal Tool, known as OCAT. Prior to his work in

the area of welfare to work programs, Damien held several other positions both at the California Employment Development Department and the Department of Social Services, where he began work in 2006.

## **Child Care**

**Jigna Shah** is Chief of the Child Care and Intergenerational Services Bureau at the California Department of Social Services (CDSS). Jigna and her team manage the CalWORKs Stage One Child Care subsidy program, the Emergency Child Care Bridge, the CalWORKs Home Visiting Program, and other whole family approaches to addressing poverty. Jigna has worked in the field of early education policy for nearly two decades, working with city and county human service agencies, local childcare resource and referral programs, local planning departments, and other organizations working towards the well-being of children and families in California.

## **Automation**

**Raquel Givon** oversees the Automation and Client Initiatives Bureau within the Family Empowerment and Engagement Division at the California Department of Social Services. Rocky has been with CDSS for over twelve years and has been the Automation Bureau Chief for the last four years. Her current portfolio includes the EBT project, the Statewide Automated Welfare Systems (SAWS), the Statewide Verification Hub project, and MEDS Modernization. In addition to these automation projects, Rocky and her team also oversee a number of statewide stakeholder engagement efforts.

## **Housing**

**Marta Galan** is the Unit Manager of the Homeless Children and Families Unit in the CDSS Housing and Homelessness Bureau, where she is responsible for the development, implementation, and management of three prominent homelessness programs administered through local county welfare departments (CWD) across the state. In her CDSS capacity, Marta also provides support and technical assistance to state-level homelessness efforts including the Homeless Management Information System Subcommittee of the Governor's Homeless Coordinating and Financing Council. Before joining CDSS, Galan was a program analyst for homelessness programs administered by the San Francisco Human Services Agency. She earned a Master of Public Policy degree and Master of Social Welfare degree from the University of California, Berkeley and Bachelor's degree from the University of Washington.

### CalWORKs

#### **Rudy Gloria - CalWORKs Eligibility**

Rudy Gloria is a policy manager within the CalWORKs & Family Resilience Branch at the California Department of Social Services. Prior to his current position, he held eligibility and employment Services worker, supervisor and Fair Hearings appeals roles at Contra Costa County Employment & Human Services and Solano County Health & Human Services. His program experience includes CalWORKs, Welfare to Work, CalFresh, Medi-Cal, General Assistance and CMSP.

#### **Shawn Dorris - CalWORKs Eligibility**

Shawn is a CalWORKs policy manager with the California Department of Social Services. She has been with the department for 22+ years, specializing in AFDC, CalWORKs and Tribal TANF during her career. She has been the forms and Notices of Action (as well as “Turner”) expert for the Eligibility Bureau for most of her career in the department. She also has a background in acute psychiatric care, mental health behavioral treatment specializing in behavior modification and crisis intervention. Shawn currently oversees the regulatory areas for child support and mandatory inclusion as well as other areas. She was the mandatory inclusion, minor parent, non-citizen and income regulation area specialist as an analyst.

#### **Octavio Galvan – CalWORKs Overpayments**

Octavio Galvan is a Policy and Program Analyst in the CalWORKs Early Engagement & Eligibility Bureau at the California Department of Social services. He has performed analytical activities including reviewing and analyzing state and federal legislation; drafted state regulations and legislation; implemented state law changes; consulted with county partners on policy; and formulated policy changes in the CalWORKs program. Octavio received his Master’s in Public Administration with an emphasis on public policy from San Francisco State University and a BA in Criminal Justice from CSU San Bernardino.

#### **Rose O’Connor – CalWORKs Eligibility**

Rose O’Connor is a CalWORKs policy manager in the CalWORKs and Family Resilience Branch of the California Department of Social Services. She began her state career as a program analyst in the Automation, Integrity, and Client Initiative bureau where she was responsible for analyzing SAWS project deliverables and tracking policy and automation issues identified by internal and external stakeholders. She later became the program analyst overseeing the Refugee School Impact program where she worked with multiple school districts across the state. She has been with the department for over five years. Prior to joining state service, she worked as a Human Services Specialist in Sacramento County for over twelve years.

#### **Jeannie McKendry – CalWORKs Homeless Assistance**

Jeannie McKendry has been a program and policy analyst in the CDSS Housing and Homelessness Bureau for the last three years, where she works on implementing program and policy changes, evaluating program design, and providing technical assistance to the counties on the CalWORKs Homeless Assistance program (HA), the CalWORKs Housing Support Program (HSP), and the Bringing Families Home program (BFH). Jeannie serves as the primary program and policy expert for permanent and temporary HA. Prior to joining the Housing and Homelessness Bureau, Jeannie was a

policy analyst in the CDSS CalWORKs Eligibility Bureau for ten years. She has a bachelor's degree from UC Davis in Political Science and Anthropology.

### **Kathy Yang – CalFresh Eligibility**

Kathy joined the CalFresh and Nutrition Branch at the California Department of Social Services in October 2018. ## **Medi-Cal Eligibility**

### **Sandra Williams - Medi-Cal Eligibility**

Sandra (Sandie) Williams is the Medi-Cal Eligibility Division Chief for the Department of Health Care Services (DHCS). The DHCS Medi-Cal Eligibility Division works directly with counties, County Welfare Directors Association (CWDA), CalHEERS, Covered CA, Statewide Automated Welfare System (SAWS), and a variety of Stakeholders within the Medi-Cal Program.

Born in Modesto, California, Sandie was hired in 1991 as a Medi-Cal Eligibility Worker with the Community Services Agency of Stanislaus County. Sandie spent many years as a Program Training Supervisor, Medi-Cal Coordinator/Manager, and the Affordable Care Act (ACA) Health Care Reform Project Lead. During her career, she developed and implemented many social services initiatives. Her program experience includes: Medi-Cal, CalFresh, CalWORKs, General Assistance, and Welfare to Work.

### **Brooke Hennessy - Medi-Cal Eligibility**

Brooke Hennessy is the Chief of the Financial Eligibility Unit of the Policy Development Branch within the Medi-Cal Eligibility Division of the Department of Health Care Services, specializing in eligibility for Non-MAGI Medi-Cal programs. She and her team of policy analysts research and respond to inquiries from counties and other stakeholders, draft written policy guidance, analyze proposed legislation, and implement new Medi-Cal policies.

Prior to joining DHCS, she worked in the legal field in the practice areas of bankruptcy and civil litigation. Brooke holds Bachelor of Arts degrees in English and Political Science from University of California, Davis, and a Juris Doctor from University of Pacific, McGeorge School of Law.

### **Theresa Hasbrouck - Medi-Cal Eligibility**

Theresa Hasbrouck is the Section Chief for the Policy Development Branch, housed in the Medi-Cal Eligibility Division of the Department of Health Care Services. Theresa oversees a section of Medi-Cal Financial Eligibility Unit Chiefs, Health Program Specialists, and Program Analysts who implement new Medi-Cal policies enacted into law by the legislature,

draft policy guidance for counties, research and respond to Medi-Cal inquiries from stakeholders and beneficiaries, and serve as subject matter experts for functional changes to eligibility systems.

Before her transition to the Department of Health Care Services, Theresa was an Eligibility Supervisor for the Stanislaus County Community Services Agency. Theresa was instrumental in all aspects of the implementation of the Affordable Care Act in Stanislaus County. Theresa directed the development of educational materials, the drafting of policies and procedures, and collaborated with stakeholders in the community to ensure a seamless transition to coverage.

## Workshop Descriptions and Presenters Biographies

### **ABAWD and Work Registration in CalFresh Programs**

**Presenter:** Dan Witherell

**Description:** This workshop explores additional work requirements for applicants and participants who meet the definition of able-bodied adults without dependents (ABAWD).

Topics include definition of able-bodied adult without dependents, tracking the 36-month period, work requirements, distinguishing work registration requirements from work requirements

As a result of this workshop participants understand key concepts associated with work registration and work requirements and can apply those concepts to specific cases.

**Daniel Witherell** is an instructor and consultant with the Center for Human Services, UC Davis. Daniel has 35 years of experience in the training and administration of the CalWORKs, CalFresh, and Medi-Cal programs. ### **SNAP Farmers Market Initiative: Increasing CalFresh and Market Match Sales**



**Presenters:** Amy DeLisio & Stephanie Carillo

**Description:** The State Nutrition Action Council (SNAC) implemented the Farmers Market Initiative (FMI) to address barriers to shopping at farmers markets reported by low income shoppers which includes lack of awareness, affordability, and not feeling welcomed. Highlights of FMI include community outreach resources and techniques, on-site market supports, key partnerships, and methods for evaluating program impact. Markets with an onsite food navigator experienced a 402% increase in CalFresh redemption in July 2019 compared to 2018 and an average monthly increase of 31 new customers compared to an average monthly increase of 2 new customers at other market locations with promotion only.

**Amy DeLisio** MPH, RD is the director at the Center for Wellness and Nutrition (CWN) and has fifteen years of experience working on nutrition education, social marketing, and chronic disease prevention interventions serving vulnerable populations. DeLisio has extensive experience with capacity building efforts, multi-level interventions, partnership development, and coalition building around common goals. She is passionate about implementing community driven approaches that increase food justice. Prior to joining CWN, DeLisio implemented new clinic policies and procedure to improve diabetes care for patients, developed a statewide Breastfeeding Campaign for the California WIC program, and provided statewide technical support to SNAP-Ed grantees.

**Stephanie Carillo**, MAS, RD, is Program Manager of healthy food access and worksite wellness initiatives at the Public Health Institute's Center for Wellness and Nutrition. Stephanie promotes health and nutrition for under-served communities through health initiatives that focus on increasing food access and physical activity opportunities through healthy retail and worksite wellness interventions funded by SNAP-Ed, Centers for Disease Control and Prevention and a private Growers Association.

Stephanie has been promoting health and nutrition for under-served communities since 2001. Her dedication to serving the community includes a focus on the early years from infancy to age five. Formally, a county WIC Director, she provided nutrition programs, health services, and breastfeeding support and built the capacity of community health workers through training programs and advised on the development of a department-wide wellness program. As a certified lactation educator, Stephanie is passionate about proper nutrition early on in a child's life. Her eight years with the WIC program were dedicated to providing families with education on good nutrition, increased access to healthy food, and connection to community resources.

Stephanie is a registered dietitian from Stony Brook University in New York and a certified lactation educator. She holds a Master's of Advanced Study in Maternal and Child Nutrition from University of California at Davis.

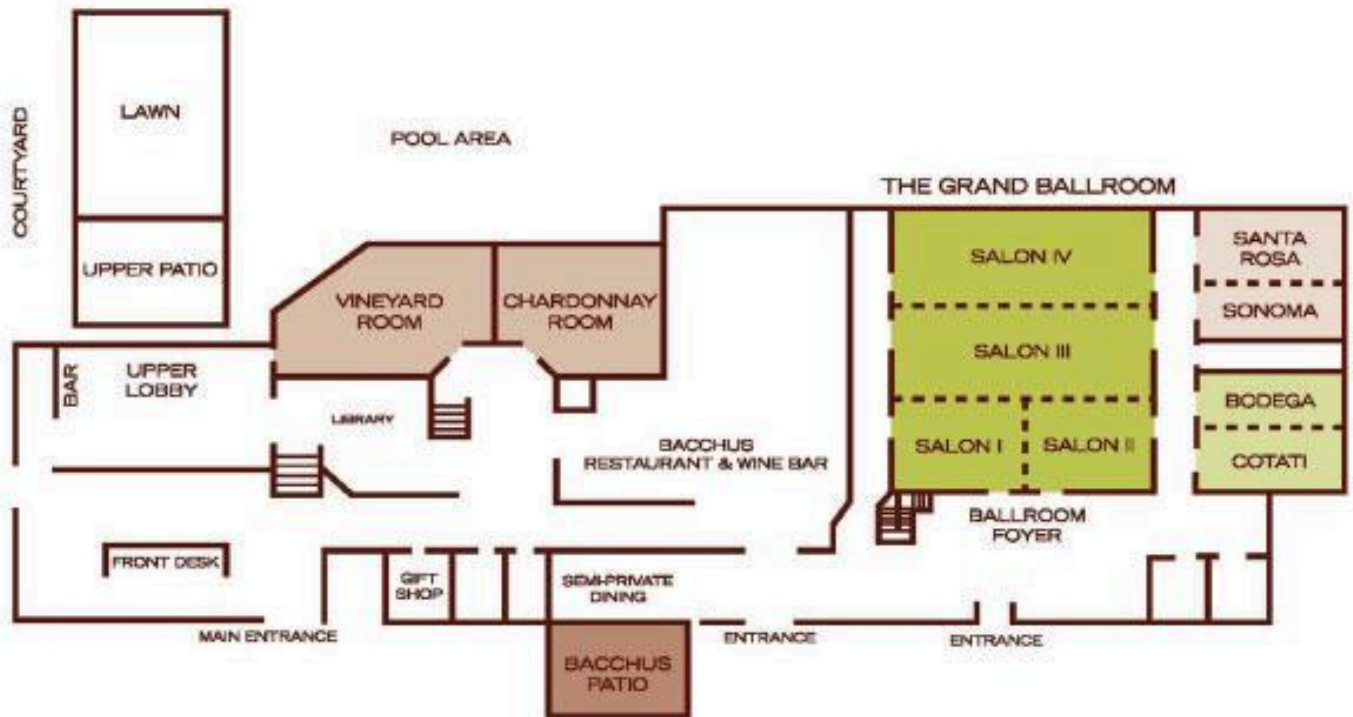

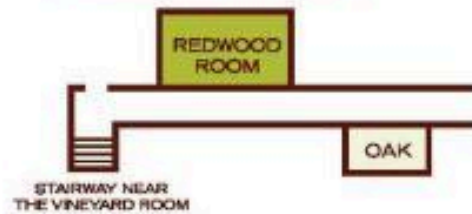
