**Chain of Communication/How to Effectively Communicate with School Officials  
Regarding Harassment, Intimidation, and Bullying (HIB)**

Parents are often discouraged or frustrated when they attempt to communicate with central office administrators and are sent back to building-based officials in order to resolve a problem their child may be experiencing in school. To prevent that frustration, parents can become informed about the “**Chain of Communication**,” or where to begin the communication sequences regarding an HIB.
