ON THE QUESTION: Mayor Hogan noted that the contract (#1-05) to demolish properties at three sites in the City will need to be re-bid because there were discrepancies in the first bid, on Jan. 20, 2005, in the way contractors proposed to do the work. Public Works Superintendent Oakes said the City will pay for the asbestos survey of the properties, and that he expects the report soon.

• Assistant Public Works Superintendent Cornish and City Planner Reynolds gave a report on plans for the City's new Yard Waste Composting Facility. Assistant Superintendent Cornish said he first investigated how similar facilities were run in Geneva, Canandaigua and Corning, and suggested the City charge non-residents wishing to drop off brush at rates similar to Steuben County charges at its transfer station. Compost material will be free for City residents, while non-residents will be charged. A punch ticket could be sold at the City Clerk's office and other locations for non-residents to use when dropping or brush or buying compost. Plans now call for facility hours to be 7 a.m.-5 p.m. Thursday through Sunday, with the yard to be staffed by a full-time employee who will check residencies. Commissioner Fucci asked to have another report on the facility before plans are finalized.
