Parking is a privilege. Students may be denied parking for: outstanding debts, discipline issues, attendance issues, excessive tardies, and/or parking violations from the previous school year. If eligible for parking privileges, students must agree to follow all parking rules and regulations (listed below), pay the required permit fee, submit a completed application, and present a valid driver's license and current vehicle registration.

The following policies apply to all students who are approved for parking:

- Seniors and juniors may purchase a parking permit for **\$45.00**. Permits will be available to students who meet all of the criteria above. Parking privileges can be denied or revoked for parking infractions.
- Parking spaces will be assigned to seniors who meet the requirements first and then to juniors. Parking may not be available for all students requesting parking privileges.
- Students must park in their assigned parking spots. Parking in areas other than the assigned area may result in the loss of parking privileges and/or disciplinary action.
- AMHS permit decal stickers must be appropriately displayed on the **driver's side rear window and front windshield**.
- Parking permits **may not be exchanged, sold or copied**. Permits may only be utilized by the person to whom they were issued. The parking permit is void when the student transfers or graduates.
- Students are to exit from vehicles immediately upon arrival on campus and are prohibited from loitering in parking lots before or after school.
- Students must be **escorted by an administrator** or an administrator's designee to go to a parking lot or their vehicle during school hours. Students in the parking lot without admin escort are out-of-area and are subject to disciplinary action.
- **Seatbelt use and speed limit** are required and expected. Reckless or careless driving is prohibited. Students are expected to drive with care in and around campus. Non-compliance will result in disciplinary action.
- CCSD and AMHS/SOA can request NCPD to conduct **routine searches** of student vehicles parked on school property at any time. Failure to provide access to the interior of the vehicle will result in disciplinary action and possible legal consequences. Student drivers and vehicle owners are responsible/liable to anything left or found in their vehicle. Vehicles are to be **locked and secured** at all times while on campus.
- The **campus and parking lots are locked** and inaccessible from **8:00 pm until 6:00 am** each day and during weekends with some exceptions of athletic events and weekends with school performance events.

Your signature below acknowledges that you understand that being permitted to park on school premises is a matter of privilege, not a right, and failure to meet the regulations above will subject you to losing parking privileges, forfeiture of parking fees and disciplinary action as determined by the administration.
