At **Find My Auto Parts Pty Ltd** also known as **ifndautoparts** we respect and value your privacy and take the protection of your personal information very seriously and we only collect personal data in accordance with data protection laws as set out in this policy.

This Privacy Policy describes how **Find My Auto Parts Pty Ltd** (the "**Site**", "**we**", "**us**", or "**our**") collects, uses, and discloses your personal information when you visit, use our Services, or make a purchase from **Find My Auto Parts Pty Ltd** (the "**Site**") or otherwise communicate with us (collectively, the "**Services**"). For purposes of this Privacy Policy, "**you**" and "**your**" means you as the user of the Services, whether you are a customer, website visitor, or another individual whose information we have collected pursuant to this Privacy Policy.

This Privacy Policy applies only to your use of this Site and if you follow any links to other websites, your data will be used in accordance with the privacy policies of such third-party sites.

The type of personal information we collect

We currently collect and process the following information:

Approximate location, physical user or device location within an area greater than or equal to 3 square kilometres

Sensitive personal information

We do not process sensitive information.

Children's data

We do not knowingly solicit data from or market to children under 18 years of age. By using our website, you represent that you are at least 18 years of age or that you are the parent or guardian of such a minor and consent to such minor dependent's use of our website. If we learn that personal information from users less than 18 years of age has been collected, we will deactivate the account and take reasonable measures to promptly delete such data from our records. How we get the personal information and why we have it

Most of the personal information we process is provided to us directly by you for one of the following reasons:

Marketing and advertising

We use your personal information for marketing and promotional purposes, such as to send marketing, advertising and promotional communications by email, text message or postal mail, and to show you advertisements for products or Services. What legal basis do we rely on to process your information

We only process your personal information when we believe it is necessary and we have a valid legal reason (i.e. legal basis) to do so under applicable law. This may be with your consent to comply with laws, to provide you with Services, to enter into or fulfil our contractual obligations, to protect your rights or to fulfil our legitimate business interests.

The General Data Protection Regulation (GDPR) and UK GDPR require us to explain the valid legal bases we rely on in order to process your personal information. As such, we may rely on the following legal bases to process your personal information:

- Legitimate business interests. We may use your personal information for our legitimate business interests, such as letting you know about our products and Services.
- Consent. We may process your information if you have given us permission
 (i.e. consent) to use your personal information for a specific purpose. You can
 withdraw your consent at any time by contacting us at hello@ifnd.com.
- Legal Obligations. We may process your information where we believe it is necessary for compliance with our legal obligations, such as to cooperate with a law enforcement body or regulatory agency, exercise or defend our legal rights, or disclose your information as evidence in litigation in which we are involved.

How we store your personal information

Your information is securely stored by our third-party provider. AWS instances which are located in North Virginia, USA. We have contracts in place with this provider which require them to store and use data in compliance with all applicable laws. We may sometimes transfer your information to countries which do not offer the same standard of data protection as available under English law. However, we put all necessary measures in place to ensure that your data is protected to an adequate level in such countries.

Retention and Deletion of personal information

We will keep your personal information for the length of time necessary to fulfil the purposes for which we collected it. We may keep your personal information for longer than this to comply with other legal requirements. We will only keep your customer profile information for three years and/or as long as you remain an active customer (whichever is the longer, as set out further in the table below), or otherwise as required for our business operations or by applicable laws. Recordings of inbound calls to Customer Service are retained for 6 months unless it is reasonable or legally required in the circumstances to hold such recording(s) for a longer period (for

example, due to a potential dispute, complaint or ongoing customer service enquiry).

We may need to retain certain personal information even once a customer account or profile has been closed or deleted to enforce our terms, to comply with legal or regulatory obligations, for fraud prevention, to identify, issue or resolve legal claims and/or for proper record keeping purposes. We may also retain a record of any stated objection by you to receiving Find my Auto Parts Pty Ltd updates for the purpose of ensuring that we can continue to respect your wishes and not contact you further. When the applicable retention period has been reached and/or Find my Auto Parts Pty Ltd no longer requires your personal information for any of the purposes stated above, your personal information will be deleted or destroyed in a manner that cannot be restored or reproduced.

Type of record/personal information	Retention period
Personal information for individuals (or 'prospects') who have signed up to marketing	3 years from sign-up. This period will be extended: (i) by a further 3 years if you subsequently make a purchase online or if you interact with Customer Service; and/or (ii) by a further 18 months if you interact with any of Find my Auto Parts Pty Ltd digital content, for example, if you click on marketing emails or interact with Find my Auto Parts Pty Ltd digital content on the Site.
Customer account/profile data	3 years from the creation of the account/profile. This period will be extended: (i) by a further 3 years if you subsequently make a purchase online or if you interact with Customer Service; and/or (ii) by a further 18 months if you interact with any of Find my Auto Parts Pty Ltd digital content, for example, if you click on marketing emails or interact with Find my Auto Parts Pty Ltd digital content on the Site.

Your data protection rights

Under data protection law, you have rights including:

Your right of access - You have the right to ask us for copies of your personal information.

Your right to rectification - You have the right to ask us to rectify personal information you think is inaccurate in cases where we process your data for a legal obligation.

Your right to erasure - You have the right to ask us to erase your personal information in certain circumstances.

Your right to restriction of processing - You have the right to ask us to restrict the processing of your personal information in certain circumstances.

Your right to object to processing - You have the the right to object to the processing of your personal information in cases where we process your data with your consent, for the purposes of performance of a contract or to comply with a legal obligation.

Cookies

Our Site may place and access certain first-party Cookies on your computer or device. First-party Cookies are those placed directly by us and are used only by us.
