# **Open Opportunities**

Title: Funding to Strengthen School Food Supply Chain

Amount: \$1.5 billion

Source: Commodity Credit Corporation funds

**Description:** The Biden-Harris administration is providing up to \$1.5 billion to states and school districts to help school meal program operators deal with the challenges of supply chain disruptions brought on by the pandemic. With funding made available through USDA's Commodity Credit Corporation, USDA will provide:

- Supply Chain Assistance Funds: \$1 billion for schools to purchase food for their meal programs
- USDA Foods: \$300 million for states to purchase foods to be distributed to schools
- Local Food for Schools Cooperative Agreement Program: \$200 million will be used for cooperative agreements to purchase local foods for schools with a focus on buying from historically underserved producers.

A state-by-state breakdown of funds can be found in this table.

## **Actions for NFSN Partners:**

- Keep an eye out for a forthcoming Request for Applications from USDA for the Local Food for Schools Cooperative Agreement Program.
- Advocate with your state authority that conducts school food purchasing as they
  formulate their application to use their portion of the \$200 million in local purchasing
  funds.
- Be in touch with any local School Food Authorities to offer support in identifying new vendors or diversify supply networks with the Supply Chain Assistance Funds.

## Title: Local Food Purchase Assistance Cooperative Agreement Program (LFPA)

Amount: \$400m

**Source:** American Rescue Plan Act funds

**Description:** The purpose of this program is to maintain and improve food and agricultural supply chain resiliency and program will award up to \$400 million through non-competitive cooperative agreements with state and tribal governments to support local, regional, and socially disadvantaged farmers and ranchers through the purchase of domestic local foods. Local and regional farmers and ranchers are those within the state or 400 miles of delivery destination. The cooperative agreements will allow for state and tribal governments to procure and distribute local and regional foods and beverages that are healthy, nutritious and unique to their geographic area. The food will meet the needs of the population, and serve feeding programs, including food banks, schools and organizations that reach underserved communities. In addition to increasing local food consumption, funds will help build and expand economic opportunity for local and socially disadvantaged producers.

Deadline: May 6, 2022 (extended from April 5)

**Actions for NFSN partners**: Be in touch with your state department of agriculture or Tribal government food and agriculture authorities to inform their application. This is the time for government agencies to hear from providers and local producers about how they should structure their proposal – what specifically will make this funding most beneficial?

**Title:** Food Supply Chain Guaranteed Loan Program **Amount:** \$100m to facilitate \$100b in loan guarantees

Source: American Rescue Plan Act funds

**Description:** This program guarantees loans of up to \$40 million for qualified lenders to finance food systems projects, specifically for the start-up or expansion of activities in the *middle* of the food supply chain. The program will support new investments in infrastructure for food aggregation, processing, manufacturing, storage, transportation, wholesaling, and distribution.

**Deadline:** Rolling

Title: Farm and Food Worker Relief Grant Program

Amount: \$665 million

**Source:** Annual spending and COVID relief

**Description:** The Farm and Food Worker Relief Grant Program provides approximately \$665 million in Consolidated Appropriations Act funds to provide grants to State agencies, Tribal

entities, and nonprofit organizations with experience in providing support or relief services to farmworkers or meatpacking workers. Awards will generally range from \$5,000,000 to \$50,000,000.

Deadline: February 8, 2022

**Title:** ReConnect Program **Amount:** \$1.15 billion

Source: Rural Development funding

**Description:** This funding is available for projects that serve rural areas where at least 90 percent of the households lack broadband service at speeds of 100 megabits per second (Mbps) (download) and 20 Mbps (upload). USDA will give funding priority to projects that will serve people in low-density rural areas and areas lacking internet access services at speeds of at least 25 Mbps (download) and 3 Mbps (upload).

Applicants must commit to building facilities capable of providing broadband service at speeds of 100 Mbps (download and upload) to every location in a proposed service area at the same time. In making funding decisions, USDA will also consider the economic needs of the community to be served; the extent to which a provider will offer affordable service options; a project's commitment to strong labor standards; and whether a project is serving Tribal lands or is submitted by a local government, Tribal government, non-profit or cooperative.

Title: Technical Assistance Partnerships for Underserved Producers

Amount: \$75m

Source: American Rescue Plan Act funds

**Description:** USDA will provide approximately \$75 million in American Rescue Plan funding to 20 organizations to provide technical assistance to connect underserved producers with USDA programs and services. Organizations were selected for their proven track records working with underserved producer communities, such as veterans, beginning farmers, limited resource producers, and producers living in high-poverty areas. These organizations will work with underserved producer communities on business and tax planning, financial assistance planning, market planning, farmer advocacy, and business curriculum development.

Title: Meat and Poultry Inspection Readiness Grant Program

Farm to Food Bank Grants support the harvesting, processing, packaging or transportation of food donated by agricultural producers, processors, or distributors for use by emergency feeding organizations, like food banks.

Title: Federal Micro-purchase Threshold

**Description:** A Food and Nutrition Service memo dated November 17, 2021, clarifies for child nutrition program regional directors and state agencies that the federal micro-purchase threshold is \$50,000; it also updates the requirement to recommend equitable distribution of micro-purchases (awarding micro-purchases to a wide variety of people) rather than requiring it.

Title: Tribal Homelands Initiative

Amount: N/A Source: N/A

**Description:** U.S. Departments of Agriculture and the Department Interior have created the Tribal Homelands Initiative. This collaborative effort will improve federal stewardship of public lands, waters, and wildlife by strengthening the role of tribal communities in federal land management. Through a joint Secretarial Order (PDF, 270 KB), the two Departments codified a policy to facilitate agreements with tribes to collaborate in the co-stewardship of federal lands and waters.

The Departments also committed to ensuring that all decisions relating to federal stewardship of lands, waters, and wildlife include consideration of how to safeguard the treaty, spiritual, subsistence, and cultural interests of any Indian Tribes. The Order additionally directs the Departments to ensure that tribal governments play an integral role in decision-making related to the management of federal lands and waters through consultation, capacity-building, and other means consistent with applicable authority.
