Jackbox Games Holiday Video Contest Rules

- 1. **Eligibility:** No purchase necessary to enter or win the giveaway. The Jackbox Games Holiday Video Contest promotion is open to legal residents of the 50 United States and the District of Columbia, who are at least eighteen (18) years of age as of November 1, 2023, except employees of Jackbox Games ("Sponsor") and its affiliates, partners, and advertising and promotion agencies, and anyone involved in the development or execution of this Contest (collectively the foregoing entities are the "Contest Entities"), and the immediate families or household members of each. Each participant ("Entrant") may enter only one (1) time during the Promotion Period (this means once overall, not once on Instagram and once on TikTok); Entrants who submit multiple entries will be disqualified.
- 3. **Prize:** Two (2) Grand Prizes: The Grand Prize winners will each be awarded one (1) Steam code for The Jackbox Party Pack 10 and one (1) \$100 gift card for Doordash. Prize is non-transferable and no substitution by winners or cash equivalent is allowed. Sponsor reserves the right to substitute prize for one of equal or greater value if the advertised prize becomes unavailable. Winner is solely responsible for the payment of all federal, state and local taxes and all other expenses or costs relating to the prize not expressly set forth above.
- 4. **Selection of Winners:** Grand Prize winners will be selected from all eligible entries. The two qualifying entries with the highest numbers of likes at the end of the Promotion Period will be selected as contest winners; provided that in the event multiple entries have the same number of likes (the "Tie Entries"), the winner(s) will be selected by random drawing amongst the Tie Entries. Likes must be organic, provided by real individuals (not bots or other deceptive means as adjudged by Jackbox Games in its sole discretion) and cannot be paid for, traded for, or otherwise obtained by any request other than through the post itself. Potential winners must respond to the initial notification within 48 hours after delivery. release) within an additional five-day period. Failure to comply with any requirements on a timely basis may result in disqualification and award of prize to an alternate winner.
