

Intro

RoxSerpent is the co-creator of Flavor Frenzy and Dandy's world, a former contributor to Tower Heroes and a former contributor to Databrawl. He's gone by other aliases such as Homestuck_Jake413, Jakers, TravelingMoonRock and ChillFaceless.

This document is a more comprehensive recompilation of our original document, which can be viewed [here](#) and is something I recommend you read. This document also serves to make people aware of Rox and to compile what he had done, things he directly admitted to yet people in his community either forgave him for or brushed off as "petty drama taken too far". **(All links in the document are being updated to reuploads as Rox privated all of his videos)**

CW: Grooming, CP, sexual convos toward and involving minors

Please do not attack anyone mentioned here, that is not the purpose of the document and doing such solves nothing.

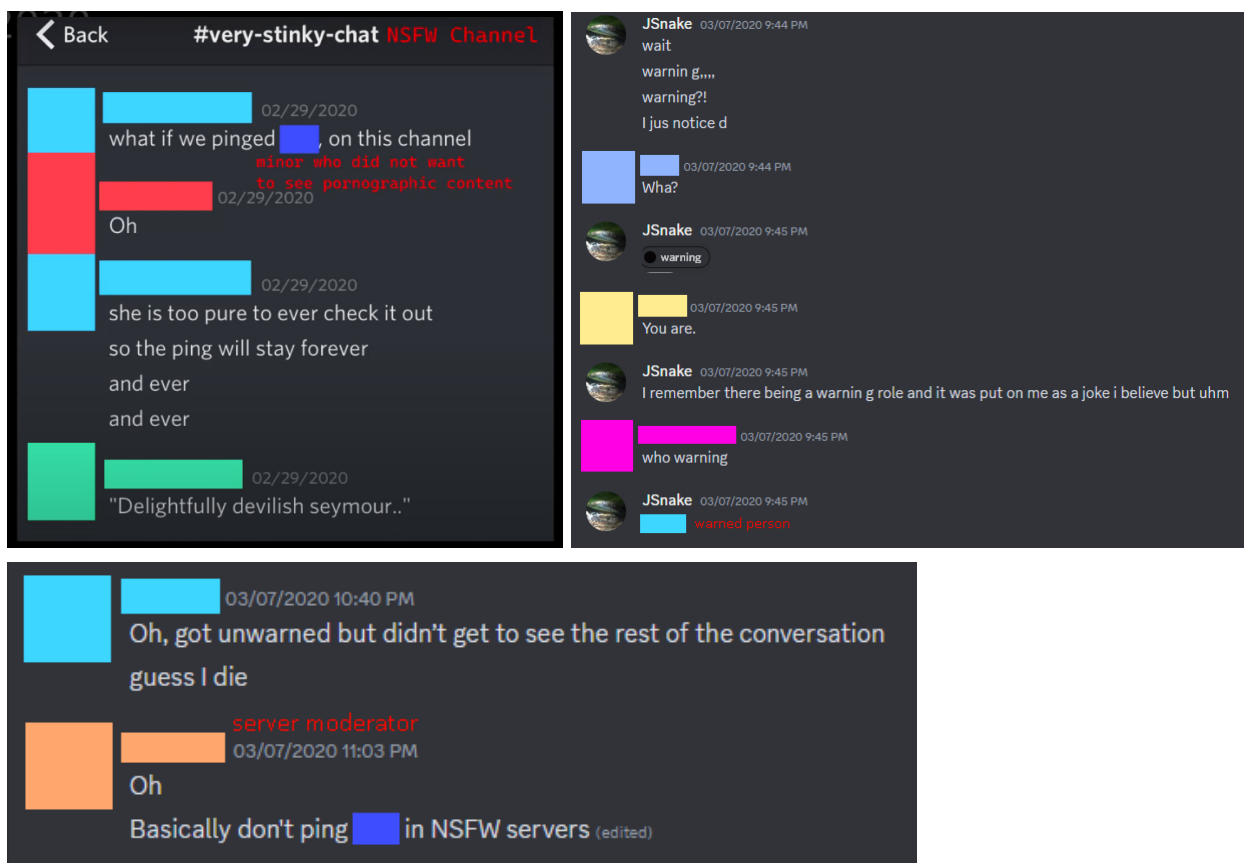
Chapter 1: Lies

[Our Involvement](#)

Sometime ago Rox had approached one of us to apologize. Its timing coming from out of the blue and days after they joined BP (censored for anonymity) made us think it was more so them being worried things may come out about them or that we may get them banned from BP instead of it being genuine. This feeling was exacerbated after their video, where they claim they've been "[trying their best to apologize to those involved](#)" when to us that's clearly not the case. At the time we didn't do anything, but once we found out fully what he had done we brought it up to a moderator, and it turns out a moderator in that community was his friend and leaked everything to him. This is what prompted Rox to create his response video.

What caused us to create the document originally was his lies about our friend group, smearing us to try and justify his actions, taking some blame off him and shifting it to us ([linked here](#)).

Something Rox completely neglected to mention is that the minor obviously did not have access to any NSFW channels, not only was the person that suggested the ping warned, but Rox was the one who asked why they got the warning. Rox would've known why they were warned, but instead stripped it of context and somehow had this screenshot ready to use in his defense.

Chapter 2: Deceit

The First Video

Rox's video is riddled with lies, tip-toeing around using specific words/phrases and cherry picking what was given to them, all to make the situations seem less severe than they really are. This section will dissect the discrepancies in both videos in order.

"Accusations that have been making the rounds in a lot of servers and media I'm in"

The video was in response to Rox's sexual interactions with a 13 year old being brought to a single server, which had a moderator they were friends with in it. This is the only community that it was brought to and it was kept private, this video was just to already have control of the narrative if the evidence *did* ever go public.

“At the time me and Tom were in a lot of friend groups in that community, a lot of which included NSFW channels”

This was addressed in **Chapter 1** of the document, but this is also his only example of any NSFW channels in any of the servers. Rox only brought this up to redirect blame off himself to avoid taking full accountability of his actions. He also states “Since my friends were doing it, it’s okay for me to do it” which is weird when he’s describing how he got a 15 year old to send him nudes, no one but him did that.

“Some of the things Buddy said were blown way out of proportion”

No, they weren’t. Though that’d be a bit hard to tell since Rox only shared the bare minimum to make his point and not anything he himself said or any other statements from Buddy. Something I only just realized is I’m pretty sure Rox came up with the nickname “Buddy” from this screenshot that he left out in his video, likely because what Buddy describes here and in another screenshot IS the definition of grooming.

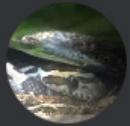

This is a blatant lie, of course you wouldn’t know that because Rox didn’t show or mention what he said, but thankfully we can. **Do keep in mind while reading this that these messages were sent to Buddy (13 years old), were about Paige (15 years old) and Rox was 17 at the time.**



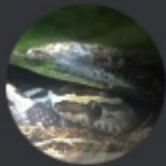

“I left the Databrawl community both out of guilt of what happened and because I stopped enjoying being the community”

This is a lie. Rox didn't leave Databrawl out of guilt, he left because of something he left out of his video, the actual catalyst he seemed to conveniently not mention.

Before Rox was in a relationship with Tom, there was someone else we'll call **Anon**. Rox had feelings for Anon, but Anon did not feel the same way about Rox. Sometime later Anon began dating another person, which Rox took great offense to. Rox took this opportunity to vilify and treat Anon like shit while victimizing himself.



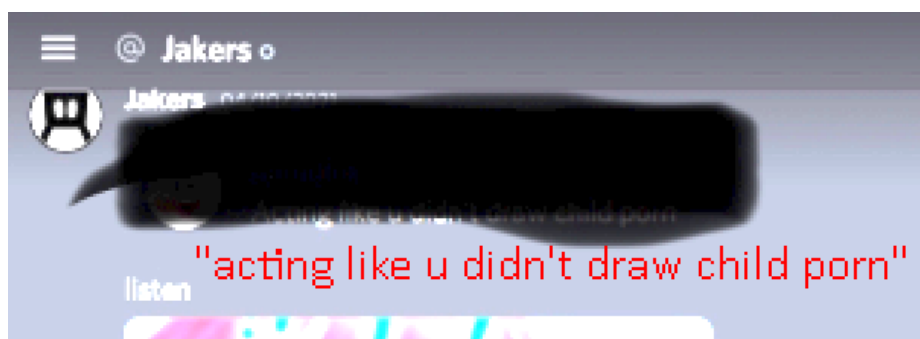
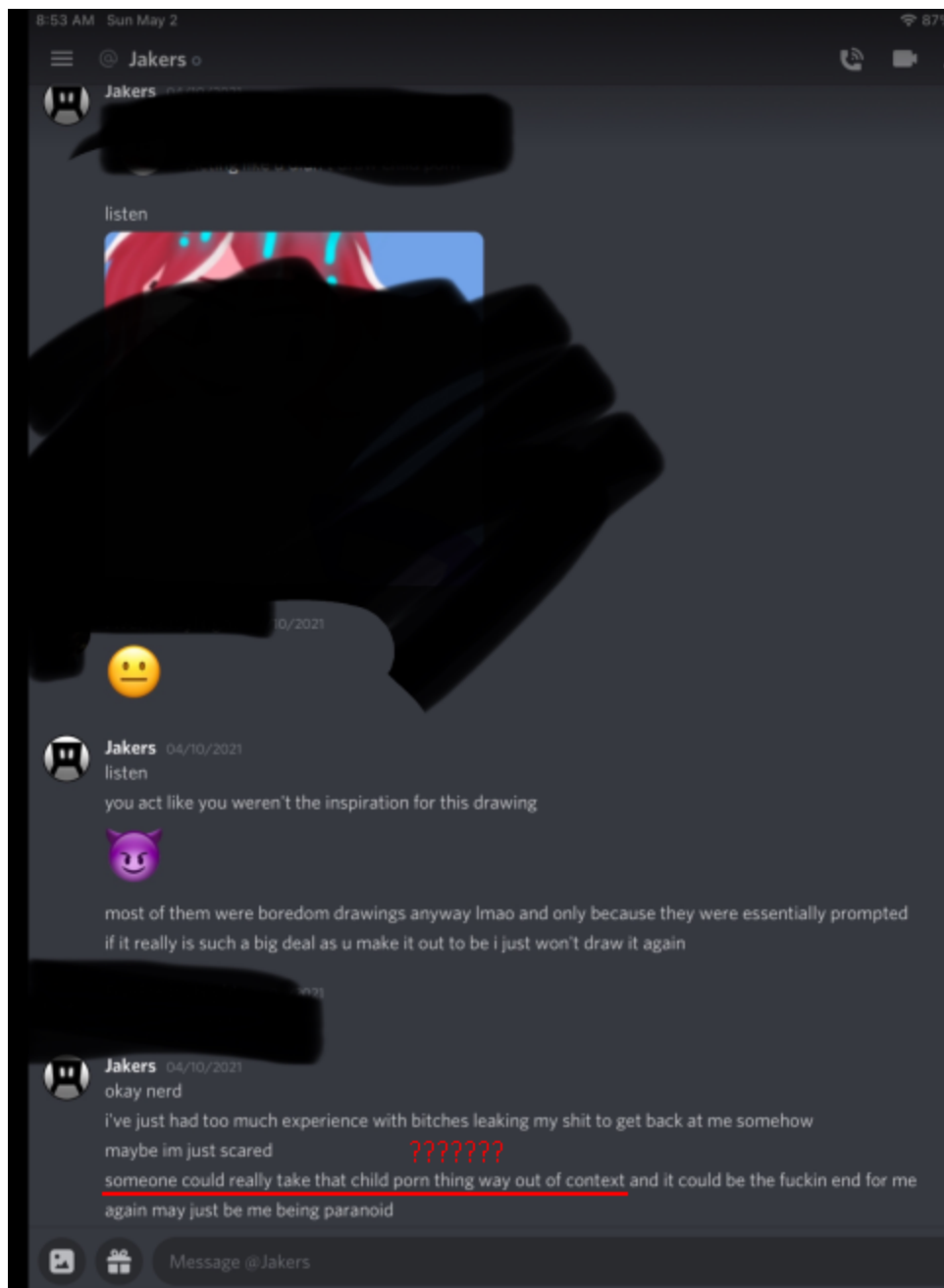


This info being brought up in our friend group was the catalyst for the other friend group Rox was in to share the myriad of garbage he had put them through, including what happened to Tom and treating a ton of their friends like shit (private stuff, just know Rox treated a handful of people not mentioned here horribly).

When Rox was confronted about this he left Databrawl. It was not out of “guilt of what happened”, but rather the guilt of being caught. Rox did try coming back sometime later, but left after realizing nobody there trusted him anymore.

[Rox Drawing CP](#)

This isn't something we can really speak that much on as it involves a friend group we are not affiliated with in any way, but Rox didn't share the screenshot showing him admitting to drawing CP, thankfully we can. It's odd Rox feigns ignorance to where any accusation of pedophilia comes from, when the screenshot was shared to his friend and likely to Rox as well since he addressed it in his video. (They like to mention Rox was 17 when everything happened, but completely ignore that Rox was 18 for some of the CP and 4 days from 18 in the image below)



“Ever since early of last year I’ve been trying my best to reach out to those involved”

No he hasn’t. Rox’s 2 apologizes were 4 months apart and as mentioned in Chapter 1, Rox’s apology to us only came when he joined the BP Community.

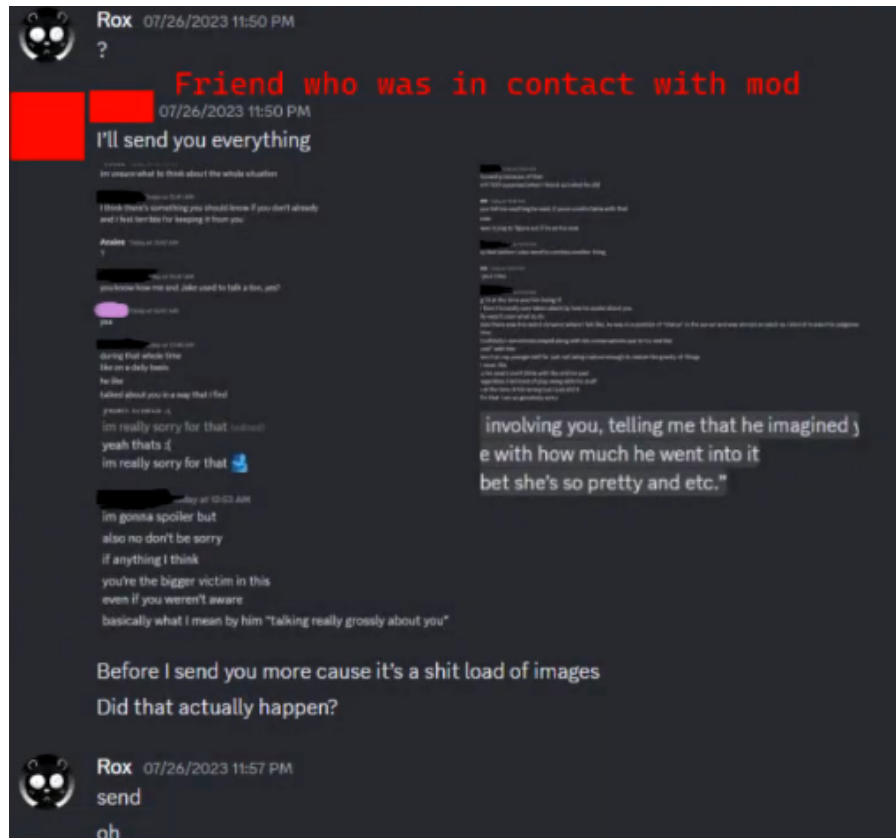
The Response Video

After the first document was made, Rox created a response video that too is filled with lies. Unlike his first video, Rox didn’t and still hasn’t to this day shared the response video to his community, probably because it would expose them to a narrative he has no control over (You can tell he never shared it from the big gap in views between both videos). Similar to the previous section, this will also dissect the discrepancies in order.

“Everything I received was shown in the video”

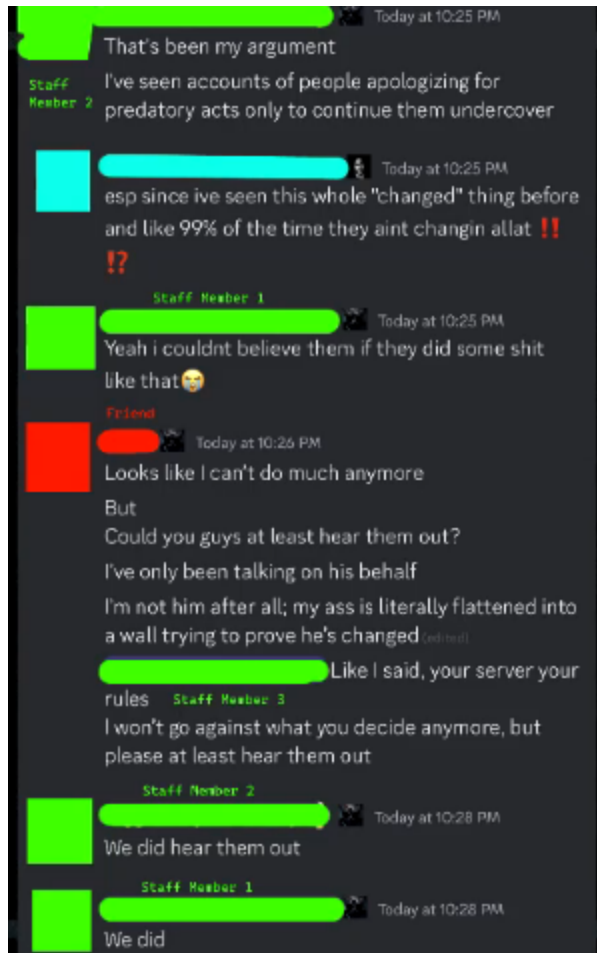
This is a blatant lie. Rox’s original response only shared 2 screenshots between Paige and Buddy, while you can clearly see several more that weren’t ever shown. Another reason this likely isn’t true is because of Rox’s nickname for the 13 year old being “Buddy”. As mentioned in Chapter 2, it likely came from another screenshot from here that was *never* present in the original video. [You can see the only 2 images shown here](#)

Another damning thing about Rox’s statement here is that if he really wasn’t shown all the screenshots, that means when he said “that couldn’t be further from the truth” when talking about Buddy and accusing them of lying, saying it “wasn’t that severe”, Rox literally did not know what he was talking about. Rox blindly twisted the truth to make himself seem better and didn’t have the evidence to back his side. Either he lied knowingly, or didn’t care enough to simply ask their friend for the screenshots before making his video.



“The moderators shadow-banned me from the server and said they ‘did hear me out’ when that’s just not true.”

This claim is extremely dumb, because Rox debunked it himself immediately after saying it. The moderators DID hear them out, as he said he was “telephoning through his friend” about the situation and you can clearly see Rox’s friend speaking for him in the screenshot he provided. Yes, they did not talk to him directly, but saying they didn’t “hear him out” is a blatant lie.



“The moderators said I couldn’t change”

They never said that, you can see in the screenshot that’s not true. The moderators said given what you’ve done they cannot trust you’ve changed, that even if you did they don’t want to risk it and keep you in their community.

“At the end of the document, the people that created it claimed I have not changed from the events of the situation.”

The document never once says Rox didn’t change. What he’s likely referencing is a line in the document that’s directly quoting him in his first video ([here](#)) talking about his transition from Databrawl and Tower Heroes.

The intention of that line in the original document was to outline conflicting statements he made, where he talked about how he left feeling guilt while also explaining he literally didn’t change when hopping communities. As mentioned before he did not leave Databrawl out of guilt and him saying he hadn’t changed only serves to justify his actions later on. It feels like he only brought this up so he can go on a tangent about how much he’s changed.

Chapter 3: The Truth

Now that all that is out of the way, Here is a rewrite of the timeline Rox presented in his first video with what **actually happened**, in the order it happened and include info that was left out or just flat out wrong.

- MM/DD/YYYY

2019

- 2/20/2019: Rox joins Databrawl

2020

- 1/??/2020 - 2/??/2020: Rox created the Box Battle/DB+ server
- 2/02/2020: Rox becomes a Contributor
- 3/??/2020: Anon began dating someone else and Rox would constantly vilify and treat Anon like shit
- 4/05/2020: Rox becomes a Moderator
- 5/14/2020 - 5/28/2020 (?): Rox would interact sexually with Buddy (13 years old), mostly about Paige (15 years old)
- 8/??/2020: Rox and Tom get in a relationship
- 9/16/2020: Rox and Tom get into a Video Call and Rox gets Tom to send them nudes
- 9/29/2020: (less than 2 weeks later): Rox dumps Tom for Paige
- 9/30/2020: Rox would be confronted with what they did to Tom and Anon and leaves Databrawl
- 10/06/2020: Rox completely purges the DB+ server (?)
- 10/10/2020: Rox rejoins Databrawl
- 11/30/2020: Rox joins the Tower Heroes community, and later calls both of his previous friend groups "toxic" despite his behavior

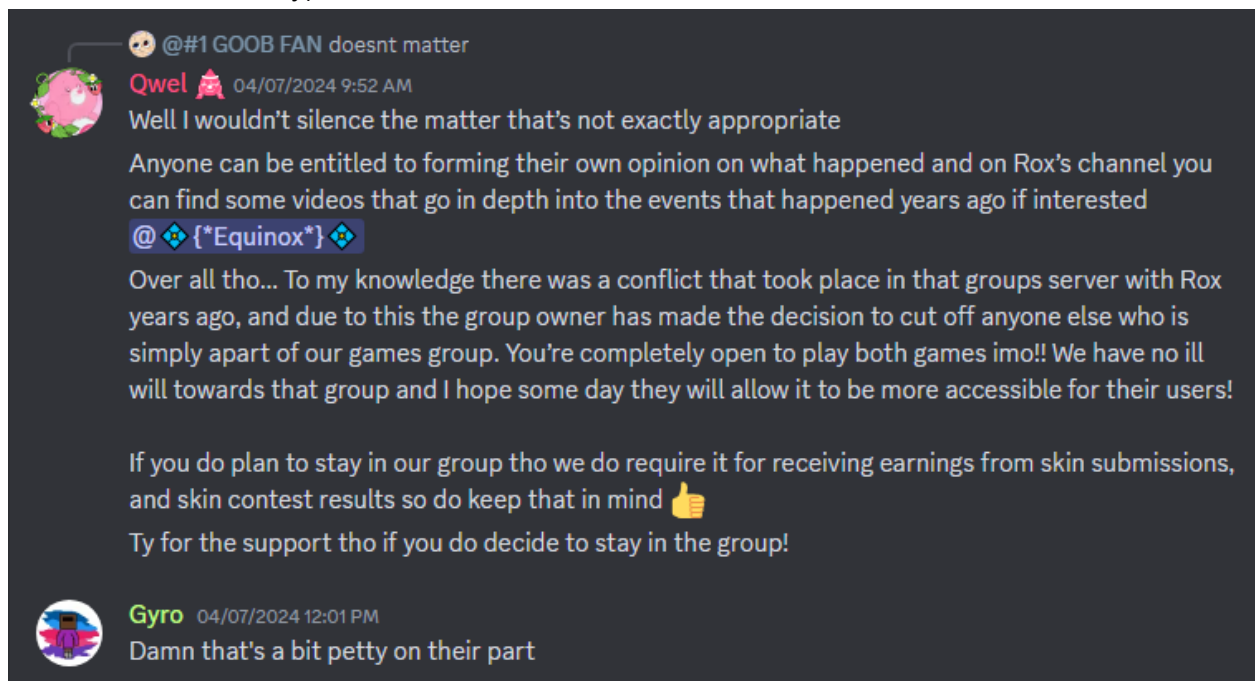

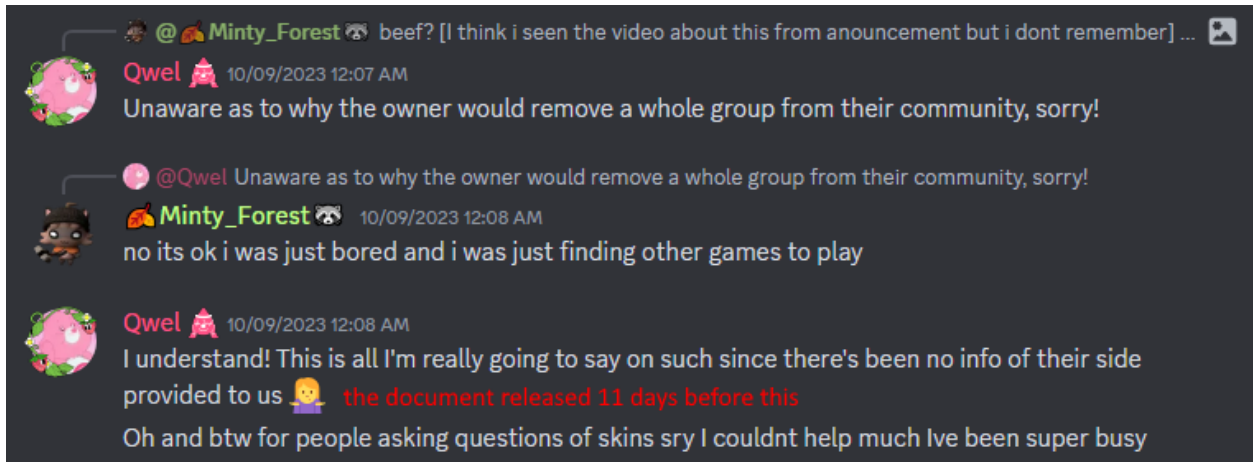
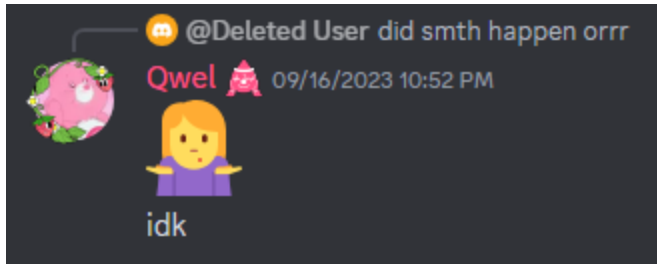
- 1/09/2021: Rox fully leaves Databrawl
- 4/01/2021: Rox becomes a contributor for Tower Heroes
- 4/10/2021: Rox draws CP
- 4/26/2021: Rox draws CP of Gary (15) and someone else, Rox would've been 18 at this time (there's almost certainly more, especially since Rox's caption for this was "The sequel to _ x gary")
- 6/22/2021: Rox ~~leaves~~ is banned from Tower Heroes

Conclusion

To us Rox's apology rings hollow -- lying repeatedly in both videos, only apologizing for what was leaked publicly, using us as a 3rd party to justify his actions, and only sharing his first video full of lies to his community. To this day Rox has never shared the video directly addressing what he did to his server and it SHOWS. Nobody in their community grasps the severity of what they did, and it's likely because only the first video filled with lies was shown to them. With both his videos addressing this being riddled with lies, misinformation and excuses, we cannot in good faith believe anything he says. We hope this document is able to more comprehensively explain what Rox did.

Also something somewhat unrelated but I find it odd their co-owner, Qwel, doesn't seem to actually know what Rox did and instead helped contribute to the narrative that what happened was just petty drama. (Blush Crunch was banned after we became aware of Rox's sexual interactions with Buddy)





TLDR (including Chapter 4)

Rox only responded to what he knew would be public, and only shared his skewed retelling of events to his community, including tons of lies. Talking about what happened with Rox was allowed in his community, Rox even admitting he did everything the document accused him of. When Dandy's World blew up, talking about what Rox did in any way was banned and labeled as "misinformation" and "targeted harassment" while others got banned for just stating facts.

Rox mentions how nothing has come out of him doing similar stuff since then, but he only stopped AFTER he was caught in two different communities doing it. We don't doubt he changed, but this point makes no sense as he'd have to be stupid to keep doing it while trying to make a career on ROBLOX with a community of minors.

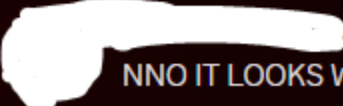
Alas, both of them have shown they favor their wallets over letting the truth get out, and would rather ignore the document knowing full well it'll get buried as we don't have the power to widely spread it. We don't expect a response from them, but we still hope they do eventually.

Chapter 4: The Ugly (NEW INFO)

This is more recent information to us, but after this document was released, former friends of Rox during their Tower Heroes era had contacted us about creepy things they did, also involving minors. **According to the people involved, almost everyone was roughly 14 at the time of these screenshots while Rox was nearly 18.**

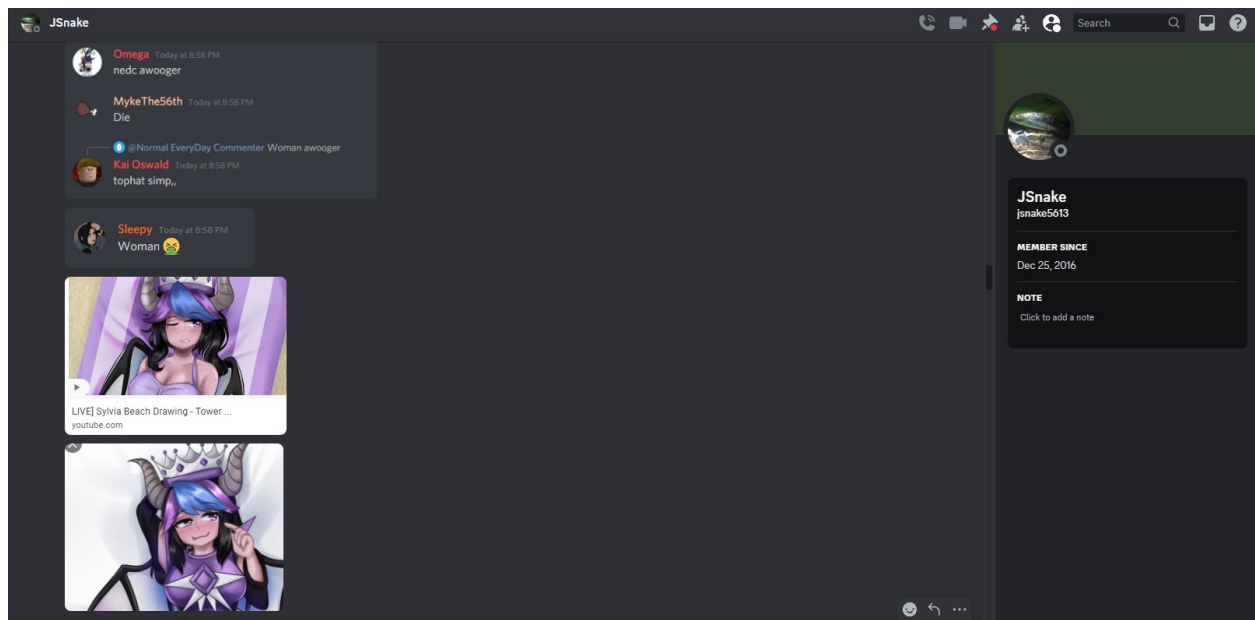

Additionally, Qwel has exclusively been talking about the document through tickets instead of giving it any attention publicly, and we would like to talk about their response here as we take issue with it.

Hello! we've had this brought to us already by some, I am going to send you a copy of what I've told other users who create a ticket on such...
Hello, thank you for bringing this to our attention. We have been dealing with this situation and it's important we clear this up.

First of all, it is important to say that Rox was 17 when all of this happened. The incidents with Rox messaging people occurred in 2020 and the art was made in May of 2021. Rox has already responded to all of these things nearly a year ago. These accusations have been around before BlushCrunch Studios even existed. Paige, the person affected in the document, has forgiven Rox, and Rox has spent the last two years learning from these decisions and moving past it and has since never repeated these choices. This is why everything in the document is from 3-4 years ago.

Second off, the person who created this document has a bias against BlushCrunch as a whole. Xtriel is a dev at Databrawl, and Databrawl has banned everyone who is a member of BlushCrunch from their games. They are also the same people who are spreading around these old allegations most likely to damage Rox due to our success with Dandy's World.

This doesn't excuse what Rox did all of those years ago, none of us deny that. But we think everyone deserves a second chance, and we've done everything we can to help make the situation better. However, Rox is not a pedophile nor a groomer. Rox was a teenager in those messages that are being circulated.

“First of all, it is important to say Rox was 17 at the time”

It's important to say that was already stated in the document. Qwel would rather harp on Rox's age at the time and not the age gap between him and Buddy, who was 13, and probably because it'd look way worse if they tried justifying his actions there. Also being under 18 doesn't suddenly mean you cannot be a groomer.

“The incidents with Rox messaging people occurred in 2020, Rox has already responded to all of these nearly a year ago”

Well now there's instances of him doing this in 2021 as well, and when you say “Rox responded” you mean he admitted to doing it or lied then yes he did. Rox himself also admitted in his second video that the first was full of lies, especially the segment on Buddy, but refused to share this video or our side to his Community and does to this day.

“Paige, the person affected has forgiven Rox”

No, they haven't. We asked them while writing this and they told us what they said was only after YEARS of your apology if you've done nothing wrong will they forgive you. So far both your responses come off more as defenses and excuses for your actions and not as apologies where you take full accountability (Also they weren't the only person affected).

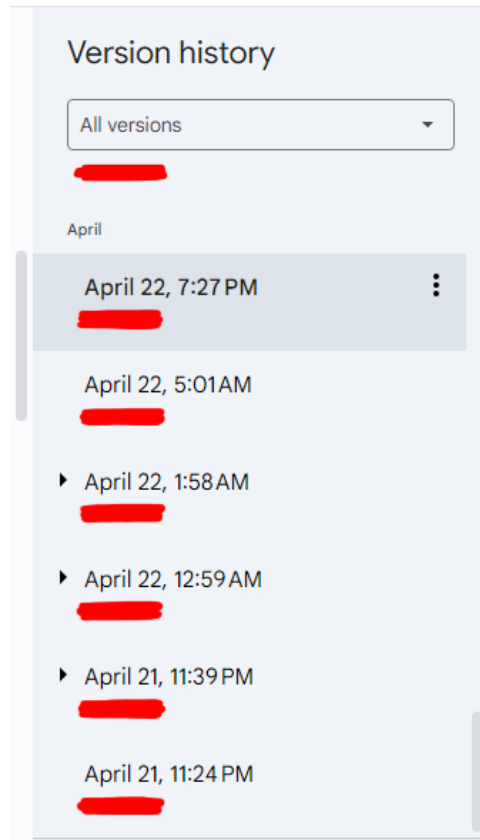
“That’s why everything in the document is from 3-4 years ago”

The reason everything is from 3-4 years ago is because nobody knew about it, Rox got away with it. What happened with Buddy only became public to anyone last year, and in Rox’s video he only addressed allegations he KNEW were being spread around and nothing more. He was never properly held accountable for his past. Qwel would rather ignore these facts and from what we can tell excuse Rox’s actions by saying “It’s old news” or ignoring details that are indefensible (Stating “it doesn’t excuse it” after trying to excuse it doesn’t count).

“The person that created the document has a bias against BlushCrunch as a whole, and was likely created to sabotage the success of Dandy’s World”

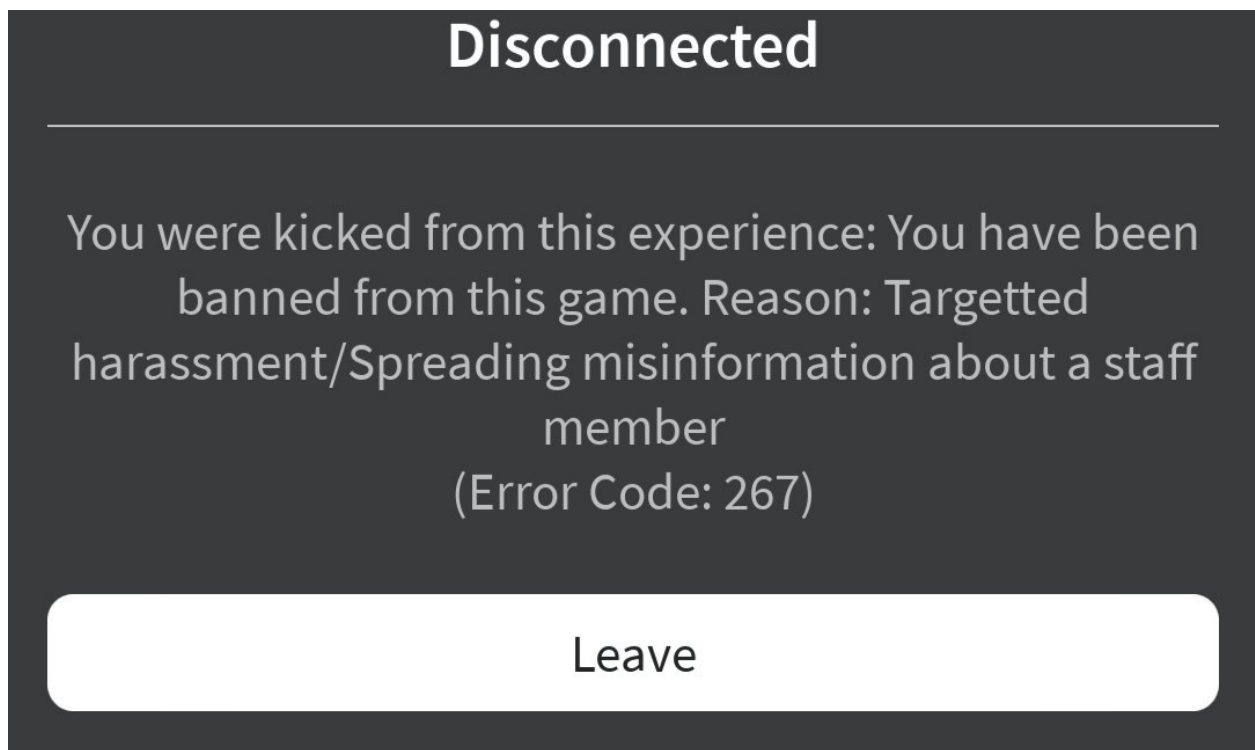
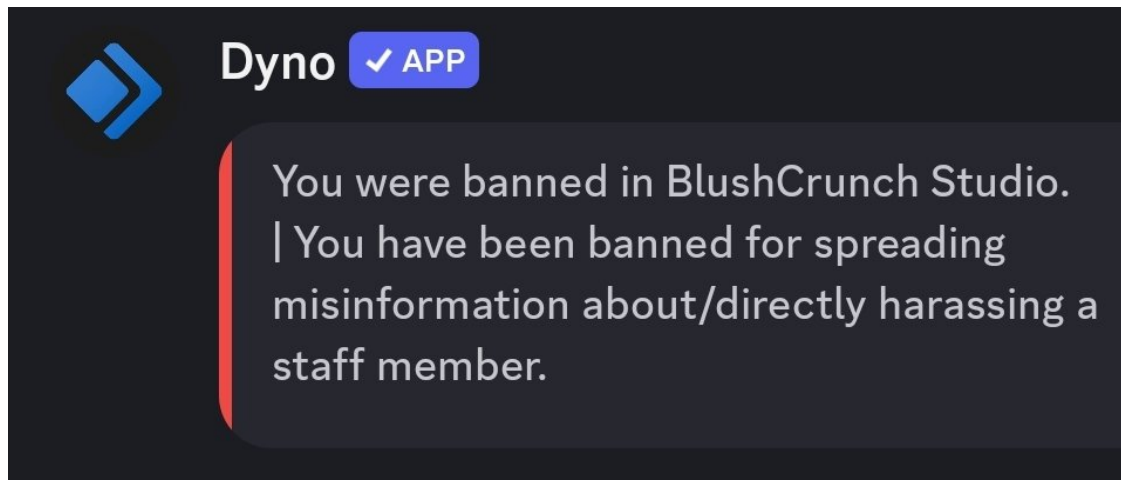
Firstly this has nothing to do with BlushCrunch, this is about Rox and we hold no bias against them. Secondly, Ok? Are we supposed to think highly of Rox while writing this, what’s the point of mentioning a potential bias? This is a complete nonpoint to try to discredit the document.

As for Dandy’s World, while it definitely did affect how frequently the document was being written, it was never about that. The document started being written 2 months ago, well before Dandy’s World was even known by us. We wanted to rewrite it as Rox had never shared our side or the truth to his community, only his first video filled with lies and excuses. The WHOLE POINT of the document is to both archive what Rox did that has *never* been made public and also to have our side out there, to have him respond without the lies, 3rd parties or excuses. This has been the goal from the start and hasn’t changed.



From what we can infer, Qwel and Rox have 0 intention of ever largely addressing this publicly now. Instead, Qwel publicly feigned ignorance to knowing what Rox did but is now saying they're "giving him a second chance". It's a shame to see Qwel favor their success with Dandy's World over having Rox take full accountability for his past and his lies from both his response videos, **none** of this would've been known if it weren't for our document.

In fact, apparently someone got completely banned from their community for making a video where they simply state what's in the document, things Rox **admit to** with their ban reason being "spreading misinformation/targeted harassment". [This is the video in question](#), the closest thing to misinformation in it is them making a pedo joke in their intro (they outright state Rox isn't a pedo later too and not to harass them as well).



Also it's insanely disingenuous that after we updated the document with this info, Rox moved the goalpost in their response from "The victim in question forgave me" to "They chose to not forgive me but instead make things worse", and kept in saying we only created the document to damage Dandy's World when that isn't true.

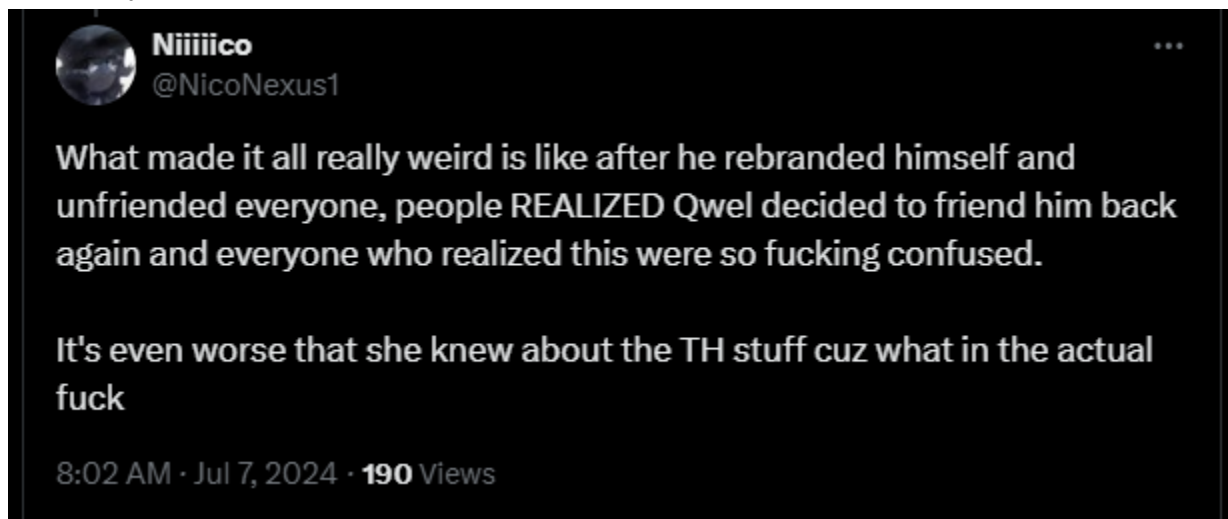

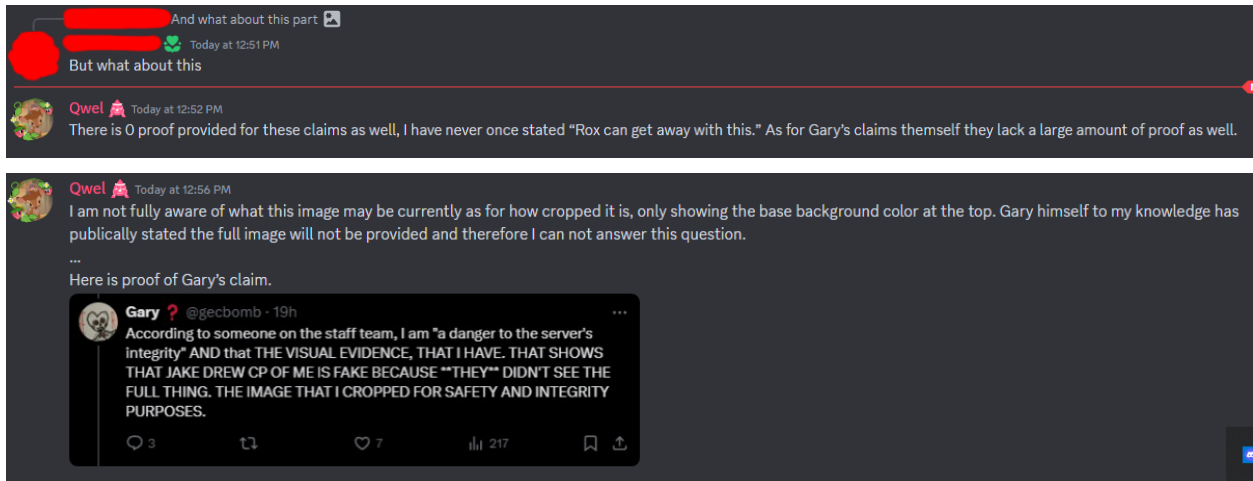

A thread explaining more about Rox drawing CP from a victim of it and further implicating Qwel to have been aware of it well before anyone else. Furthermore apparently after Rox rebranded themselves and left Tower Heroes Qwel willingly friended him again and went along with him, which is significantly worse in hindsight knowing Qwel was completely aware of Rox drawing CP before anyone else.



Qwel has also effectively denied these accusations, saying Gary "lacks a large amount of proof" and likely tried this approach as the convos happened in a voice call. (more on next page)



Thankfully, chat logs of that voice call exist where you can clearly tell Qwel knew and understands what Rox was doing was inappropriate, and a convo from another the same Tower Heroes contributor to Hiloh about Rox further proves this did happen and what was said in the VC

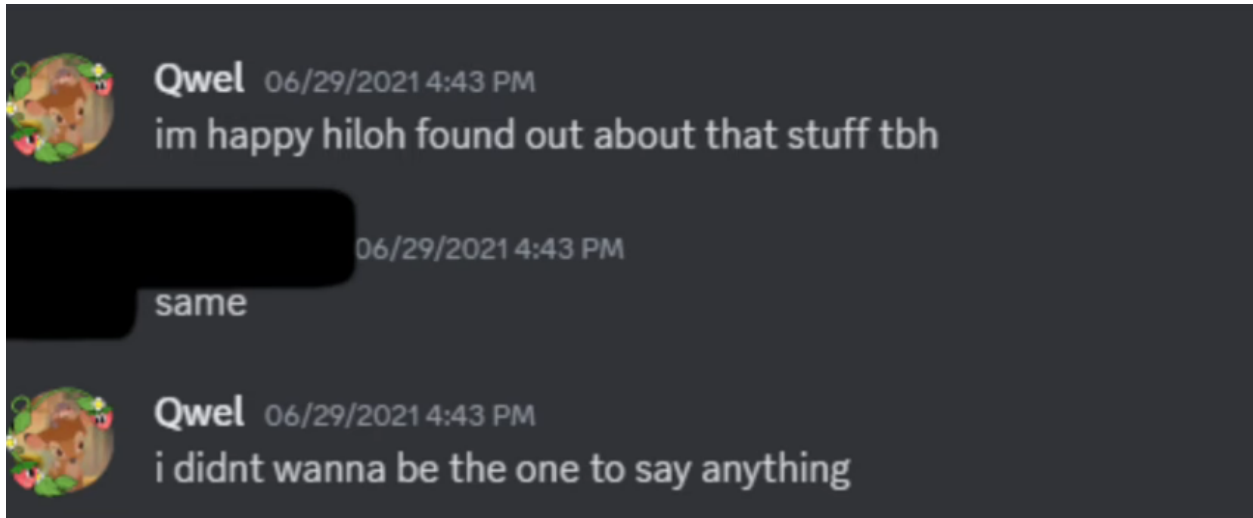

Chapter 5: The Uglier (Response)

Rox has finally made a response to our document, something we were holding hopes would happen. Unfortunately, he went the route of not just antagonizing us but rushing his video out instead of taking the time to review what he's saying and like his first 2 responses it's riddled with lies and manipulation. This chapter will be dedicated to responding and dissecting what Rox and Qwel say in their newest response video. Expect it to be lengthy as there's massive issues with almost every point Rox makes.

Rox's Response

Hurricane Beryl & Rox's dead cat

This is guilt tripping and manipulative, plain and simple. It's completely irrelevant to his video and is only to make his side seem sympathetic, which is definitely why he also included the news clip and showed the death toll. Him starting his video off with emotional manipulation is insane and goes to show how desperate he is now to victimize his side while antagonizing us.

In fact he even ends his video doing the exact same thing, but instead using the death of his pet to garner sympathy. It's disgusting to see not just the deaths of at least a dozen people used for his gain, but the death of his pet as well.

In the time between the release of this new document, dealing with the harassment from users, and creating this video, my cat Chloe had passed away. The people harassing me and dealing with the situation never gave me the time to mourn her loss.

You were hiding it. Before Dandy’s World’s release, talking about the document/accusations was allowed, it was only then that discussion about it at all was cracked down on. 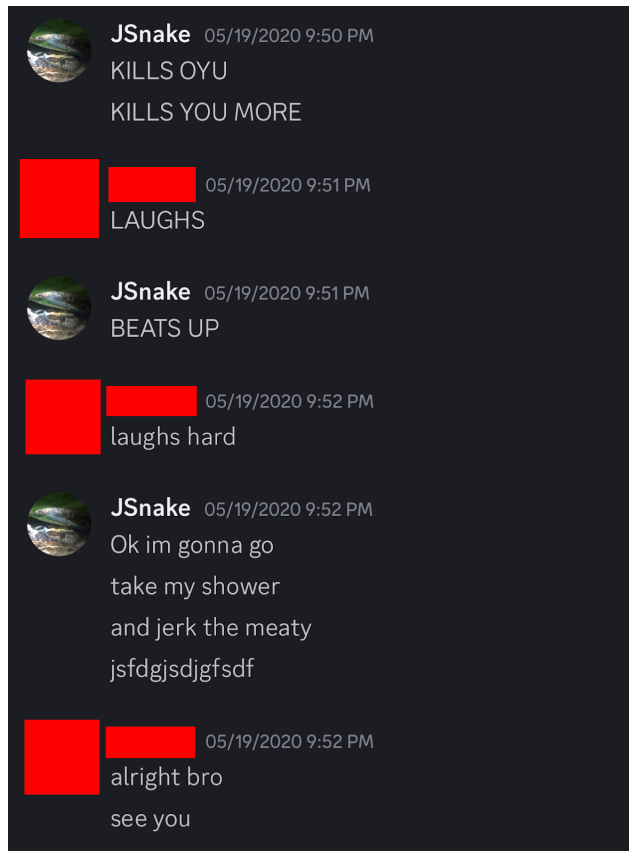
Also let it be known minors can be groomers too, he only included a definition specifying “Adult” to try and exonerate the use of the term. The mental gap between 13 and 17 is massive and Rox seemingly ignores this in his video as well.

“The document creators don’t show context to the screenshots or proof that they were even sent to Buddy” (Implying they could be fake)

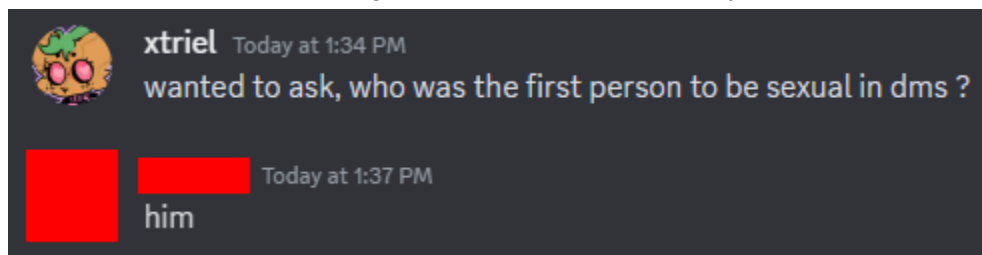
You admit they were real and apologized for them, except you tried to lie until receipts were sent. We know you were sent most if not all the screenshots of Buddy describing their interactions with you, including the part where they describe Grooming because of your second video and the nickname “Buddy”. The fact you’re even trying to push doubt on the validity of these after you already admit to them is baffling, especially opening the idea it could’ve come from “the myriad of DMs and servers I was in at the time”. The fact Rox even tries this when he knows these are real and towards Buddy is disingenuous, but since he thinks showing more context would somehow change anything, here’s less cropped screenshots sent to us by Buddy. Reminder once again Rox was 17 and Buddy was 13.





To add onto this, according to Buddy, the first person to act sexually in DMs was Rox. In only an hour Rox would escalate it to telling Buddy about how he and another friend “watched each other have fun”. Reminder again, Rox was 17 and Buddy was 13.

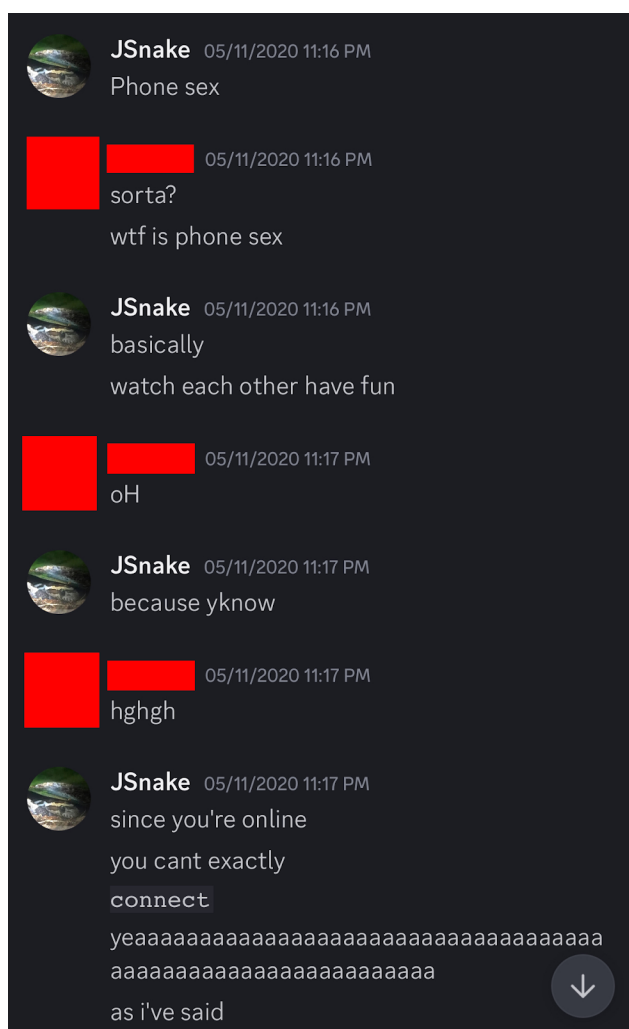

“The old document oddly does not accuse me of being a groomer”

The old document doesn't call you a groomer because even though people around me were using it, I myself wasn't fully aware of what it meant and I didn't want to accuse someone of something I didn't think they were. It has nothing to do with making it “more sensational”. It's also odd he's saying “allegedly” after openly admitting to what happened with Buddy.

“The document said almost 18 rather than 17 to make it more sensational”

You were 2 months - 2 weeks from being 18 in the screenshots, and in the ones Gary posted you were already 18, but it seems you conveniently skipped over that. Regardless, being 17-18 isn't a sudden switch as to whether it's ok like you seem to believe, as evident with yours and Qwel's replies to tickets.

“I remember there specifically being 15-16 year olds, I don't remember it being mostly 14 year olds” + “Moaning in the vc was my attempt at humor”

So you remember their ages and the context as to why you were moaning at them, but when it comes to the more serious allegations like with Gary or Buddy or who the statements are even

from / their validity, your memory is suddenly hazy? There's no consistency. Additionally, the people involved here stated they were 13-14 at the time which was shown both in his video and in this document. Regardless, there being someone 16 wouldn't've mattered, there were still a big handful of 13-14 year olds present.

“These messages were supposedly proof of me grooming but weren't targeted at any person” + “They compared these messages with the interactions I had with Buddy”

These images were to show you further acting inappropriately around children when you were nearly 18 years old. It doesn't matter whether or not they were directed at anyone specific, you were almost legally an adult and some of them were bordering not being allowed on Discord.

As for this being compared to what happened with Buddy, you completely stripped that of its context. That was in regards to your copy-pasted ticket response, where Qwel tried to say “The messages are from 2020”, so it was pointed out that's not true and it continued well into 2021.

“The document spins what happened in Phighting, saying they did hear me out when they didn't”

They did hear you out. You argued your side through your friend and they didn't want to let someone with that past into their community. You mention them saying “people who say they've changed often don't” like that somehow proves your point, but that shows exactly what this document said earlier. They never said you couldn't change, they said they can't trust you have and would rather not risk it (*Rox also ignored the message under that where a mod said “I couldn't believe that if they did shit like that”*). Also so much for anonymity, looks like you're dragging everyone into this.

“xtriel claims I left the Pixel Bit community when I was actually banned, which is ironic for a page called ‘The Truth’”

???? Wow, I used the wrong word once. Why is this even being brought up like it's some sort of “gotcha” moment? If you wanna get needlessly nitpicky over word usage, you, Qwel and your mods haven't used “shadow ban” or “misinformation” correctly a single time, it's just a ban and you're accusing us of “disinformation”, not misinfo. Though, I guess you'd rather use bigger and easier to understand words to sensationalize what happened more than to take a 5 second google search to verify what you're saying.

“The document claims I did not share their side to my community. I'm doing it right now even though you claimed I'd never make this video”

Because you didn't. As mentioned earlier, you never shared that video ANYWHERE. It was silently uploaded to your Youtube channel and only got boosted in views after the rewrite of the document and Duck Adam's video. Only your first (and now third) video was sent to BlushCrunch, so this would be the first time you've linked the document in any way to your community.

Once again, if you actually bothered reading either document you would've found out that's what we're talking about, it's even in big bold text in the old document so you cannot miss it.

As for your current video, I was not only told a video wasn't being made by a moderator in your server (which was true at the time), but [you yourself state you wouldn't've responded if things didn't escalate](#). You didn't want the community to know our side, and you made sure any public discussion of it wouldn't get in the way of your success.

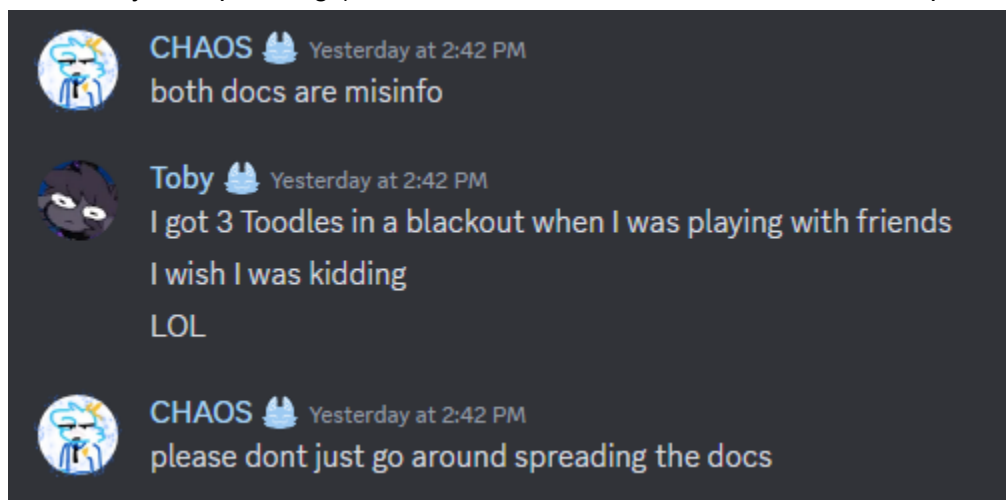
[“xtriel is a biased source of information”](#) + [“xtriel has a vendetta against me”](#)

Everyone has a bias, obviously someone writing a document exposing you for grooming will have some sort of bias, similar to how your mods lying on your behalf both in and out of your server is a bias toward you. Similar to how your pretty clearly angry response video where you nitpick me saying “leave” instead of “ban” is biased against us and it's clearly affecting your judgment, what matters is whether you show it. You screaming “bias” and “misinformation” with no evidence to every ticket is a nonpoint to quickly discredit us and that was our point.

I think it's very weird he'd skip over me saying we hold no bias against him to lecture how having a bias is bad, but since clearly it needs to be stated again and more thoroughly: Everyone has a bias, it's normal. We hold no strong bias against Rox and have shown none in our document, any bias we do have has not been proven in any way by Rox, it's a nonpoint.

As for contacting youtubers, if you couldn't infer from my tweet I was hoping for a response that'd finally get our side out there and was told the best way to do it is through Youtubers. What we wanted was an apology, one without the lies, excuses or bullshit you drenched your last 2 responses in, and my worry was you'd either not respond at all or antagonize us further as fully taking blame would look significantly worse on you. Which, as you mentioned, both options were something you were considering and you likely would've NEVER responded if it didn't escalate, so what's your point here?

Additionally, them claiming I was going on “every social media to spread the document” is a lie. He showed a screenshot of me commenting on Tik-Tok but stripped it completely of its context. I was responding to one of your trial mods who was actively lying on other posts on your behalf. Funnily enough, after what happened on Tik-Tok you promoted them to moderator and left out the lie they tried peddling (You're welcome, that would've been another point in this document).

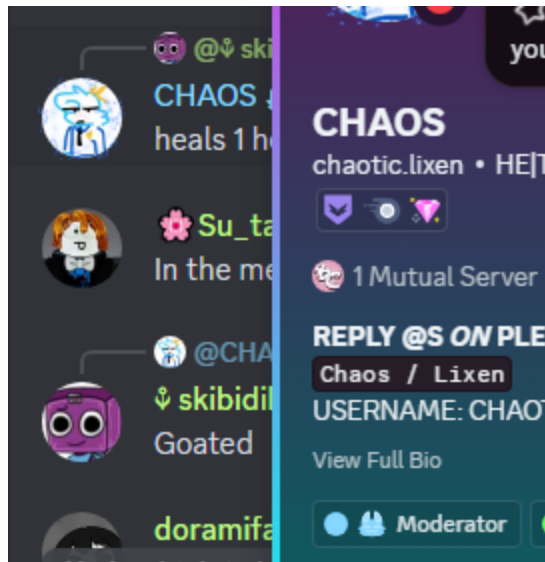

Dragging Duncan into this and trying to compare his and Duncan's allegations.

The fact Rox had to drag Duncan into this at all to defend himself speaks volumes, and was something we hoped he did as it would've shown he has no ground to stand on. What he's trying to do here is discredit me instead of the claims against himself, which ironically what he has isn't about me but rather my employer??

His and Duncan's situations are completely different, yours is where you never once refuted knowing the age of anyone (likely because you knew), have a track record of this behavior throughout 2020-2021 and drew CP on multiple occasions including as a legal adult. Duncan has never repeated what happened with Mya and has claimed to have not known their age, a claim that to this day has never been refuted nor any evidence has been shown. *(Also small thing but Rox saying Duncan was "at least in their early 20s" feels disingenuous and an attempt to try and make Duncan seem years older than they really were and as such make their situation seem worse. From my knowledge, Duncan would've been 19-20 at the time. It's odd he even said that when he clearly has no guess as to how old Duncan is)*

Additionally one of the documents he shared was a defense of myself, as to why I don't believe he's a pedophile like Mya claims, and only has this one example as to me "repeatedly defending him". I don't condone what he did, I did not excuse what he did nor did I ignore anything in the document, it was a defense as to why I still work for him and that's it. Also I think it's funny you try to claim "I don't care and defend bad things my friends do" when we used to be friends (maybe not close ones, but we were).

Bringing Duncan into this does nothing to clear the accusations on Rox nor does it remove the validity of them, Rox spends a majority of the video attempting to paint the victims and his accusers as "bad people" while farming sympathy and it's so blatant people have noticed immediately. It's pretty ironic you complain about death threats and misinformation then peddle accusations against someone not involved that to this day haven't been proven with a pathetic disclaimer to not harass anyone left at the VERY END of your video. Very disappointed to see that the majority of the time in this video is spent discrediting others instead of responding to the allegations. I get that it can be frustrating to see all these people come at you but defending yourself should be at the highest priority. I haven't really spoken publicly about the situation that much but the reason I held off on banning Rox for a bit was because he had always led the contrib team on for his time there. I wouldn't be told the full story and aspects of it would be downplayed as what I can only assume were a means to keep his role in the community. I'd be contacted by members of the Databrawl community that wanted to inform me about Rox's past actions there and be told not to listen to them by Rox. Me and the mod team were really conflicted on what to do during the time as we were still dealing with the effects of the massive drama Octotrooper started after her ban and didn't want to make even more enemies, but we eventually settled on removing him from the community. As far as the Qwel ban goes, once she moved on to BlushCrunch she became less and less active in Pixelbit over the years. When the document came out I was expecting there to be some sort of response but nothing was said on it which made it clear the plan was to have everything fizzle out over time which I found horrible. Adding on to that, I would see lies being spread by her and the way the situation was being handled in her server overall was disappointing. In the VC Qwel had with Spookiner, she mentioned that she knew about the art Rox drew (there are screenshots of Spook telling me she told him this that were purposely not included in this video) yet Qwel still decided to work with him. This always rubbed everyone the wrong way and the fact it's trying to be spun into her not knowing is wrong. Obviously it wasn't an easy choice to ban her as she did a handful of things for the game but this behavior was just unacceptable. I'm at the very least glad that there was some sort of response in the end from you guys but I just wish most of it wasn't bringing people down and not telling the truth.

Regarding Gary

[“I do not remember making CP of Gary”](#)

In Rox's video they try to say Gary lied about Rox making CP, but in the same breath admits to drawing them kissing and [“vaguely having sex”](#). Regardless of what you're saying it is, you purposely depicted 2 minors having sex and just admit it was meant to be revenge porn, all while you were 18. Also, the fact he has to say he's “not aware of drawing CP of them” instead of flat out denying it is odd, he's using safe words in case it turns out he did, meaning the possibility it happened isn't ruled out in his head.

[“Gary refers to himself in the third person, to intentionally make it look like a third party was dubbing Duck Adam's video”](#)

Genuinely, what do they gain from doing this? Also, immediately after you mention Gary did outright say he voiced it, but also fail to mention the description also states he voiced it. This claim makes no sense and you even admit it in your video, so why make it? What would Gary or Duck Adam gain from doing that at all?

Talking in a third person is completely normal and is to try and present the information more neutrally rather than as ones retelling of events or their opinions, and Gary confirmed this was their intention.

While Qwel didn't directly call it petty, the screenshot you provided DIRECTLY SHOWS Qwel downplaying it and lying about knowing what happened, calling it “some conflict that happened in Databrawl”. The first document and both of Rox's videos would've already been released for a while.

[Databrawl's ban of BlushCrunch](#)

Firstly, while it states it's a ban, it isn't. People who want to play Databrawl can simply just leave the group to play it, as stated in the kick message. We want nothing to do with anyone that supports Rox in our community as he hurt many friends and members of ours directly. My hope was that when they get kicked they would bring it up in either of our servers to figure out what happened, which is what showed us BlushCrunch pushing the narrative that this was all just petty drama.

This narrative was directly caused by both Rox, Qwel, and the mods they have a responsibility for. As once again only Rox's first video had been shared to the community and Qwel was actively feigning ignorance to knowing what Rox did. While mentioning “people are saying it's petty on their own” is true, it's because they didn't know what happened in Databrawl as you NEVER shared it with them. The closest it ever got was Qwel mentioning you made some videos on it, but they try to downplay it in their summary immediately after.

Duck Adam's Ban

Rox props up the reasoning for Duck Adam's ban to be that he essentially "exposed minors recklessly to NSFW" (ironic) and "called him a pedo over and over". Duck Adam had a single clip making a pedo joke and that was it, and you can clearly see in the clip ROX PLAYED IN HIS RESPONSE Duck Adam saying Rox isn't a pedo. Ironically, Rox actually says "Duck Adam called me a pedophile over and over again" over and over again, but I guess saying he made a joke about it once then clarified you weren't would be as sensational.

As for the ban appeal they received from someone pretending to be me, that isn't me why would you even include it in the video. Then there is rox getting nitpicking that my friend Gary did the voicover of the video in third person, in a video laying out the allegations in a way that's easier to understand it feels best that it'd be third person to get rid of bias. As for the claims that there was no warning in my original flavor frenzy video that is guess what, not true. There is a warning before the part about rox in the video and jake completely lies about the contents of my video saying that it's just calling him a p*do over and over again and that my ban speedrun was just saying that I don't care if I'm banned. Neither of these are true (the ban one is kinda true but just cyber) if you watched either of those you'd know I didn't call him a pedophile once. I tried reaching out to rox before the video was published not to use it for the video but instead to hear his side of the story and ask a few questions which he frames as me trying to use him for content(im not parlo jeez). He also shows an obvious joke comment on my video that i pinned cause its funny but rox claims its me promoting harrasement and threatening others but like ive gone out of my way to prevent that. The last thing I wanna note is how he shows alt accounts that aren't even mine or not for playing dandys world (only 4 of the ones he showed were actually used to play the game on the ban speedruns). That's all I felt like saying about my part in the video but I want to point out how instead of responding to the allegations he uses sympathy bait and paints everyone who called him out in a bad light. Bye yall!!!!

[“Duck Adam recklessly exposed 7000 people, I’d imagine to be minors, without warning”](#)

While Duck Adam didn’t include an explicit NSFW warning in their video, there was a warning that he was about to talk about something serious, but Rox completely cut over it. Additionally, you directly exposed minors in your server to even more NSFW content than what our document has with this video just now. You even did that with your first video, when the allegations against you weren’t public and were only spread to Phighting.

Even though your community knowing what you did is what we wanted, the hypocrisy of repeatedly deleting the document and discussion of it publicly on your server because it’s “NSFW and against our rules” regardless of if they added a content warning or how the document itself has a content warning, THEN posting this video which has even MORE inappropriate content in it than our document is insane. This too is extremely blatant and people have noticed. Guess you could say [having a “No NSFW” rule is worthless if you’re not enforcing it](#), right? Or was it ok for you to do it because your video was more focused on attacking us instead of responding to your allegations?

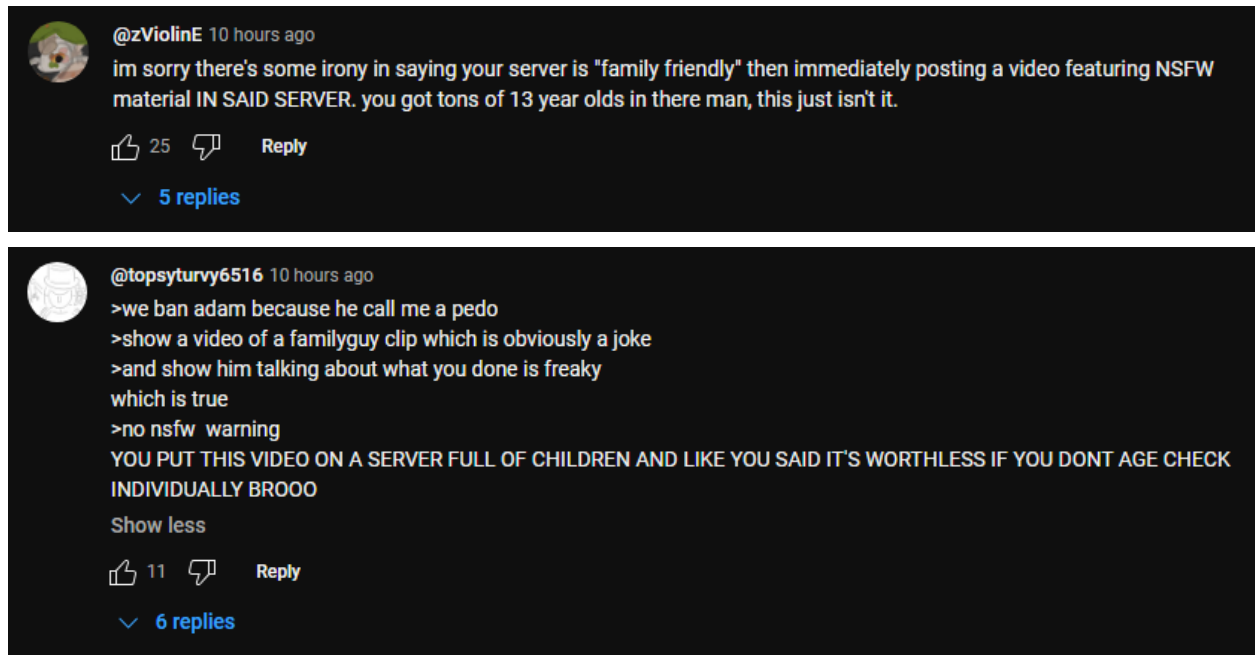

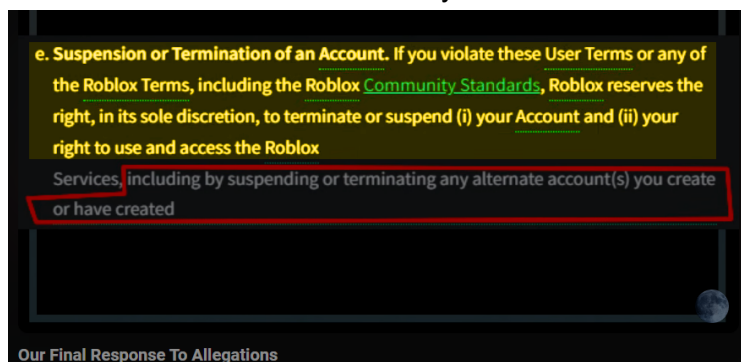

The fact you assumed it was Duck Adam in a google survey where identities can't reliably be verified and used it here STILL without verifying it is dumb. Maybe you would've been able to ask them if you didn't deny their friend request when they tried reaching out to you.

[“We published Flavor Frenzy 2 years after the incident with Buddy”](#)

Just wanted to point out Rox purposely chose one of the earliest incidents in the timeline to try and distance the time between Flavor Frenzy and his accusations. The most recent one we know of was from Gary, where in late April 2021 when Rox (18) drew revenge porn of them (15). Flavor Frenzy would've actually been published less than a year after Rox drew that.

[“Duck Adam ban evading is against Roblox's TOS”](#)

That's for terminations of Roblox accounts, not game-specific bans. The fact you couldn't even be bothered to read all the text in your screenshot is astounding.



“My server was raided by Duck Adam’s community and I assume Duck Adam is ok with the raiding”

The clip you showed here clearly has him worried about the raiding, it’s genuinely baffling how many times you’ve made assumptions or claims like this then show evidence directly contradicting you.

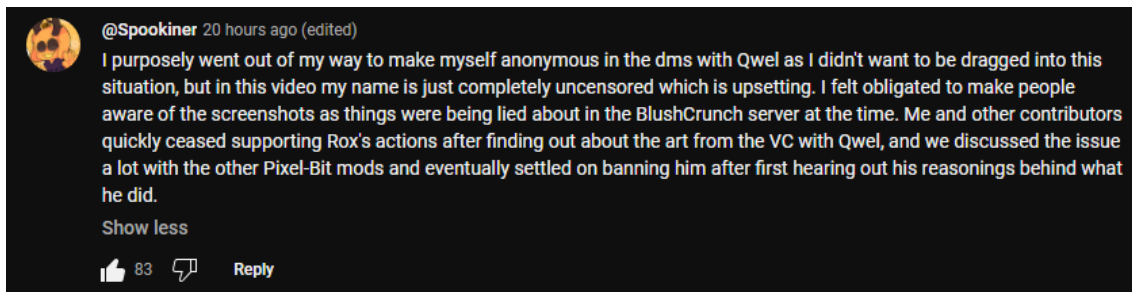
Qwel’s Response

“The screenshots in no way prove I knew about the art for months and the messages aren’t even from me”

While it doesn’t prove you knew about it since April specifically it does prove you knew about it before anyone else in Pixel Bit and knew it was inappropriate, which was Gary’s point. Like you said, that was the reaction of someone else toward you talking about Rox drawing porn of Gary when they were 15 and Rox was 18. Nobody tried hiding or denying the messages weren’t from you, like why would you start a DM call then proceed to use text chat? You used wording such as “Gary’s claim lacks a large amount of proof” instead of outright admitting or denying it, as though you knew it was something that might’ve happened or were trying to hide it in case evidence doesn’t exist.

“The screenshots were cropped in a misleading way”

What was misleading about it? It was showing you clearly knew what Rox was doing and uncropping it didn’t change the context at all. Calling it misleading then proceeding to not explain how is misleading. Also unsure why you felt the need to drag Spookiner into this by name, them being revealed changed nothing.



“When Gary posted their thread on twitter, I learned the same day I was shadow banned from Pixel-Bit, they did not tell me why” + “Hiloh was aware of what Rox was doing but waited to ban them”

Firstly you and Rox don’t know what shadow banning is, and it goes to show you’re just using words you don’t know incorrectly to sensationalize what happened. Being banned without being told the reason isn’t a shadow ban, that’s just a normal ban and from what people have said in your comments you’ve done exactly that too.

Secondly, Hiloh actually commented on your video explaining why you were banned, and it was because they were waiting on a response from you addressing the situation. When it became clear to them yours and Rox's intentions were to lie and censor discussion about the document in your community in the hopes the allegations would simply go away, they banned you.

Thirdly, as for Rox's ban, Hiloh's comment elaborates they held off on banning Rox as he'd "lead the contrib team on" by downplaying what happened with him repeatedly, and the full story never being given to hiloh, a behavior that seems to be consistent with Rox from 2020 to now.

Very disappointed to see that the majority of the time in this video is spent discrediting others instead of responding to the allegations. I get that it can be frustrating to see all these people come at you but defending yourself should be at the highest priority. I haven't really spoken publicly about the situation that much but the reason I held off on banning Rox for a bit was because he had always led the contrib team on for his time there. I wouldn't be told the full story and aspects of it would be downplayed as what I can only assume were a means to keep his role in the community. I'd be contacted by members of the Databrawl community that wanted to inform me about Rox's past actions there and be told not to listen to them by Rox. Me and the mod team were really conflicted on what to do during the time as we were still dealing with the effects of the massive drama Octotrooper started after her ban and didn't want to make even more enemies, but we eventually settled on removing him from the community. As far as the Qwel ban goes, once she moved on to BlushCrunch she became less and less active in Pixelbit over the years. When the document came out I was expecting there to be some sort of response but nothing was said on it which made it clear the plan was to have everything fizzle out over time which I found horrible. Adding on to that, I would see lies being spread by her and the way the situation was being handled in her server overall was disappointing. In the VC Qwel had with Spookiner, she mentioned that she knew about the art Rox drew (there are screenshots of Spook telling me she told him this that were purposely don't dwell on for long) yet Qwel still decided to work with him. This always rubbed everyone the wrong way and the fact it's trying to be spun into her not knowing is wrong. Obviously it wasn't an easy choice to ban her as she did a handful of things for the game but this behavior was just unacceptable. I'm at the very least glad that there was some sort of response in the end from you guys but I just wish most of it wasn't bringing people down and not telling the truth.

Conclusion to the response

Overall, Rox spent the majority of his video manipulating for sympathy, antagonizing us, deflecting onto others, lying, and both he and Qwel revealed people and communities that didn't want to be dragged into this. Almost none of it is actually refuting the evidence and that's because he admitted to the majority of it, he just hates the labels.

What truly matters here is whether the people involved accept Rox's apology, and from whom we've spoken to and what we've seen, at large the victims and old friends of Rox do not. Rox made it clear in their newest video the victims likely won't ever truly get closure from him, and in fact he will gladly make new enemies instead of fully admitting guilt.

As expected, when the document began spreading more than he'd like he attacked us and still won't address the bulk of our document about how he lied and manipulated in both his videos. We hope nothing else needs to be said to show Rox shouldn't be trusted, because what we showed and he showed with his conduct here should make that clear.

Sidenote: This is irrelevant but if you're reading this I noticed you [directly acknowledge me calling your game stolen](#) but still refuse to credit the people you took from. Please consider crediting Minus Elevation, taking inspiration or ideas from games is fine but taking another roblox game's concept verbatim and never crediting them anywhere is lame as hell.

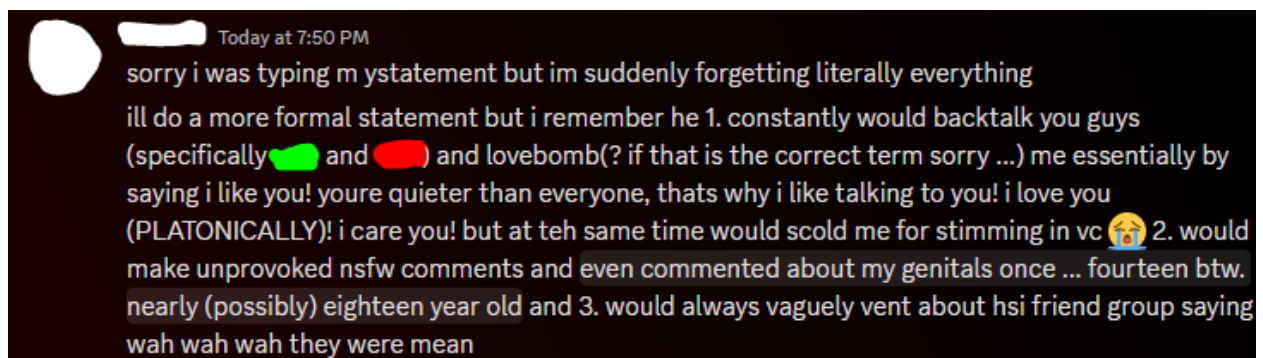
While there's no direct evidence of this happening as they allege it all happened in a Voice Chats, they are able to show evidence they were both a moderator and friends with both of them. In the screenshots you can also see Rox using us to guilt trip them, a behavior that lines up with how he acted back in 2021. Additionally it shows Rox saying he's been "nothing but receptive and honest" when at the time the first document as it is now would've been released.







Elaborating on the last paragraph, These weren't the only people to come to us essentially describing Rox using us to guilt trip and love bombing their friends, as their former friend group from 2021 alleged he did that to them as well. Furthermore the screenshots below show credence to the fact Rox absolutely DID NOT feel guilt over what happened and that is not why they left Databrawl [like he claims](#). The fact that 2 friend groups 3 years apart are able to corroborate the same story about Rox when he claims he's changed since then is concerning. You can notice how differently he describes the events privately to his friends compared to his videos.

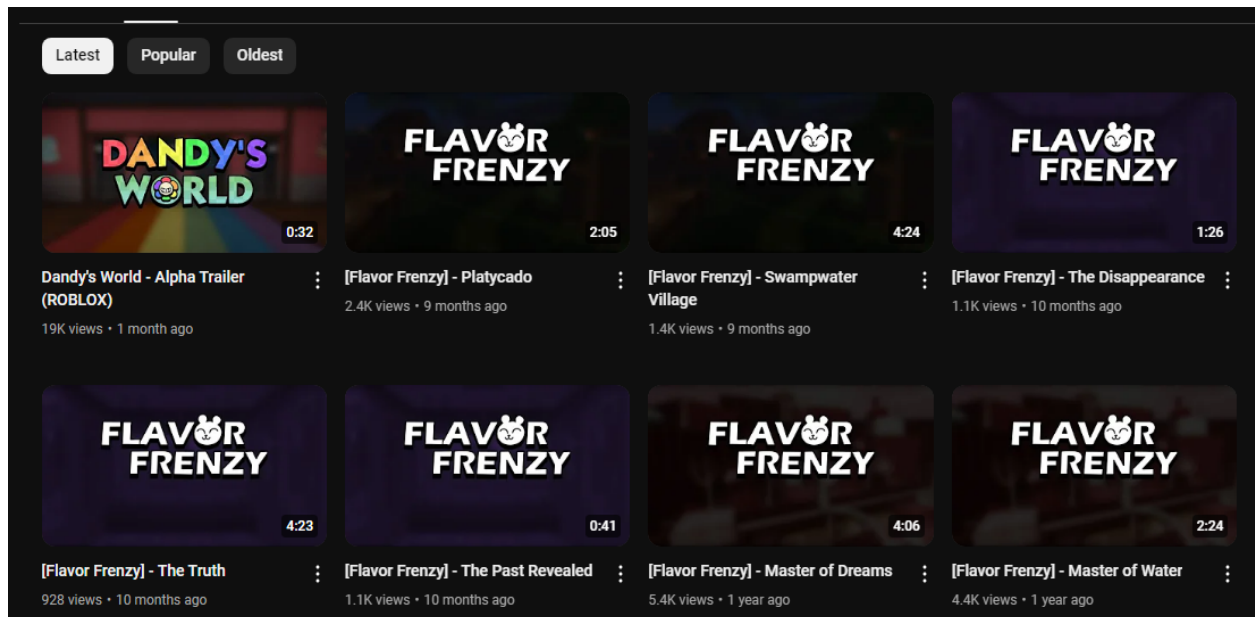
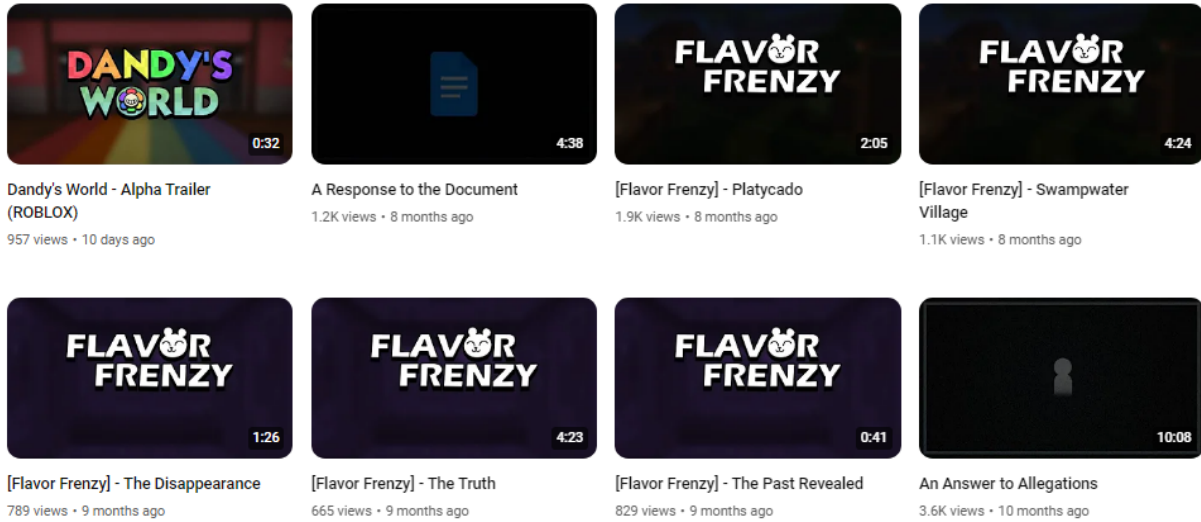


From what the other former moderator told me, they left once fully grasping the severity of what Rox had done and I assume the other staff in BlushCruch at large aren't fully aware either. 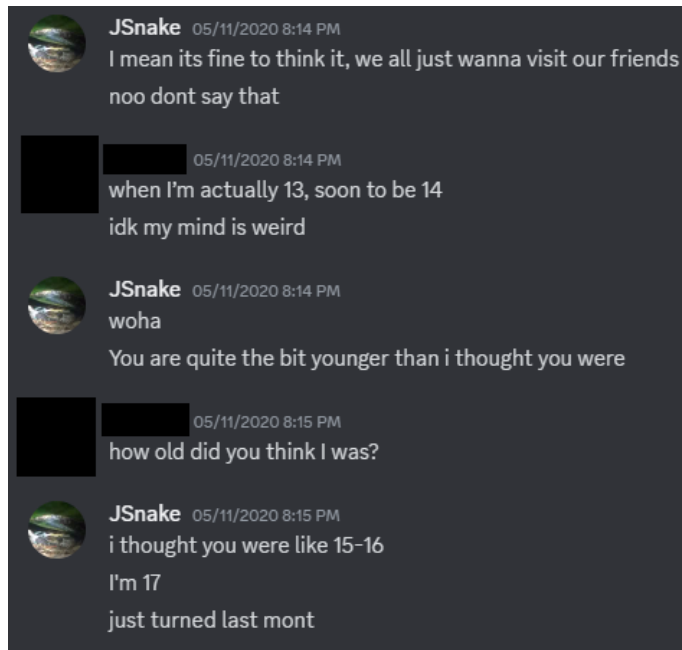

Final Information

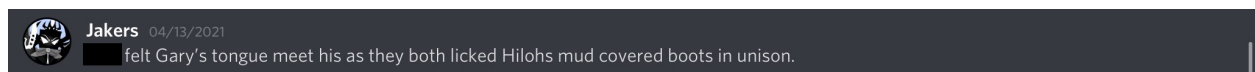
October 6th 2024

Earlier last night, a decision was made to fire Rox from BlushCrunch. The information revealed then will be shared below.

Firstly, proof Rox knew Buddy's age before any of the convos with him took place.



The image Gary claimed existed was allegedly found, where RoxSerpent drew them and someone else, who are both REAL PEOPLE and MINORS (14 and 15)having sex. The context behind why this was drawn might also be classified as revenge porn.



There are more allegations that have yet to be revealed and stuff I'm not entirely comfortable sharing yet, but you can probably expect it to be mentioned in Parlo's upcoming video.

I would like to thank Qwel and others on Rox's side for how they handled the situation privately over the past month, they were really respectful and understanding, and I appreciate how they've handled it now that more has come out about him.
