Paper orientation on all pages should be in portrait style [4].

## RESULTS AND DISCUSSION

The main title (on the first page) should begin 1 3/16 inches (7 picas) from the top edge of the page, centred, and in **Cambria 12-point, boldface** type and **UPPERCASE** [5].

### Tables

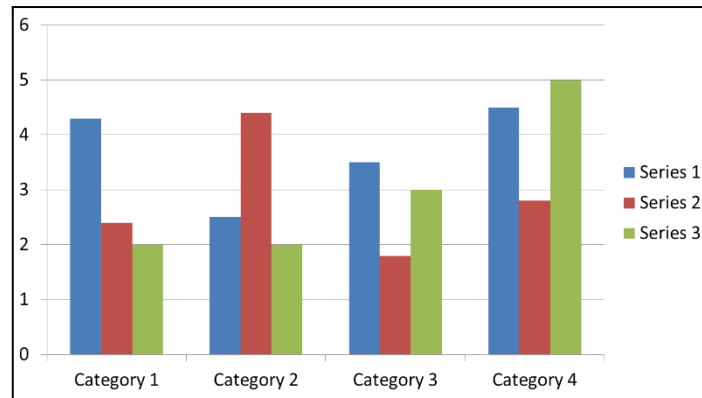
Place tables as close as possible to the text they refer to and align the **centre**. A table is labelled *Table* and given a number (*e.g.*, Table 1. Table of Islamic Education Values and Meanings in the Peta Kapanca) it should be numbered consecutively. The table label and caption or title appear **11pt space above** the table, and **6pt space after** the text or paragraph if any; it should be uniform fonts and font size, and use **10pt** font size and **Cambria style, capitalized** similarly to the paper title, aligned **centre** and **boldface**. Sources and notes appear below the table, aligned left. All tables must be in portrait orientation [6].

### Figures

Place figures as close as possible to the text they refer to and align the **centre**. Photos, graphs, charts or diagrams should be labelled *Figure* (do not abbreviate) and appear **6pt space below** the figure, **11pt space before** the next text or paragraph, and assigned a number consecutively. The label and title should be in line with the figure number (*e.g.*, Figure 1. Four Muslim Majority Countries in Asia), it should be uniform fonts and font size; use **11pt** font size and **Cambria style, capitalized** similarly to the paper title, aligned **centre** and **boldface**. Source (if any) appears underneath, flush left. Figures should be of good enough quality. Minimum image dimensions are 6 cm (2.3622 in) wide by 6 cm (2.3622 in) high [7].

## Equations

Including symbols and equations in the text, the variable name and style must be consistent with those in the equations. Equations should be indented at the left margin and numbered at the right margin, The equation number is enclosed with open and close parenthesis () **Cambria** in style and **11pt font size**. Define all symbols the first time they are used. All equation symbols must be defined clearly and understandably [8].

## FIRST-ORDER HEADINGS

For example, **“INTRODUCTION”**, should be in **Cambria 12-point boldface, UPPERCASE**, flush left, with one blank line before, and one blank line after.

### Second-order Headings (Sub-heading)

As in this heading, they should be in **Cambria 12-point boldface**, initially **Capitalized**, flush left, with one blank line before, and one after.

### Third-order Headings

Third-order headings, as in this paragraph, are discouraged. However, if you must use them, use 11-point **Cambria**, boldface, italic, initially capitalized, flush left, and proceed by one blank line, followed

by a colon and your text on the same line [9]. It should be noted, that manuscripts other than English can adapt this template.
