<u>DISCLAIMER</u>: These accounts are purely anecdotal; they may be partially or wholly false. Do not expect your experience to match any of the accounts below. Some accounts elicit scepticism from other members that I haven't included in this document; reading the whole thread (clicking on the Date link) is advised.

NOTES: In the attempt records below, the **Name** link leads to the attempter's profile. The **Date/Time** link leads to the attempt (or equivalent) thread. Four em dashes (----) signify separate posts. Members who self-reportedly vomited are highlighted in light-grey. I've tried to separate method details from experiences, but there are some overlaps/inconsistencies. I've turned short sentences into longer ones, separated with a period, but otherwise haven't done any "editing".

TOTAL: 26 attempts. 16 members reached unconsciousness. 9 members vomited. 11 members found too early. 6 members alerted or requested alerting emergency services.

I don't know what it was exactly - I was bound to an oxygen mask and it really was near chaos in that room. My arm has over 30 spots now where needles were stuck into. They then put me into a narcosis, after which they pumped me full of methylene blue, the antidote of SN. That's all I know."

SpaceForGrace said: "I SN tastes AWFUL to me, salty beyond sea water. I'm not fussy and can drink spirits straight with no issues but SN is gross!! I only had about 3 sips of the solution hope you don't mind a (following Stan's regimen). In about 10 minutes my heart rate was through the roof. I was already anxious about CTB and tried to not shout for help. I felt light question - just want to headed, sick, nervous and went scarily pale. When the ambulance came it was blue lights, my heart rate was 190, I had to be put on 100% oxygen because my oxygen clarify, aside from the levels were very very low (I think 65%), I turned blue and my blood was dark brown when I saw them take my blood. A paramedic told me I was going to make it and if fasting, you just took pure I wanted them to tell my mum. I was put in HDU, had to drink charcoal, stay on oxygen, be on a drip and take methanyl blue through an IV.

REPLY: "I only fasted then SN is very dangerous even in small doses. It is not painful, but very very scary. I did not feel like I was dying. I regret that I didn't go through with it, hence why I'm had the SN mixed with back. I feel like I'm meant to kill myself. I can't believe I was so close but asked for help. I hope I can go through with it for real soon.

I was in hospital for 2 days and one night then discharged after seeing a "crisis" team." ——— purplemoon said: "Do you have any lasting or residual side effects? Or do you feel / look basically the same way you were before you tried SN?" REPLY : "I think any suicide attempt has some effect on you mentally. But physically, I was stabilised around an hour after having the methanyl blue IV. I was BLUE like I was being called a smurf by the staff! But the next morning I looked exactly the same, felt very tired/drained and needed to go to the toilet a lot (being on a saline drip for 24 hours is a lot of liquid!). But there was no long lasting effects on my physically, it is very easily reversed if you are found in time and the doctors know how to treat it. The hospital staff were panicking as they had never heard of it before and they were running out of time. I was at a deadly stage after 30/40 minutes but I did not feel like I was dying. I don't feel any different and went back to "normal" in a couple of days!"

Forgot there was a local volunteer fire brigade. :/ I took the stuff, I didn't fast or take any acid inhibitor other than the baking soda. It was really salty, I think I may have put too much sn in the water. I drank as much as I could but wasn't able to finish the entire glass because of the saltiness and the sn itself making me drowsy. Got up to go outside, then walked a few steps before I started feeling very weak and collapsed. I don't know how long I was lying on the ground but it can't have been long. My girlfriend came out to check on me - I assume because she heard me collapse but it could've just been worry since I hadn't come to bed yet - and found me lying there. She asked me what happened and I told her that I took something, I don't think she realised it was serious at that point. She helped me into the spare bed and sat with me for a while, I started getting nauseous and was clearly pretty out of it she started freaking out about what to do - didn't want to call an ambulance since she'd seen how bad the psych ward was for me last time - saying she didn't want me to go etc. I hated seeing her like that so I made myself throw up a bit. Anyway I passed out soon afterwards and I guess she thought I might be okay? Apparently a little later I started having seizures while unconscious, gf came in to check on me and saw this so she told my mother who called the ambulance. There was no permanent damage as far as I know. 50g was too much just because it made it harder to get the stuff down having it be so concentrated, it tasted very salty like drinking seawater. As far as passing in and out of consciousness goes I guess I was too out of it to really wor

		a different mechanism than other sources of the symptom but I can't remember the details. My entire body was blue-grey. I haven't experienced any permanent numbness or necrosis or anything like that. Colour started slowly returning quite soon after they started me on the methyl blue, there was some lingering discolouration - I noticed it particularly in my feet - for a few days after I left the hospital. Oh also the methyl blue IV caused me to throw up profusely almost immediately even though I wasn't nauseous at all before they gave it to me, and the vomit was blue. Doctors and nurses seemed to think it was pretty cool, strange it was able to travel from my bloodstream to digestive system so fast. Also it tasted horrible. It changes the colour of pretty much all your bodily fluids, I was peeing blue-green for upwards of a week 50g was too much just because it made it harder to get the stuff down having it be so concentrated, it tasted very salty like drinking seawater. As far as passing in and out of consciousness goes I guess I was too out of it to really worry much, I guess the euphoria from oxygen deprivation probably contributed there. I was worried about brain damage but there's none that I know of. There was no cognitive testing done at the hospital that I remember though, so shrug. The doctor who treated me in the er didn't seem concerned about permanent damage when I asked him. I took some metoclopramide but the stuff I took was just the (lower dose) liquid kind for dogs so I don't know if it did much. I was nauseous before I threw up but I don't think enough that I would've thrown up involuntarily while conscious, maybe if I passed out. It was hours before I got the methyl blue, again rural area so quite far from the nearest hospital. I had oxygen via mask and later tube in the meantime, though. Ended up being seen at home by the home-based treatment team instead of going to the ward.

I wasn't sick at all and I don't know what happened... Used real meto from the eBay Greek vendor and SN from APC"

Walilamdzi said: "did they know it was a suicide attempt or did you say accidental ingestion? I meant sick when you puked three times?" <u>REPLY</u>: "Yeah I told them that it was a suicide. Hard to hide it."

Xaphous said: "Thanks also for your story. Can you rate your pain/overall severity of suffering /10? I ordered sn but I know it will still take a lot for me to endure more suffering. **REPLY**: "I don't know. There are a lot of things in this world that would hurt more. Maybe 6/10"

Done182 said: "What caused the pain eg headache, stomach ache? Was the pain bad enough that you would yell? This is a concern of mine as it would alert people and they would rescue me. Any advice for not calling the emergency services? If you could answer those that would be really helpful, hope you're okay." **REPLY**: "I wouldn't yell but cry, but I've never yell in my life so... About not calling... There isn't much I can help you with"

NextSummer said: "What I don't understand, if you puke your SN partly out, why do you still expect everything will go according to the plan and you can fall unconscious after 15 minutes? You did the right thing by calling the ambulance, this wouldn't have killed you anyways and you don't need to torture yourself for nothing." **REPLY**: "Yeah, I still waited some minutes just in case, but that's why I called"

NextSummer said: "I don't think there is a lethal dose in the body if one pukes 3x around 5 minutes (and before 15min) after ingestion. My personal hypothesis is that they noticed that he wanted to live (he called the ambulance and openly says he doesn't want to die anymore) and that they tried to scare him. I can not imagine a doctor saying "Oh don't worry nothing serious happened" after a failed suicide attempt."" **REPLY**: "I mean, they told that to my parents and I don't know why would they scare them. Also my methemoglobin was really high, I recall they taking blood from me and it was dark chocolate color lol"

I don't remember much after that until the paramedics arrived apparently I had slumped in my chair onto the remote and turned the volume of my stereo up so as to generate a noise complaint and police visit. Apparently from what I have been told this was around an hour after I had ingested the solution, once in the ambulance I was resuscitated and taken to hospital where I was stabalised and moved to HDU. When I woke up the next day according the doctor if I had arrived 30-40 minutes later I would have died that is approximately so roughly two hours after drinking the solution. I was then assessed for 24 hours and moved to a secure unit. I couldn't really put a time line on taking the SN and passing out but would put it at about 20-40 minutes there or there abouts. I have no idea how I didn't throw up but I didn't, maybe it was a one off I have no idea. I would ha e taken anti emetica but they didn't arrive in time for me to CTB. I would recommend to take them however as the nausea was quite bad. The really worrying or good thing depending on how you look at it is I can't remember any serious pain other than the symptoms I have mentioned, and looking back it just seems memory wise like a heavy night on the drink. As in I can remember things here and there but can't put a timeline together. I will be attempting this again but will be taking my anti emeitics this time. I am already omeprazole for an haiatus hernia.

Apparently my roommate wanted to ask me something and he found me passed out with a blue/gray face on the couch in my room. The doctors claimed that if I wasn't found, I probably would have died. Oxygen level was at 83% when the EMT did a reading. I wasn't trying to kill myself although I didn't really care if I did. I thought that I might become drowsy or pass out for a little while since i was experimenting with only 2 tablespoons. Just a warning I guess that you should probably make sure you want to kill yourself before experimenting with SN. 1. Sodium Nitr[i]te 2. Conventional spoon used to eat food with 3 & 4. I poured an entire glass of water (same amount used originally into a measuring cup) and it was 1.5 cups (US system here) 5. Exactly 1.5 cups of water to 2 -2.5 tablespoons of sodium nitr[i]te. I didn't level each spoonful out so it wasn't super exact.
zajebistakaczka	4/09/2019 and 28/09/2019		it took 5 minutes for the effects to kick in, i started hearing ringing sounds and muffled noises, then i had an anxiety induced psychotic episode which made me scream - my landlord called the police and since then i was put in a&e and then a mental hospital. i've been put on two different antipsychotics and prozac. in a&e i woke up with vertigo and i couldn't even stand on my own to go pee for 24 hours, i had mouth sores too - so i was in the observation unit for a few days until i could actually consciously talk to a mental health worker. i'm left with the effects of constant gagging and for a week i had random chest pains. no i'm not happy i survived but i had to clear it up. Suicidal4Ever said: "Only 5 with capsules? Well this is going to suck" REPLY: "i took 24 [edit: sorry i read that wrong! but yeah it was so instant, i couldn't hear anything and people were like oh she logged off so quick and honestly i felt like i was going to pass out that fast]" sleepy dog said: "You might want to be careful what you say when talking to mental health people, any of them. Maybe just pretend to be making progress, tiny steps. What antipsychotics do you use? Are you court ordered? Did they search your home, take the SN?" REPLY: "i've been with the mental health team for years, my therapist knows i don't want to get better. they don't care, they just discharged me and i was back home again."
