



## **GVSD Booster Club Hold Harmless Agreement**

*Effective for the 2025–2026 School Year*

This Hold Harmless Agreement ("Agreement") is entered into this \_\_\_\_ day of \_\_\_\_\_, 2025, by and between the Garnet Valley School District ("District") and the undersigned Booster Club ("Booster Club").

### **1. Purpose**

For and in consideration of the District's ongoing permission and approval of the Booster Club to conduct its activities in support of District programs and students, the Booster Club agrees to protect the District as set forth herein. The purpose of this Agreement is to affirm that the Booster Club operates independently of the Garnet Valley School District and assumes full responsibility for its activities, volunteers, and financial obligations.

### **2. Acknowledgement**

The Booster Club acknowledges and agrees to comply with:

- Garnet Valley School District Board Policy 915
- All applicable federal, state, and local laws
- The Garnet Valley Booster Clubs' Handbook (revised November 2024)

### **3. Indemnification and Hold Harmless**

The Booster Club agrees to **indemnify, defend, and hold harmless** the Garnet Valley School District, its employees, administrators, board members, and representatives from and against any and all claims, liabilities, damages, losses, expenses (including legal fees), or causes of action arising out of:

- The operations or activities of the Booster Club;
- The acts or omissions of the Booster Club's officers, members, agents, vendors, or volunteers;
- Any injuries or damages occurring during events or fundraisers sponsored by the Booster Club;
- Any contracts or third-party arrangements entered into by the Booster Club.

#### **4. Insurance Requirements**

The Booster Club affirms that it has obtained and will maintain, throughout the school year:

- General Liability Insurance with a minimum of **\$1,000,000 per claim** and **\$3,000,000 aggregate**.
- Garnet Valley School District shall be named as an **additional insured**.
- A **Certificate of Insurance** has been or will be submitted to the Athletic Department prior to any club activities.

#### **5. Duration**

This Agreement is effective from **July 1, 2025 through June 30, 2026**, and must be renewed annually.
