To do this, we ask that authors follow some simple guidelines, and that upon acceptance, submissions be made available to the organizers in an editable format (Word or Google Doc).

Initial submissions will be uploaded into EasyChair as a PDF.

1.1 Text Considerations

The page limit for the Educator submission type is 4 pages.

Use the formatting of this document wherever possible, including the title, author information, section titles and body text.

Body text should be written using 9-point Times New Roman font.

1.2 Layout Considerations

Do not include headers, footers or page numbers in your submission.

You do not need to include references in your educator submission. However, if you do so, please follow the format used at the end of this template. References do not count towards the page limit of your submission.

1.3 Tables and Images

Captions should be bolded, numbered (e.g., "Table 1. This is the caption") and centered above Tables and below Images. If you have any trouble uploading your submission on EasyChair - make sure that you have compressed your images to make the file size smaller.
