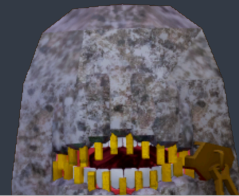

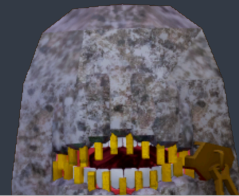

SUPERZUESS: On a scale of 1-10, how good at assisting Bob with business deals are you?

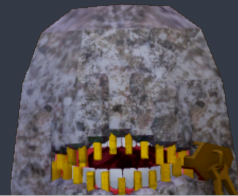
SCP-617-2: Ten out of ten

Have you ever assisted Bob with maintaining business deals without Boulder or Brick with you?

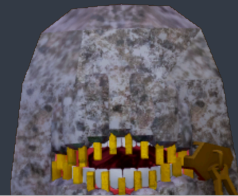

SUPERZUESS: What made you wish to be involved in business-maintaining? Was it by choice or does Bob force you?

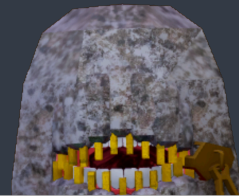
SCP-617-2: When your part of the family.

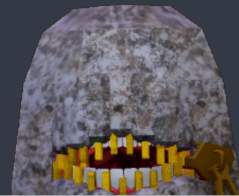
- - - - - CONCLUSION - - - - -

In conclusion, the interview went extremely well and SCP-617-2 was willing to answer most questions and shed new insight on my interview topic allowing me to further understand and discover SCP-617-2's involvement within the business deals that it conducts.

Throughout the interview, although SCP-617-2 is known as the intelligent instance with a good vocabulary, it appears that SCP-617-2 makes common mistakes, such as "Here and there" or "Your not welcome, Nerd." indicating that although intelligent, it is yet to learn the proper correction to these mistakes.

Almost instantaneously, SCP-617-2's known naturally aggressive and insulting behaviour was revealed as it stated that "Don't touch anything. It's worth more than you." to myself as a condition upon entering its containment chamber.

When asked how often SCP-617-2 helps Bob conduct business deals, it's reply was "Here and there - Whenever bossman needs it." which is peculiar as according to SCP-617-2, it only assists SCP-617-1 when asked to, indicating that SCP-617-1 has ultimate authority over business deals and SCP-617-2 does not have a 'say' when wishing to assist or not.



According to SCP-617-2, it maintains pre-made business deals by making a plan which is “a way to ensure the deal goes off without a hitch” this is understandable as SCP-617-1 previously had stated that SCP-617-2 was the brains when it came to business deals, indicating SCP-617-2 is intelligent and is quite good at thinking and formulating proper plans to ensure business deals are maintained without a problem.

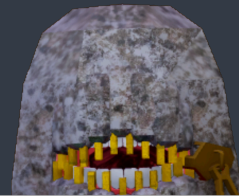
When asked if SCP-617-2 knew how many business deals it had assisted Bob with, it was unable to give an answer due to it stating that “Only bossman can tell you that.” reaffirming that SCP-617-2 is limited to allowing un-trusted individuals information about business deals and must go through the line of authority, which is centered around SCP-617-1.

SCP-617-2 believes that on a scale of 1-10, it is a 10/10 when it comes to how well SCP-617-2 is at assisting SCP-617-1 with business deals. Even stating that “No flaws, no cracks.” indicating it truly believes this statement whilst also indicating that SCP-617-2’s ‘role’, which according to SCP-617-2, is to make plans, have not yet failed and are thought through well enough to ensure they do not fail, indicating SCP-617-2’s high level of intelligence and expertise when it comes to plan formulating.

When asked about “any current business deals between Bob and other entities or individuals” SCP-617-2 was unable to answer stating that “None that I can talk about. Bossman likes to keep that list tight.” which also adds further evidence to my previous statement by which SCP-617-2 is not permitted to ‘leak’ information to individuals unauthorized by SCP-617-1.

In an attempt to gain further information, I asked about Mr.Fish, which SCP-617-2 stated that he was a “practical jokester. Knows how to take a good laugh or two. He’s quite the entertainer. Something we just love.” thus indicating why SCP-617 may have quite a good relationship with SCP-527 as both enjoy joking and humiliating others which is a common personality trait for SCP-617 and SCP-527. This also explains why SCP-617-1 has business deals with SCP-527 as it may be a positive factor.

I was confused by SCP-617-2’s response to the following question, “Are there business deals with most SCPs held within this facility?” as it stated “Yeah. Outside of the falcons. They get a pass.” SCP-617 typically refers to Falcon-2 combatives as “falcons” . I did not understand the relevance to this question. Yet, SCP-617-2 did reply with a “yeah” so I can assume that SCP-617-1 has developed connections and business deals with other individuals/entities outside of the facility, which is quite interesting and has potential to understand their background before being contained.



SCP-617-2 didn't openly state whether or not it believes it's better at "assisting Bob with business deals compared to Boulder and Brick" instead explaining that "They aren't half bad. I think that's a given. Those rocks heads couldn't solve a problem if the answer was looking at them." this allowed me to gain it's opinion on SCP-617-3 & SCP-617-4's ability when assisting SCP-617-1 conduct business deals, as in SCP-617-2's mind, they are okay but not great, yet it depends on the situation as they aren't that intelligent and therefore are unable to find the answer to a problem even if the answer was quite obvious. Thus indicating that SCP-617-2 does view itself as more intelligent than the two, but will not openly state that it is better at assisting business than them, as it may believe that they are better than it is in other areas when conducting business.

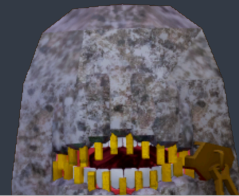
Yet, SCP-617-1 does believe that SCP-617-1 prefers it over SCP-617-3 and SCP-617-4 when assisting with conducting business deals.

Peculiarly, SCP-617-1 doesn't occasionally maintain business deals without SCP-617-3 or SCP-617-4, instead presumably, they work together as a team, not as individuals. When asked if SCP-617-2 preferred when they were with it or not, SCP-617-2 stated that "I like them all." obviously indicating that aside from the banter between them, they are quite good friends and SCP-617-2 enjoys their company.

Interestingly, SCP-617-1 has previously thought that it was better than Bob when maintaining a business deal/conducting one as it stated that "Maybe, once or twice." to my question regarding the topic. Yet, perhaps SCP-617-2 disagreed with how SCP-617-1 responded during a scenario when maintaining/conducting a business deal as it also stated that "the bossman can be ruthless." therefore perhaps SCP-617-2 prefers a less ruthless approach when conducting business deals yet doesn't question SCP-617-1's authority.

SCP-617-1 did not know what it would do when within the situation I posed which was "If you were to anger someone that you knew had a business deal with Bob, how would you react?" as it would likely depend on the situation at hand, which would indicate how it would react. Though, it did know how SCP-617-1 would react as it stated that "Bossman might not be a happy camper." which may have occurred before SCP-617-2 had previously angered an entity/individual that had business deals with SCP-617-1.

When further asked to explain SCP-617-2's 'role' when maintaining business deals and conducting them, as SCP-617-1 had referred to him as the 'brains', SCP-617-1 stated that "I make up all the plans. The strategies to win the gang wars. All the sorts." further adding more evidence to what SCP-617-1's role is. As it makes plans for proposed business deals and plans such as strategies to win "gang wars" which I assume is when an opposing group of 'rivals' attempts to band together to launch attacks upon SCP-617. As such, this confirms that SCP-617-2 is a major



asset towards SCP-617-1 as its intelligence and field of expertise in plan formulation seems quite useful.

When asked whether or not SCP-617-1 is forced to be involved in business-maintaining or does it out of free will, SCP-617-1 did not give me a straightforward answer, instead “When your part of the family. The gang. You do your part. Simple as that.” This allowed me to gain a further understanding of SCP-617-2’s views upon the interconnectedness that it believes brings each SCP-617 instance together, as a “family” or “gang”. As such, SCP-617-2 views the other instances as family members, rather than friends, which has a personalized and deeper meaning indicating that each instance will look-out for each other as they stick together as a group due to them being a “family”.

SCP-617-2’s tip for being able to form a successful business deal is “Muscle” which may be intercepted figuratively as SCP-617-2 believes in a figurative sense, that to be able to conduct successful business deals, one must be powerful enough and have a good reputation or status to do so. As “In these days, muscle and rocks talk.” indicating that to conduct successful business deals with SCP-617-1, one must be powerful, not powerless.

To keep rivals in check, SCP-617-2 demonstrated it’s earthquake ability in the surrounding area stating at the same time “By force.” thus the relationship between SCP-617 instances and rivals is extremely hostile and SCP-617 regards them by intentionally attacking them.

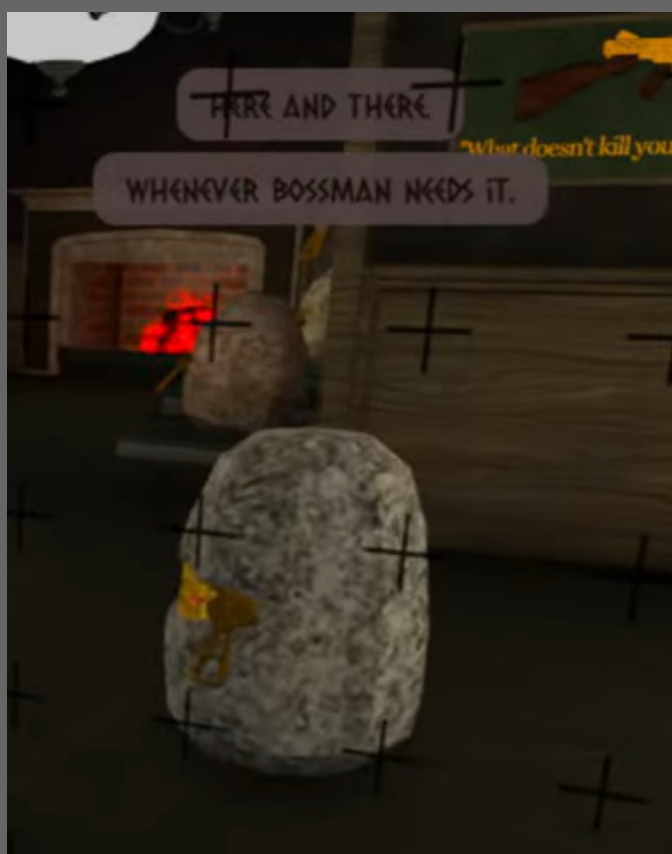

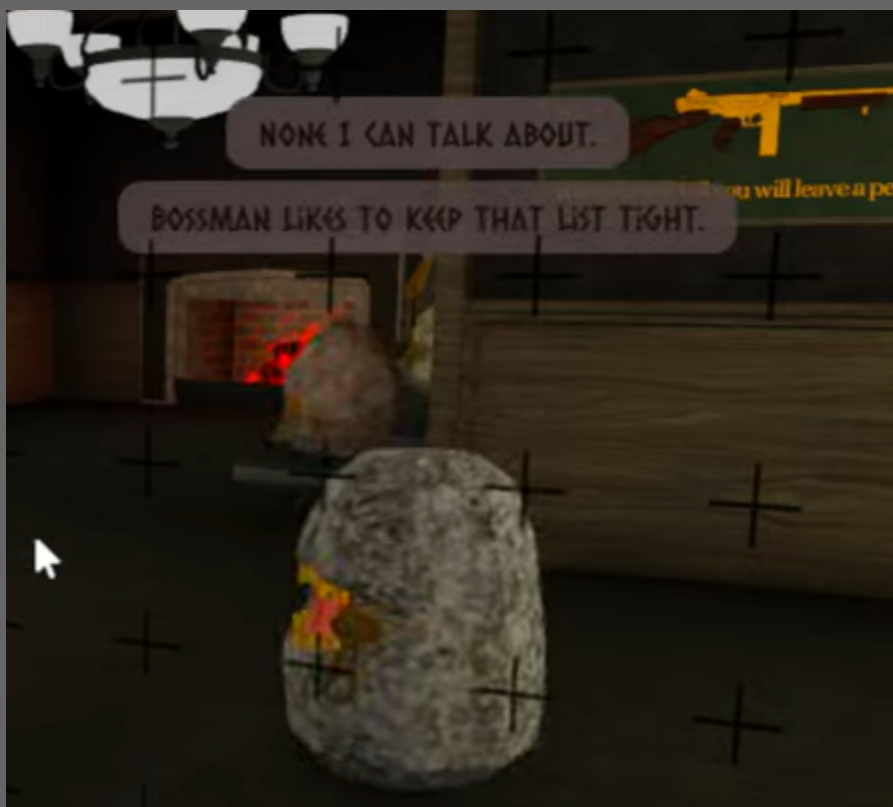

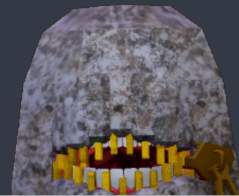

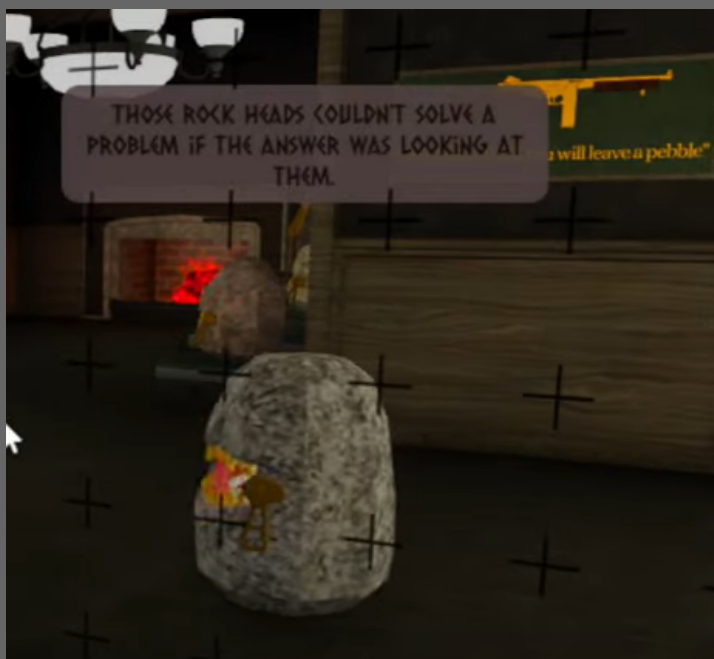

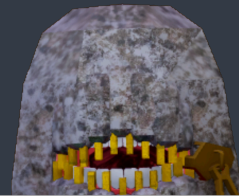

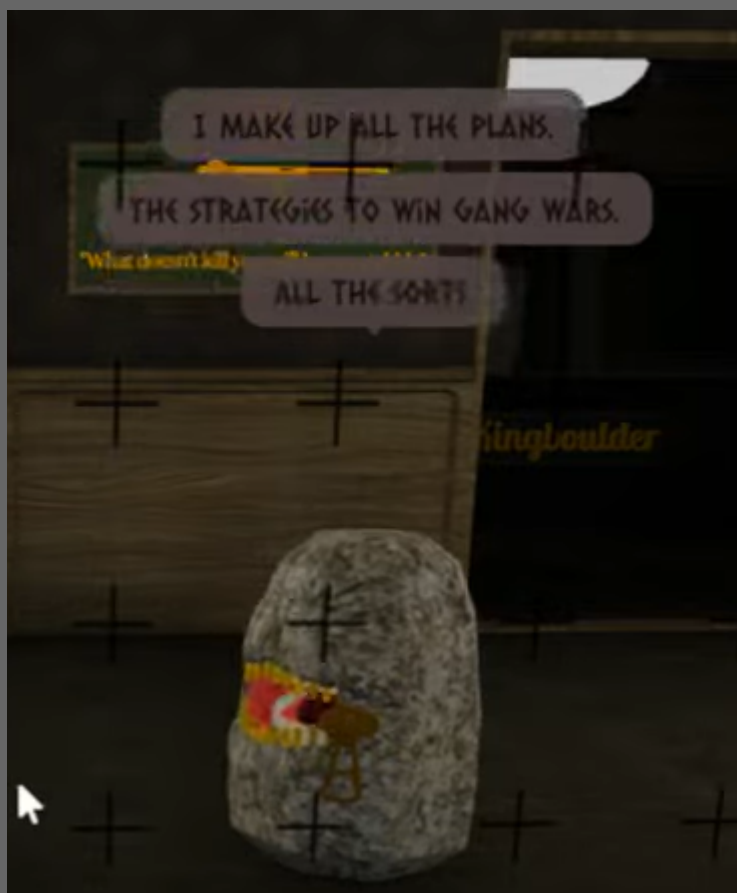


SCP-617-2's view on SCP-617-3 & SCP-617-4 when conducting business deals.





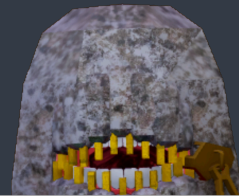

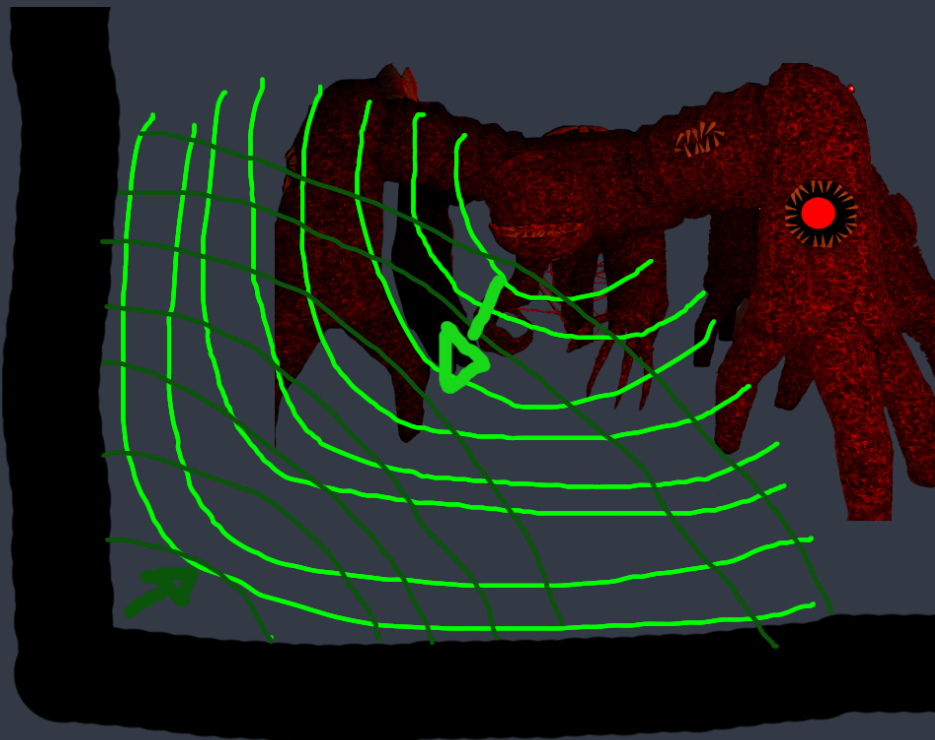

Visual demonstration



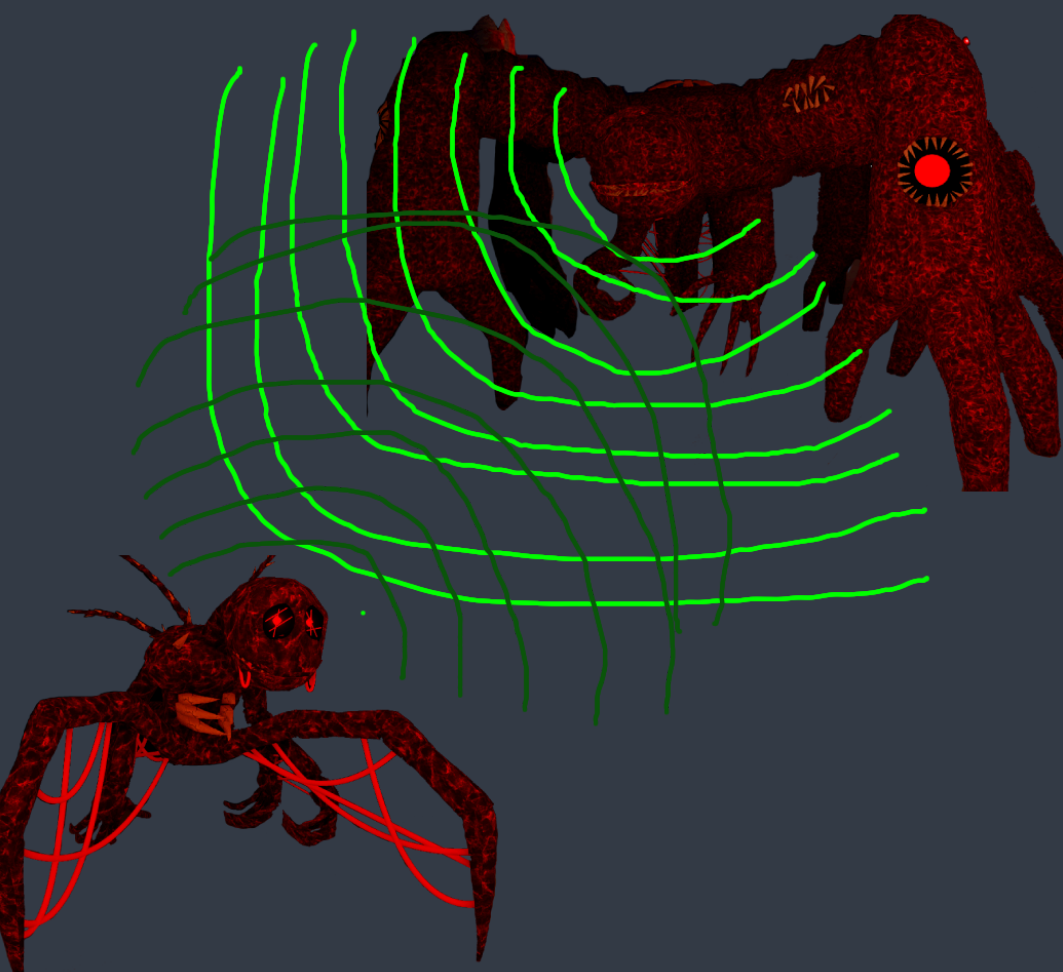
Visual demonstration of SCP-610-1 utilizing echolocation to identify individuals.
